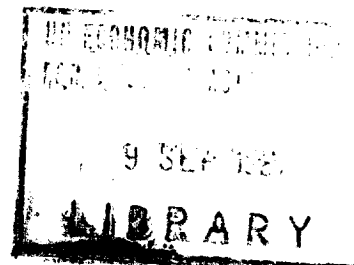

The financial status of the Commission's programmes

1. In its resolution 45 (IV), the Commission requested the Executive Secretary to submit a financial report for the period between the sessions of the Commission. This report is submitted in accordance with that request. However, in view of the adoption by the United Nations of a biennial programme system, the information provided hereunder, for the Commission secretariat's regular budget appropriations is for the biennia 1980-1981 and 1982-1983. The abbreviated form of the data provided below constitutes part of the Official Records of the General Assembly:

- (a) 1980-1981 biennium budget: The allocations for the biennium 1980-1981 amounted to \$ 14,451,000, of which \$ 6,129,100 were expended during 1980, leaving an unencumbered balance of \$ 8,321,900 as at 31 December 1980;
- (b) 1982-1983 biennium budget: ^{*}\$ 14,137,500 has been requested for the forthcoming biennium, but this request is subject to review both by the United Nations Secretariat in New York and the General Assembly.

2. In addition to the allocations for the 1980-1981 biennium in the regular budget (section 14) specifically for the Commission, funding was available to it for the activities, and in the amounts (in United States dollars), listed below.

* The decrease in the request for the 1982-1983 biennium, as opposed to the 1980-1981 biennium, is due to provision in the latter biennium for the non-recurrent costs associated with the relocation of the Commission's headquarters from Beirut to Baghdad.

3. In addition to the above, the following extrabudgetary resources were made available during the year 1980:

- (a) The Government of Lebanon contributed LL. 1,000,000 for the purpose of facilitating ECWA operations.

- (b) The Government of the Netherlands contributed \$ 200,000 towards the implementation of the 1980 work programme of the Commission. The Government of the Netherlands has also offered to make available to the Commission Dutch Florins 400,000 (\$ 188,680 at the UNDP operational rate of exchange of DFL 2.12 to \$ 1.00) for the 1981 work programme. The receipt of these funds is subject to mutual agreement on the fields in which they may be utilized, and to the concurrence of the United Nations Secretariat in New York.
- (c) The Government of France contributed \$ 37,000 for the implementation of the 1980 work programme in the area of statistics. It also contributed \$ 41,100 towards the 1981 work programme in statistics.

4. In accordance with paragraph 4 of Commission resolution 45 (IV), the combined status of Trust Funds as at 31 December 1980 is attached hereto as annex I.

5. The specific utilization of the extrabudgetary resources supporting the Commission's programmes, for the information of the member States is contained in document E/ECWA/117/Add.2.
