ELIMINATION OF RACISM AND RACIAL DISCRIMINATION

Mexico, Philippines* and Turkey: draft resolution

<u>Measures to combat contemporary forms of racism, racial discrimination, xenophobia and related intolerance</u>

The General Assembly,

Recalling its resolution 48/147 of 23 December 1994 and Commission on Human Rights resolution 1995/12 of 24 February 1995, $\underline{1}/$

Bearing in mind the outcome of the World Conference on Human Rights, held at Vienna from 14 to 25 June 1993, and, in particular, the attention given in the Vienna Declaration and Programme of Action to the elimination of racism, racial discrimination, xenophobia and other forms of intolerance, 2/

 $\underline{\text{Aware}}$ that racism, being one of the exclusionist phenomena plaguing many societies, requires resolute action and cooperation for its eradication,

Having examined the report of the Special Rapporteur of the Commission on

Human Rights on contemporary forms of racism, racial discrimination, xenophobia and related intolerance, $\underline{3}/$

<u>Deeply concerned</u> that, despite continued efforts, racism, racial discrimination, xenophobia and related intolerance, as well as acts of racial violence, continue to persist and even grow in magnitude, incessantly adopting new forms,

Conscious of the fundamental difference between, on the one hand, racism and racial discrimination as governmental policy or resulting from official doctrines of racial superiority or exclusivity and, on the other hand, other manifestations of racism, racial discrimination, xenophobia and related intolerance taking place in segments of many societies and perpetrated by individuals or groups, some of which are directed against migrant workers and members of their families, as well as new tendencies to establish policies based on racial, religious, ethnic, cultural and national superiority or exclusivity,

<u>Underlining</u> the importance of creating conditions to foster greater harmony and tolerance within societies,

- 1. <u>Welcomes</u> the report of the Special Rapporteur of the Commission on Human Rights on contemporary forms of racism, racial discrimination, xenophobia and related intolerance, in particular its conclusions and recommendations; 3/
- 2. Expresses its full support for the work of the Special Rapporteur and requests him to continue his exchange of views with relevant mechanisms, related United Nations organs and specialized agencies in order to further their effectiveness and mutual cooperation;
- 3. Expresses its profound concern at and unequivocal condemnation of all forms of racism and all racist violence, including related acts of random and indiscriminate violence;
- 4. Expresses its deep concern at and condemnation of manifestations of racism, racial discrimination, xenophobia and related intolerance against migrant workers and members of their families and other vulnerable groups in many societies;
- 5. <u>Calls upon</u> all States, in accordance with the conclusions and recommendations of the Special Rapporteur in his most recent report, to include in their educational curricula and social programmes, at all levels, knowledge, tolerance and respect for foreign cultures, peoples and countries and to inculcate positive values of all cultures;
- 6. <u>Supports</u> the efforts of Governments in taking measures aimed at the eradication of all forms of racism, racial discrimination, xenophobia and related intolerance;

- 7. Recognizes that legislation to prevent racism and racial discrimination should be implemented administratively and enforced judicially;
- 8. <u>Calls upon</u> all Governments and intergovernmental organizations, with the assistance of non-governmental organizations, as appropriate, to supply relevant information to the Special Rapporteur;
- 9. <u>Urges</u> all Governments to cooperate fully with the Special Rapporteur, with a view to enabling him to fulfil his mandate, and to consider his recommendations positively;
- 10. Requests, once again, the Secretary-General, without further delay, to provide the Special Rapporteur with all the necessary human and financial assistance in carrying out his mandate and enabling him to submit, in a timely manner, a preliminary report to the General Assembly at its fifty-first session on this question.
