APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS
AND OTHER APPOINTMENTS

Confirmation of the appointment of members of
the Investments Committee

Note by the Secretary-General

1. As indicated in document A/50/104 of 23 March 1995, it will be necessary for the General Assembly, during its current session, to confirm the appointment by the Secretary-General of three persons to fill vacancies in the Investments Committee resulting from the expiration, on 31 December 1995, of the terms of office of Mr. Yves Oltramare (Switzerland), Mr. Emmanuel Noi Omaboe (Ghana) and Mr. Jürgen Reimnitz (Germany). In addition, the General Assembly is requested to confirm the appointment of Mr. Takeshi Ohta (Japan) to fill the vacancy created by the resignation of Mr. Michiya Matsukawa of Japan.

2. In accordance with the provisions of article 20 of the Regulations of the United Nations Joint Staff Pension Fund (UNJSPF), the Secretary-General, after consultation with the United Nations Joint Staff Pension Board (UNJSPB) and the Advisory Committee on Administrative and Budgetary Questions (ACABQ), submits for confirmation by the General Assembly the reappointment of Mr. Yves Oltramare, Mr. Emmanuel Noi Omaboe and Mr. Jürgen Reimnitz as members of the United Nations Investments Committee for three-year terms of office beginning on 1 January 1996, as well as the appointment of Mr. Takeshi Ohta to fill the remainder of a three-year term expiring 31 December 1996.

3. Mr. Oltramare has served on the Committee since 1974, Mr. Omaboe since 1980 and Mr. Reimnitz since 1975. Mr. Takeshi Ohta was appointed as an ad hoc member for a one-year term beginning 1 January 1995 upon the resignation in October 1994 of Mr. Michiya Matsukawa, in order that the Fund may benefit from his expertise on the Japanese market. If confirmed, Mr. Ohta will fill the

remaining term of Mr. Matsukawa. The Secretary-General very much appreciates their willingness to carry on this important international public service.

4. The curricula vitae of the appointees for confirmation are set out in the annex to the present document.

5. In accordance with past practice, the Secretary-General has appointed as ad hoc members Mr. Peter Stormonth Darling (United Kingdom of Great Britain and Northern Ireland) and Mr. Alexander P. Papamarkou (Greece and United States of America) to serve with the Committee in 1996.
