4. Sixth preambular paragraph

5. Replace the tenth preambular paragraph by the following:

Concerned about any activities aimed at the exploitation of the natural and human resources of the Non-Self-Governing Territories to the detriment of the interests of the inhabitants of those Territories,

6. Operative paragraph 1

Replace Reaffirms the inalienable right of the peoples of colonial and Non-Self-Governing Territories to self-determination and independence by Reaffirms the right of the peoples of Non-Self-Governing Territories to self-determination in conformity with the Charter of the United Nations and General Assembly resolution 1514 (XV), containing the Declaration on the Granting of Independence to Colonial Countries and Peoples

7. Insert a new operative paragraph 2 as follows:

2. Affirms the value of foreign economic investment undertaken in collaboration with the people of the Non-Self-Governing Territories and in accordance with their wishes in order to make a valid contribution to the socio-economic development of the Territories;

8. Replace former operative paragraph 2 by the following new operative paragraph 3:

3. Reaffirms the responsibility of the administering Powers under the Charter to promote the political, economic, social and educational advancement of the Non-Self-Governing Territories, and reaffirms the legitimate rights of their peoples over their natural resources;

9. Renumber the subsequent operative paragraphs

10. Former operative paragraph 3 (present operative paragraph 4)

(a) Replace Reaffirms its concern about the activities of those foreign economic, financial and other interests which continue to exploit by Reaffirms its concern about any activities aimed at the exploitation of

18. Former operative paragraph 11 (present operative paragraph 12)

Replace for the full implementation of the Declaration by to promote the economic well-being of the peoples of the Non-Self-Governing Territories

19. Former operative paragraph 12 (present operative paragraph 13)
