#### PAPUA NEW GUINEA

[30 October 1995]

1. Papua New Guinea does not have in its inventory any of the following weapons systems:

- (a) Battle tanks;
- (b) Armoured combat vehicles;
- (c) Large-calibre artillery systems;
- (d) Combat aircraft;
- (e) Attack helicopters;
- (f) Warships;
- (g) Missiles and missile launchers.

2. The Papua New Guinea Defence Force is a relatively lightly armed force compared with other regional countries with large and sophisticated weapons systems. Furthermore, Papua New Guinea does not manufacture, let alone export such lethal weapons.

3. Papua New Guinea is therefore submitting a "nil return" for the years 1993, 1994 and 1995.
