CONSTITUTION OF BRUNEI DARUSSALAM (Order under section 83(3))

EMERGENCY (MISUSE OF DRUGS) (AMENDMENT) ORDER, 1992

In exercise of the power conferred by subsection (3) of section 83 of the Constitution of Brunei Darussalam, His Majesty The Sultan and Yang Di-Pertuan hereby makes the following Order —

1. This Order may be cited as the Emergency (Misuse of Drugs) (Amendment) Order, 1992 and shall come into force on 25th. June, 1992.

Citation and commencement.

2. The Misuse of Drugs Act, (in this Order referred to as the Act), is amended in section 2 —

Amendment of section 2 of Chapter 27.

- (a) in the definition of "pharmacist", by deleting "9" from the third line and by substituting "13" therefor.
- (b) in the definition of "veterinary surgeon", by deleting "9" from the sixth line and by substituting "13" therefor.
- 3. Section 3A of the Act is deleted and the following new section is substituted therefor —

Substitution of section 3A.

"Possession for purpose of trafficking.

- 3A. Except as authorised by this Act or the regulations made thereunder, it shall be an offence for a person, on his own behalf or on behalf of any other person, whether or not such other person is in Brunei, to have a controlled drug in his possession for the purpose of trafficking."
- 4. Section 8 of the Act is amended by deleting "exythroxylon" and substituting therefor "erythroxylon".

Amendment of section 8.

5. Section 15 of the Act is deleted and the following new section is substituted therefor —

Substitution of section 15.

"Presumption concerning trafficking.

- 15. Any person who is proved to have had in his possession more than
 - (a) 100 grammes of opium;
 - (b) 3 grammes of morphine;
 - (c) 2 grammes of diamorphine;
 - (d) 15 grammes of cannabis;
 - (e) 10 grammes of cannabis resin;

or

(f) 3 grammes of cocaine,

whether or not contained in any substance, extract, preparation or mixture shall, until the contrary is proved, be presumed to traffic in that controlled drug."

Amendment of 6. Section 29 of the Act is amended by — section 29.

- (a) inserting "(except section 6)" immediately after "Act" in the second line of subsection (3);
- (b) adding the following new subsection immediately after subsection (3)
 - "(3A) If any person convicted of an offence under section 6 is again convicted of a similar offence, he shall be liable
 - (a) in the case of an offence under paragraph (a), to imprisonment for a term of not less than 2 years;
 - (b) in the case of an offence under paragraph (b), to imprisonment for a term of not less than 3 years."

Amendment of 7. Section 33 of the Act is amended by — section 33.

- (a) deleting subsection (2) and by substituting the following new subsection therefor
 - "(2) If as a result of such medical examination or observation under subsection (1) or of a urine test conducted under section 28, it appears to the Minister that it is necessary for any person examined or observed, or who supplied the urine specimen for the urine test —
 - (a) to be subject to supervision, the Minister may make a supervision order requiring that person to be subject to the supervision of an officer of the Bureau for a period not exceeding two years; or
 - (b) to undergo treatment or rehabilitation or both at an approved institution, the Minister may make an order in writing requiring that person to be admitted for that purpose to an approved institution."
- (b) inserting "and rehabilitation" immediately after "treatment" in the second line of subsection (3);
- (c) deleting the marginal note and by substituting "Supervision, treatment and rehabilitation of drug addicts." therefor.

8. The Act is amended by inserting the following new subsection immediately after section 33 —

Insertion of new section 33A.

"Administration of approved institutions.

33A. Subject to the directions of the Minister, approved institutions shall be under the general charge and administration of the Director of Prisons appointed under subsection (1) of section 10 of the Prisons Act."

Chapter 51.

9. Section 34 of the Act is amended, in subsection (1), by inserting $\boldsymbol{-}$

Amendment of section 34.

- (a) "(including the imposition of corporal punishment)" immediately after "discipline" in the first line of paragraph (kc);
- (b) "referred to in paragraph (a) of subsection (2) of section 33, or" immediately after "persons" in the first line of paragraph (ke).
- 10. The Second Schedule to the Act is deleted and the following new Schedule is substituted therefor —
