APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS

Appointment of a member of the Joint Inspection Unit

Note by the President of the General Assembly

- 1. As indicated in paragraph 1 of the note by the Secretary-General (A/50/107), the General Assembly, by its decision 49/321 of 23 December 1994, appointed four members of the Joint Inspection Unit for a five-year term of office beginning on 1 January 1996 and expiring on 31 December 2000. The Secretary-General has been informed that one such member, Mr. Ali Badara Tall (Burkina Faso), submitted his resignation on 17 October 1995 before commencing his term of office, which would have started on 1 January 1996 and expired on 31 December 2000. The General Assembly will accordingly be required, at the fiftieth session, to appoint a person to serve as a member of the Joint Inspection Unit for a five-year term of office beginning on 1 January 1996 and expiring on 31 December 2000.
- 2. In accordance with the procedures described in article 3, paragraph 1, of the statute of the Joint Inspection Unit, the President of the General Assembly, having consulted the regional group concerned, determined that Burkina Faso should be requested to propose a candidate to replace Mr. Tall (see annex I).
- 3. The President of the General Assembly has held the further consultations described in article 3, paragraph 2, of the statute of the Joint Inspection Unit, including consultations with the President of the Economic and Social Council and with the Secretary-General in his capacity as Chairman of the Administrative Committee on Coordination. The replies received from the President of the Council and from the Secretary-General to identical letters addressed to them on 27 November 1995 by the President of the Assembly are attached (see annexes II and III).

4. Having completed the required consultations, the President of the General Assembly has the honour to submit to the Assembly the candidature of Mr. Louis Dominique Ouedraogo (Burkina Faso) for appointment as a member of the Joint Inspection Unit for a term of office beginning on 1 January 1996 and expiring on 31 December 2000.

Letter dated 31 October 1995 from the Permanent Representative of Sierra Leone to the United Nations addressed to the President of the General Assembly
