I. CONSIDERATION OF THE DRAFT BIENNIAL PROGRAMME  
OF WORK OF THE SECOND COMMITTEE FOR 1996-1997

1. At the 44th meeting, on 13 December 1995, the representative of the Secretariat introduced and read out corrections to the draft biennial programme of work of the Second Committee for 1996-1997 (A/C.2/50/L.65/Rev.1, annex).
