Resumed organizational session for 1995

ELECTIONS, NOMINATIONS AND APPOINTMENTS

Note by the Secretary-General

- 1. Pursuant to General Assembly resolutions 32/162 of 19 December 1977, 40/202 of 17 December 1985 and 45/264 of 13 May 1991, the Economic and Social Council is to elect, at its resumed organizational session for 1995, 19 members of the Commission on Human Settlements, for a four-year term beginning on 1 January 1996, to fill the vacancies created by the expiration on 31 December 1995 of the terms of the following members: Austria, Barbados, Belarus, Botswana, Bulgaria, Germany, Ghana, Greece, Haiti, India, Jordan, Kenya, Malaysia, Mexico, Norway, Philippines, Sri Lanka, Sudan and United Republic of Tanzania.
- 2. In accordance with paragraph 1 of section II of General Assembly resolution 32/162, the 19 members are to be elected on the following basis:
 - (a) Five seats for African States;
 - (b) Five seats for Asian States;
 - (c) Two seats for Eastern European States;
 - (d) Three seats for Latin American and Caribbean States;
 - (e) Four seats for Western European and other States.
- 3. The membership of the Commission in 1995 is given in the annex below.
