The meeting was called to order at 3.35 p.m.

ADOPTION OF THE REPORT (continued) (A/AC.182/L.26)

- 1. Mrs. RAMIRO-LOPEZ (Philippines), Rapporteur, introduced the Introduction (A/AC.182/L.26) to the Special Committee's report and read out some changes that had been made.
- 2. She read out a statement on the work done by the Working Group in connexion with the question of the maintenance of international peace and security.*
- Mr. PIRIS (France) said that the Committee must re-examine its method of Once again it had not been possible to prepare the Committee's report in good time and in all languages, and the Rapporteur had unfortunately again been required to read out a lengthy statement constituting the bulk of the report so that delegations had not had a chance to see the report in written form. When the decision to discontinue, for budgetary reasons, the provision of summary records for the Special Committee had been re-examined, his delegation had maintained that the reinstatement of summary records would not result in any improvement of the situation with respect to the preparation of the report. The example of the current session convincingly demonstrated that the French delegation had been right, and fully warranted a re-examination of the question of the provision of summary records. The Committee should perhaps terminate its deliberations a few days earlier in order to give the Rapporteur and the Secretariat time to prepare the report and the same should also be done by other Committees established by the General Assembly on the recommendation of the Sixth Committee. In any case the situation must never be allowed to recur. The Committee had a special responsibility in that connexion since its mandate included the question of the rationalization of existing procedures of the United Nations.

The meeting rose at 7.30 p.m.
