REVIEW OF THE IMPLEMENTATION OF THE RECOMMENDATIONS AND DECISIONS ADOPTED BY THE GENERAL ASSEMBLY AT ITS TENTH SPECIAL SESSION

Report of the First Committee

I. INTRODUCTION

1. The item entitled:

"Review of the implementation of the recommendations and decisions adopted by the General Assembly at its tenth special session:

- "(a) Report of the Disarmament Commission;
- "(b) Report of the Conference on Disarmament;
- "(c) Status of multilateral disarmament agreements;
- "(d) Advisory Board on Disarmament Matters;
- "(e) United Nations Institute for Disarmament Research"

was included in the provisional agenda of the forty-eighth session in accordance with General Assembly resolutions 36/92 H of 9 December 1981, 38/183 O of 20 December 1983, 39/148 H of 17 December 1984, 44/119 G of 15 December 1989, 45/62 F and G of 4 December 1990, 46/38 A to D of 6 December 1991 and 47/54 A, E and F of 9 December 1992.

2. At its 3rd plenary meeting, on 24 September 1993, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.

3. At its 2nd meeting, on 14 October 1993, the First Committee decided to hold a general debate on all disarmament and international security items allocated to it, namely, items 57 to 75 and 77 to 82. The deliberations on those items took place at the 3rd to 14th meetings, on 18 to 22, 25, 26 and 28 October (see A/C.1/48/SR.3-14). Consideration of draft resolutions on those items took place at the 18th to 23rd meetings, on 3 to 5, 8 and 9 November (see A/C.1/48/SR.18-23). Action on draft resolutions on those items took place at the 24th to 30th meetings, on 11, 12, 15, 16, 18 and 19 November (see A/C.1/48/SR.24-30).

II. CONSIDERATION OF DRAFT RESOLUTIONS

A. Draft resolutions A/C.1/48/L.3 and Rev.1

5. On 27 October, <u>Benin, Brazil, Bulgaria, Canada</u>, the <u>Czech Republic</u>, <u>Ecuador, Germany, Ireland, Mauritius, Mongolia</u>, the <u>Republic of Korea</u> and <u>Ukraine</u> submitted a draft resolution entitled "Report of the Disarmament Commission" (A/C.1/48/L.3).

6. At the 29th meeting, the representative of <u>Brazil</u> introduced the draft resolution, which read as follows:

"The General Assembly,

"Having considered the annual report of the Disarmament Commission, $\underline{3}/$

"Recalling its resolutions 47/54 A of 9 December 1992 and 47/54 G of 8 April 1993,

"<u>Considering</u> the role that the Disarmament Commission has been called upon to play and the contribution that it should make in examining and submitting recommendations on various problems in the field of disarmament and in the promotion of the implementation of the relevant decisions of the tenth special session,

"1. <u>Takes note</u> of the annual report of the Disarmament Commission;

"2. <u>Commends</u> the Disarmament Commission for its adoption by consensus of a set of guidelines and recommendations for regional approaches to disarmament within the context of global security, which were recommended to the General Assembly for consideration, pursuant to the adopted 'Ways and means to enhance the functioning of the Disarmament Commission'; $\underline{4}$ /

"3. <u>Endorses</u> the guidelines and recommendations for regional approaches to disarmament within the context of international security as adopted by the Disarmament Commission at its 1993 substantive session;

"4. <u>Notes with satisfaction</u> that the Disarmament Commission has made significant progress in achieving agreement on guidelines and recommendations under the agenda item entitled 'The role of science and technology in the context of international security, disarmament and other related fields', which is to be concluded in 1994;

"5. <u>Reaffirms</u> the importance of further enhancing the dialogue and cooperation among the First Committee, the Disarmament Commission and the Conference on Disarmament;

"6. <u>Recommends</u> that the Conference on Disarmament consider, within its competence, the guidelines and recommendations for regional approaches to disarmament within the context of international security;

"7. <u>Reaffirms</u> the role of the Disarmament Commission as the specialized, deliberative body within the United Nations multilateral disarmament machinery that allows for in-depth deliberations on specific disarmament issues, leading to the submission of concrete recommendations on those issues;

"8. <u>Encourages</u> the Disarmament Commission to continue to make every effort to enhance its working methods so as to enable it to give focused consideration to a limited number of priority issues in the field of disarmament, bearing in mind the decision it has taken to move its agenda towards a three-item phased approach;

"9. <u>Requests</u> the Disarmament Commission to continue its work in accordance with its mandate, as set forth in paragraph 118 of the Final Document of the Tenth Special Session of the General Assembly, 5/ and with paragraph 3 of resolution 37/78 H of 9 December 1982, and to that end to make every effort to achieve specific recommendations on the items on its agenda, taking into account the adopted 'Ways and means to enhance the functioning of the Disarmament Commission';

"10. <u>Recommends</u> that the Disarmament Commission, at its 1993 organizational session, adopt the following items for consideration at its 1994 substantive session:

- "(1) Process of nuclear disarmament in the framework of international peace and security, with the objective of the elimination of nuclear weapons;
- "(2) The role of science and technology in the context of international security;
- "(3) International arms transfers, with particular reference to resolution 46/36 H of 6 December 1991;

"11. <u>Recommends</u> that the Disarmament Commission, at its 1994 organizational session, consider including in the agenda of its 1995 substantive session an item entitled 'General guidelines for non-proliferation, with special emphasis on weapons of mass destruction';

"12. <u>Requests</u> the Disarmament Commission to meet for a period not exceeding four weeks during 1994 and to submit a substantive report to the General Assembly at its forty-ninth session;

"13. <u>Requests</u> the Secretary-General to transmit to the Disarmament Commission the annual report of the Conference on Disarmament, $\underline{6}$ / together with all the official records of the forty-eighth session of the General Assembly relating to disarmament matters, and to render all assistance that the Commission may require for implementing the present resolution;

"14. <u>Also requests</u> the Secretary-General to ensure full provision to the Commission and its subsidiary bodies of interpretation and translation facilities in the official languages, and to assign, as a matter of priority, all the necessary resources and services to this end;

"15. <u>Decides</u> to include in the provisional agenda of its forty-ninth session the item entitled 'Report of the Disarmament Commission'."

7. On 16 November, the sponsors submitted a revised draft resolution $(A/C.1/48/L.3/Rev.1)\,.$

8. At its 29th meeting, on 18 November, the Committee adopted revised draft resolution A/C.1/48/L.3/Rev.1 by a recorded vote of 139 to none, with 1 abstention (see para. 14, draft resolution A). The voting was as follows: $\underline{7}$ /

B. Draft resolution A/C.1/48/L.41

9. At the 23rd meeting, on 9 November, the representative of <u>Egypt</u> introduced a draft resolution entitled "Report of the Conference on Disarmament" (A/C.1/48/L.41), which was later also sponsored by the <u>Czech Republic</u>.

10. In connection with the draft resolution, the Secretary-General submitted a statement on its programme budget implications (A/C.1/48/L.55).

11. At its 30th meeting, on 19 November, the Committee adopted draft resolution A/C.1/48/L.41 without a vote (see para. 14, draft resolution B).

C. Draft resolution A/C.1/48/L.46

12. On 4 November, <u>Egypt</u> and <u>Poland</u> submitted a draft resolution entitled "United Nations Institute for Disarmament Research" (A/C.1/48/L.46), which was later also sponsored by <u>Paraguay</u>. The text of the draft resolution read as follows:

"The General Assembly,

"<u>Recalling</u> its resolution 34/83 M of 11 December 1979, in which it requested the Secretary-General to establish the United Nations Institute for Disarmament Research on the basis of the recommendations contained in the report of the Secretary-General, $\underline{8}/$

"<u>Reaffirming</u> its resolution 39/148 H of 17 December 1984, in which it approved the statute of the United Nations Institute for Disarmament Research, the functions of which are, <u>inter alia</u>, to assist ongoing negotiations on disarmament and to continue efforts to ensure greater international security at a progressively lower level of armaments, in accordance with article II, paragraph 2 (c), of the statute,

"<u>Recommends</u> that the United Nations Institute for Disarmament Research, in programming its activities, should assist the Conference on Disarmament as the sole multilateral negotiating body in the field of disarmament, and the United Nations Disarmament Commission in fulfilling their respective mandates while maintaining the autonomous status of the Institute."

13. At the 24th meeting, on 11 November, the sponsors stated that they would not press for action on the draft resolution.

III. RECOMMENDATIONS OF THE FIRST COMMITTEE

14. The First Committee recommends to the General Assembly the adoption of the following draft resolutions:

1. <u>Takes note</u> of the annual report of the Disarmament Commission;

3. <u>Endorses</u> the guidelines and recommendations for regional approaches to disarmament within the context of global security as adopted by the Disarmament Commission at its 1993 substantive session;

4. <u>Notes with satisfaction</u> that the Disarmament Commission has made significant progress in achieving agreement on guidelines and recommendations under the agenda item entitled "The role of science and technology in the context of international security, disarmament and other related fields", which is to be concluded in 1994;

5. <u>Takes note</u> of the continuing consideration by the Disarmament Commission of the item entitled "Process of nuclear disarmament in the framework of international peace and security, with the objective of the elimination of nuclear weapons", which is to be concluded in 1994;

6. <u>Reaffirms</u> the importance of further enhancing the dialogue and cooperation among the First Committee, the Disarmament Commission and the Conference on Disarmament;

7. <u>Recommends</u> that the Conference on Disarmament consider, within its competence, the guidelines and recommendations for regional approaches to disarmament within the context of international security;

11. <u>Recommends</u> that the Disarmament Commission, at its 1993 organizational session, adopt the following items for consideration and conclusion at its 1994 substantive session:

- Process of nuclear disarmament in the framework of international peace and security, with the objective of the elimination of nuclear weapons;
- (2) The role of science and technology in the context of international security, disarmament and other related fields;

12. <u>Also recommends</u> that the Disarmament Commission, at its 1993 organizational session, include in the agenda of its 1994 substantive session an item entitled "International arms transfers, with particular reference to resolution 46/36 H of 6 December 1991";

13. <u>Requests</u> the Disarmament Commission to meet for a period not exceeding four weeks during 1994 and to submit a substantive report to the General Assembly at its forty-ninth session;

14. <u>Requests</u> the Secretary-General to transmit to the Disarmament Commission the annual report of the Conference on Disarmament, <u>13</u>/ together with all the official records of the forty-eighth session of the General Assembly relating to disarmament matters, and to render all assistance that the Commission may require for implementing the present resolution;

15. <u>Also requests</u> the Secretary-General to ensure full provision to the Commission and its subsidiary bodies of interpretation and translation facilities in the official languages and to assign, as a matter of priority, all the necessary resources and services to that end;

16. <u>Decides</u> to include in the provisional agenda of its forty-ninth session the item entitled "Report of the Disarmament Commission".

Report of the Conference on Disarmament

The General Assembly,

Having considered the report of the Conference on Disarmament, 13/

<u>Convinced</u> that the Conference on Disarmament, as the single multilateral disarmament negotiating forum of the international community, has the primary role in substantive negotiations on priority questions of disarmament,

<u>13</u>/ <u>Official Records of the General Assembly, Forty-eighth Session</u>, <u>Supplement No. 27</u> (A/48/27).

<u>Considering</u>, in this respect, that the present international climate should give additional impetus to multilateral negotiations with the aim of reaching concrete agreements,

<u>Welcoming</u> the decision of the Conference on Disarmament to give to its Ad Hoc Committee on a Nuclear Test Ban a mandate to negotiate such a ban,

Noting with satisfaction the results achieved so far on the subject of improved and effective functioning of the Conference on Disarmament, as well as the decision to carry out inter-sessional consultations with a view to achieving consensus on the issue of its membership during the inter-sessional period, and the decision to continue consultations on the issue of the agenda at its 1994 session,

1. <u>Reaffirms</u> the role of the Conference on Disarmament as the single multilateral disarmament negotiating forum of the international community;

2. <u>Welcomes</u> the determination of the Conference on Disarmament to fulfil that role in the light of the evolving international situation with a view to making early substantive progress on priority items of its agenda;

3. <u>Also welcomes</u> the decision of the Conference on Disarmament to give to its Ad Hoc Committee on a Nuclear Test Ban a mandate to negotiate such a ban;

4. <u>Urges</u> the Conference on Disarmament to reach a consensus that would result in the expansion of its membership before the start of its 1994 session;

5. <u>Encourages</u> the ongoing review of the agenda, membership and methods of work of the Conference on Disarmament;

6. <u>Requests</u> the Secretary-General to ensure the provision, to the Conference on Disarmament, of additional administrative, substantive and conference support services for its negotiations;

7. <u>Requests</u> the Conference on Disarmament to submit a report on its work to the General Assembly at its forty-ninth session;

8. <u>Decides</u> to include in the provisional agenda of its forty-ninth session the item entitled "Report of the Conference on Disarmament".
