COMMISSION ON HUMAN RIGHTS Thirty-seventh session 2 February-13 March 1981

PROVISIONAL AGENDA

Note by the Secretary-General

- 1. The thirty-seventh session of the Commission on Human Rights will be held at the United Nations Office at Geneva from 2 February to 13 March 1981. The first meeting will be convened at 11 a.m. on Monday, 2 February 1981.
- 2. The provisional agenda for the thirty-seventh session is reproduced below. It is drawn up in accordance with rule 5 of the rules of procedure of the functional commissions of the Economic and Social Council. At its thirty-sixth session the Commission took note 1/of a draft provisional agenda prepared in accordance with Economic and Social Council resolution 1394 (LVII). The provisional agenda reproduced below contains the following additional items: new item 12, "Review of the draft medium-term plan for the period 1984 to 1989" (in accordance with General Assembly resolution 35/9 of 3 November 1980), new item 29, "Election of members of the Sub-Commission on Prevention of Discrimination and Protection of Minorities". At its thirty-fourth session, the Commission elected 26 members of the Sub-Commission on Prevention of Discrimination and Protection of Minorities for a three-year term. The Commission will accordingly hold a new election of the members of the Sub-Commission at the thirty-seventh session.
- 3. It will be noted that item 8 has been reworded in accordance with the decision of the Commission as contained in resolution 6 (XXXVI).
- 4. The thirty-seventh session of the Commission will be preceded by meetings of four groups, which will take place from 26 to 30 January 1981:
- (a) In connection with item 10 (a), and in accordance with Economic and Social Council resolution 1980/32, an open-ended working group will convene to complete the work on a draft convention against torture and other cruel, inhuman or degrading treatment or punishment;
- (b) In connection with item 14, and in accordance with Economic and Social Council decision 1980/138, an open-ended working group will convene to facilitate the completion of the work on a draft convention on the rights of the child;

- (c) In connection with item 13 (b), and in accordance with Economic and Social Council decision 1980/134, a working group composed of five members of the Commission will meet to examine such particular situations as might be referred to the Commission by the Sub-Commission on Prevention of Discrimination and Protection of Minorities under Economic and Social Council resolution 1503 (XLVIII) of 27 May 1970 and those situations which the Commission has decided to keep under review;
- (d) In connection with item 17, and in accordance with Commission resolution 13 (XXXVI), the group of three members of the Commission appointed in accordance with article IX of the International Convention on the Suppression and Punishment of the Crime of Apartheid will convene to consider reports submitted by States parties in accordance with article VII of that Convention.
- 5. The Economic and Social Council, by decision 1980/139, endorsed Commission decision 14 (XXXVI) by which the session of the Ad Hoc Committee on Periodic Reports, which was scheduled to take place prior to the thirty-seventh session of the Commission, would be postponed and would take place prior to the thirty-eighth session of the Commission.
- 6. In connection with item 11, the Commission decided, in resolution 28 (XXXVI), to establish at the very beginning of the thirty-seventh session an open-ended working group to continue the over-all analysis of "Further promotion and encouragement of human rights and fundamental freedoms" as indicated in that resolution.
- 7. In connection with item 19, the Commission decided, by resolution 35 (XXXVI), to establish again the open-ended working group at its thirty-seventh session and to allot more time to the working group during the thirty-seventh session in order that it might complete its task at that session.
- 8. Any decisions or resolutions affecting the provisional agenda of the Commission which may be taken by the General Assembly at its thirty-fifth session or by the Economic and Social Council at its organizational session in February 1981 will be brought to the attention of the Commission in an addendum to the present document. The annotations to the items listed in the provisional agenda will be issued in another addendum.
