PROVISIONAL AGENDA AND ANNOTATIONS

Note by the Secretary-General

1. The forty-eighth session of the Committee on the Elimination of Racial Discrimination will be held at the United Nations Office at Geneva from 26 February to 15 March 1996. The first meeting of the session will be convened at 10.30 a.m. on Monday, 26 February.
2. This document contains the provisional agenda for the forty-eighth session of the Committee, prepared by the Secretary-General in accordance with rule 6 of the rules of procedure, together with annotations relating thereto.
3. The attention of States parties is drawn, in particular, to the annotations to item 6, which contain the tentative timetable for consideration of reports submitted by States parties under article 9 of the Convention.
4. In accordance with rule 64 of the rules of procedure, the representatives of the States parties are invited to be present at the meetings of the Committee when their reports are examined.

ANNOTATIONS TO THE PROVISIONAL AGENDA

1. Opening of the session by the representative of the Secretary-General

The forty-eighth session of the Committee will be opened by the representative of the Secretary-General, who will preside over the meeting until the election of the Chairman of the Committee.

2. Solemn declaration by the newly elected members of the Committee under rule 14 of the rules of procedure

In accordance with rule 14 of the rules of procedure, the nine members of the Committee elected or re-elected at the Sixteenth Meeting of the States parties to the Convention, held on 16 January 1996, will make the following solemn declaration:

"I solemnly declare that I will perform my duties and exercise my powers as a member of the Committee on the Elimination of Racial Discrimination honourably, faithfully, impartially and conscientiously."

3. Election of officers

In accordance with article 10, paragraph 2, of the Convention and rules 15 and 16 of the rules of procedure, the Committee shall elect from among its members a Chairman, three Vice-Chairmen and a Rapporteur. The officers of the Committee shall be elected for a term of two years.

Under rule 58 of the rules of procedure, elections shall be held by secret ballot, unless the Committee decides otherwise in the case of election to fill a place for which there is only one candidate.

4. Adoption of the agenda

Under rule 8 of the rules of procedure, the adoption of the agenda of any session shall follow the election of officers when required under rule 15. In accordance with rule 9, the Committee may revise the agenda during a session and may, as appropriate, add, defer or delete items.

5. Prevention of racial discrimination, including early warning and urgent procedures

The Committee decided at its forty-fifth session to establish this point as one of its regular and principal agenda items. Within the framework of its efforts to prevent racial discrimination, the Committee may decide to take early warning measures aimed at preventing existing problems from escalating into conflicts; or it may decide to initiate urgent procedures aimed at responding to problems requiring immediate attention to prevent or limit the scale or number of serious violations of the Convention. The Committee may also take action or further action regarding States parties already considered under the item.

6. Consideration of reports, comments and information submitted by States parties under article 9 of the Convention

The following timetable for consideration of reports submitted by States parties at the forty-eighth session has been drawn up by the Secretary-General, in consultation with the Chairman, taking into account the relevant decisions taken by the Committee at its forty-seventh session.

In pursuance of established practice and in conformity with rule 64 of the rules of procedure, the Secretary-General has informed the States parties concerned of the tentative dates on which their respective reports are scheduled for consideration by the Committee, as follows:

7. Consideration of communications under article 14 of the Convention

In accordance with the provisions of chapter XVIII of its rules of procedure, the Committee will consider under this item communications which are or appear to be submitted to it under article 14 of the Convention.

In accordance with rule 88 of the rules of procedure, the meetings of the Committee during which communications under article 14 of the Convention are examined shall be closed.

8. Action by the General Assembly at its fiftieth session

- (a) Annual report submitted by the Committee on the Elimination of Racial Discrimination under article 9, paragraph 2, of the Convention

Following a request made by the Committee at its seventh session in 1973, this item is included yearly on the Committee's provisional agenda.

Pursuant to article 9, paragraph 2, of the Convention, the annual report of the Committee, covering its activities during the forty-sixth and forty-seventh sessions, was submitted to the General Assembly at its fiftieth session. The Committee will have before it the relevant summary records of the Third Committee and the relevant General Assembly resolution.

- (b) Effective implementation of international instruments on human rights, including reporting obligations under international instruments on human rights

During the fiftieth session of the General Assembly, this item was considered by the Third Committee jointly with a number of other items. The Committee will have before it the relevant summary records of the Third Committee and the relevant General Assembly resolution.

Additionally, for its consideration of item 8 (a) and (b) of the provisional agenda, the Committee will have before it the following documents:

- (a) Note of the Secretary-General transmitting to the General Assembly the report of the Sixth Meeting of persons chairing the human rights treaty bodies (A/50/505);
- (b) Relevant summary records and reports of the Third Committee;
- (c) Relevant General Assembly resolutions.

9. Submission of reports by States parties under article 9, paragraph 1, of the Convention

At its forty-eighth session, the Committee will have before it a note by the Secretary-General concerning the status of submission of reports by States parties in accordance with article 9 of the Convention (CERD/C/302). Part A of that document indicates reports received from States parties and pending consideration by the Committee. Part B of the document contains information relating to overdue reports.

10. Consideration of copies of petitions, copies of reports and other information relating to Trust and Non-Self-Governing Territories and to all other territories to which General Assembly resolution 1514 (XV) applies, in conformity with article 15 of the Convention

Under this item, the Committee will have before it a note by the Secretary-General (CERD/C/301) concerning article 15 of the Convention and listing, as appropriate, copies of petitions, reports and working papers relating to the Trusteeship Council and the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples.

11. Third Decade to Combat Racism and Racial Discrimination

At its 695th meeting (thirtieth session) in August 1984, the Committee decided to keep this item on its agenda and requested the Secretary-General to keep it informed of the relevant activities which would be undertaken in accordance with the Programme of Action for the Third Decade.

Among the matters to be considered under this agenda item, the Committee may wish to discuss the relevant action taken by the General Assembly at its fiftieth session and follow-up to its joint meeting with the Sub-Commission on Prevention of Discrimination and Protection of Minorities and the Special Rapporteur on contemporary forms of racism, racial discrimination and xenophobia and related intolerance, held on 8 August 1995.

For its consideration of this item the Committee will have before it the following documents:
