LETTER DATED 6 FEBRUARY 1996 FROM THE SECRETARY-GENERAL ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL

I have the honour to refer to your letter dated 1 February 1996 (S/1996/76) in which you inform me that the members of the Security Council concur in principle with my recommendation that the United Nations Preventive Deployment Force (UNPREDEP) become an independent mission which will have basically the same mandate, strength and composition of forces.

I appreciate this decision in principle by the Security Council. The financial and administrative implications regarding the establishment of UNPREDEP as an independent mission have in general terms been outlined in paragraphs 21 to 23 of my report of 29 January 1996 (S/1996/65).

These implications should be seen in the context of the necessary restructuring of the United Nations presence in the former Yugoslavia as a result of the expiration of the mandates of UNCRO, UNPROFOR and UNPF-HQ and the establishment of two new missions in Bosnia and Herzegovina and Croatia pursuant to Security Council resolutions 1035 (1995) and 1037 (1996). I am submitting separately a comprehensive report on these arrangements under the document symbol S/1996/83.

In the past, with regard to UNPREDEP, essential administrative, logistic and communications services were centrally provided as theatre assets by UNPF-HQ from within the budget of that headquarters and within the troop ceilings approved by the Security Council. With the termination of UNPF-HQ, these services need to be incorporated in the UNPREDEP budget and into that mission's authorized strength. As pointed out in paragraph 22 of my report S/1996/65, UNPREDEP's strength will have to be increased by 50 military personnel in order to provide for a continued engineering capability in support of its operations.

Previously, overall operational authority over the military components of the three operations in former Yugoslavia, including UNPREDEP, was exercised on my behalf through the Theatre Force Commander of UNPF-HQ. This arrangement has come to an end on 31 January 1996. Therefore, I will shortly appoint a Force Commander of UNPREDEP who will have authority over the military units and personnel of the force. This will require making the appropriate provision in the staffing table of that mission.

I should like to emphasize that these arrangements have in the past largely been covered in the budget of UNPF-HQ. Thus, the financial implications essentially represent a reallocation of resources previously provided for in the UNPF budget. As pointed out in my report, I intend to submit to the relevant United Nations bodies concrete proposals on the financial and administrative requirements of the proposed change in the status of UNPREDEP. These proposals will be submitted in conjunction with the financial and administrative arrangements for the liquidation of UNCRO, UNPROFOR and UNPF-HQ as well as for the new missions in Bosnia and Herzegovina and Croatia in order to enable the pertinent bodies of the General Assembly to assess the recommendations in a consolidated manner.

In light of the above and given the concurrence in principle by the Security Council to my recommendation that UNPREDEP become an independent mission, I would appreciate the Council's approval of the proposed increase of the authorized strength of UNPREDEP by 50 military personnel and of the appointment of a Force Commander of UNPREDEP. A statement outlining the financial implications for the adjustments required for UNPREDEP as an independent mission is issued as an annex to this letter.

### <u>Annex</u>

#### FINANCIAL IMPLICATIONS

- 1. As I indicated in paragraph 23 of my report to the Security Council dated 29 January 1996 (S/1996/65), it is my intention to revert to the relevant United Nations bodies at a later date with concrete proposals on the financial and administrative requirements of the proposed change in the status of the United Nations Preventive Deployment Force (UNPREDEP) in the former Yugoslav Republic of Macedonia. The following cost estimates are provided for the information of the Security Council.
- 2. The estimated cost associated with the change in status of the United Nations Preventive Deployment Force (UNPREDEP) in the former Yugoslav Republic of Macedonia to become an independent mission reporting directly to the United Nations headquarters in New York for a six-month period would be \$29 million. This estimate provides for 1,050 contingent personnel, 35 military observers, 26 civilian police, 73 international civilian staff and 127 locally recruited staff.
- 3. A breakdown of the estimated financial requirements, by main categories of expenditure, is attached for information purposes. Should the Security Council concur with my recommendation that UNPREDEP become an independent mission, it would be my recommendation to the General Assembly that the costs relating thereto should be considered an expense of the Organization to be borne by Member States in accordance with Article 17, paragraph 2, of the Charter of the United Nations and that the assessments to be levied on Member States be credited to a Special Account to be established for this purpose.
