RESOLUTION ADOPTED BY THE GENERAL ASSEMBLY

50/216. <u>Questions relating to the proposed</u> programme budget for the biennium 1996-1997

United Nations Mission for the Verification of Human Rights and of Compliance with the Commitments of the Comprehensive Agreement on Human Rights in Guatemala

1. Takes note of the report of the Secretary General $\underline{1}/$ and the recommendations of the Advisory Committee on Administrative and Budgetary Questions in its report; $\underline{2}/$

2. <u>Approves</u> the estimate of 7,124,800 United States dollars for the United Nations Mission for the Verification of Human Rights and of Compliance with the Commitments of the Comprehensive Agreement on Human Rights in Guatemala for the period from 1 January to 31 March 1996, under section 3 (Peace-keeping operations and special missions) of the proposed programme budget for the biennium 1996-1997; <u>3</u>/

2. <u>Approves</u> expenses, chargeable directly to the Fund, totalling 40,208,300 dollars net for the biennium 1996-1997 and an increase in expenses of 835,500 dollars net for the biennium 1994-1995, for the administration of the Fund;

3. <u>Authorizes</u> the United Nations Joint Staff Pension Board to supplement the voluntary contributions to the Emergency Fund for the biennium 1996-1997 by an amount not exceeding 200,000 dollars;
