STATUS OF THE INTERNATIONAL HUMAN RIGHTS INSTRUMENTS AND THE GENERAL SITUATION OF OVERDUE REPORTS

### Report of the Secretary-General

1. The present report contains updated information on the status of the international human rights instruments and the general situation of overdue reports as at 30 June 1994 in regard to the following seven instruments:

(a) The International Covenant on Economic, Social and Cultural Rights, adopted by the General Assembly on 16 December 1966 and entered into force on 3 January 1976;

(b) The International Covenant on Civil and Political Rights, adopted by the General Assembly on 16 December 1966 and entered into force on 23 March 1976;

(c) The International Convention on the Elimination of All Forms of Racial Discrimination, adopted by the General Assembly on 21 December 1965 and entered into force on 4 January 1969;

(d) The International Convention on the Suppression and Punishment of the Crime of Apartheid, adopted by the General Assembly on 30 November 1973 and entered into force on 18 July 1976;

(e) The Convention on the Elimination of All Forms of Discrimination against Women, adopted by the General Assembly on 18 December 1979 and entered into force on 3 September 1981;

(f) The Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, adopted by the General Assembly on 10 December 1984 and entered into force on 26 June 1987; and

(g) The Convention on the Rights of the Child, adopted by the General Assembly on 20 November 1989 and entered into force on 2 September 1990.

2. Since the Fourth meeting of persons chairing human rights treaty bodies, there has been a significant increase in the number of States parties to the human rights instruments. As at 30 June 1994, there were a total of 869 States parties to the seven treaties listed above, as compared with 762 States parties as at 1 September 1992.

3. On 30 June 1994 10 of the 184 Member States of the United Nations were not a party to any of the seven human rights instruments. Those States are the following: Andorra, Brunei Darussalam, Eritrea, Kazakhstan, Kyrgyzstan, Malaysia, Saudi Arabia, Singapore, South Africa and Uzbekistan.

4. The system of reporting under the seven instruments as at 30 June 1994 involved 177 States as compared with 164 in 1992 that were parties to at least one of these instruments. The number of overdue reports of these States parties totalled 1,040 (as compared with 871). Detailed information on the submission of reports and the general situation of overdue reports is contained in tables 1, 2 and 3 below.

#### <u>Table 1</u>

5. Table 1 below shows the total number of States parties to the seven instruments as at 30 June 1994 and at 1 September 1992 (for the sake of comparison) and the number of overdue reports under each instrument. It should be noted that article 9 (1) of the International Convention on the Elimination of All Forms of Racial Discrimination specifies a periodicity of one year for initial reports and every two years thereafter for periodic reports, which accounts, in part, for the very high number of reports overdue under that Convention.

#### <u>Table 2</u>

6. Table 2 below shows the number of reports which have been received each year by the treaty bodies from their inception through the first half of 1994. It should be noted that combined reports, which consist of two or more periodic reports submitted in a single document, have been counted in the table as one report. The listing does not include revised reports, additional information or special reports submitted in accordance with a special decision of the Committee concerned. Included in the totals are reports received from

the German Democratic Republic (which united with the Federal Republic of Germany in 1990 to form a single State) and from Czechoslovakia (which changed its name to the Czech and Slovak Republic in 1991 and was succeeded by the Czech Republic and Slovakia in 1993).

7. Table 2 clearly indicates that a majority of States parties are not respecting the obligation to report periodically under each of the treaties concerned.

It may be noted in table 2 that there has been an overall decrease in the 8. number of reports submitted under the International Covenant on Economic, Social and Cultural Rights and the International Convention on the Elimination of All Forms of Racial Discrimination. This decrease reflects, in part, changes in the reporting procedures which were recommended by the two treaty bodies concerned. By resolution 1988/4 of 24 May 1988, the Economic and Social Council endorsed the recommendation made by the Committee on Economic, Social and Cultural Rights that States parties be requested to submit a single comprehensive initial report within two years of the entry into force of the Covenant for the State party concerned, and thereafter comprehensive periodic reports at five-year intervals. That arrangement replaced one under which partial reports were to be submitted every two years starting within one year of entry into force. Consequently, States parties to the Covenant have been submitting fewer reports covering only certain articles of the Covenant rather than comprehensive reports. Similarly, at its thirty-sixth session, held in August 1988, the Committee on the Elimination of Racial Discrimination endorsed the proposal made at the eleventh meeting of States parties to the Convention that, following the submission of initial comprehensive reports to the Committee, States are to submit further comprehensive reports every four years (i.e. on every second occasion when reports are due) and to submit brief updating reports on the intervening occasions. Consequently, States parties to that Convention have been submitting more combined comprehensive reports.

#### <u>Table 3</u>

9. Table 3 below lists the States parties to the various instruments and the number of overdue reports under each instrument. The total number of treaties to which a given State is a party and the total number of overdue reports of each State is also given. The absence of any number indicates that the State is not a party to the instrument concerned.

10. It should further be noted, with respect to the practice of the Committee on the Elimination of Racial Discrimination (CERD) and the Committee on the Elimination of Discrimination against Women (CEDAW), that successive overdue reports may be submitted in a single consolidated document. This practice has also been followed by the Committee against Torture (CAT), which reviews the situation of overdue reports on a case-by-case basis.
