1995 UNITED NATIONS PLEDGING CONFERENCE FOR DEVELOPMENT ACTIVITIES

REPORT OF THE 1995 UNITED NATIONS PLEDGING CONFERENCE FOR DEVELOPMENT ACTIVITIES

A. Opening and duration of the session

- 1. By its resolution 42/215 of 21 December 1990, the General Assembly decided, inter alia, that the adoption and signing of the Final Act of the Conference should be replaced by the adoption of a procedural report of the Conference.
- 2. The Conference was held at United Nations Headquarters on 1 and 2 November 1995.
- 3. The Conference was opened by the Secretary-General.

B. Attendance

E. Announcement of pledges

The Conference heard the announcement of pledges by a number of Governments to one or more programmes and funds, and took note of the fact that several Governments were not in a position to announce their contributions but proposed to communicate their announcement of such contributions to the Secretary-General as soon as they were in a position to do so after the closure of the Conference.
