Note by the Secretariat

1. The proposed organization of work of the Commission for Social Development at its special session of 1996 (see annex) has been prepared pursuant to Economic and Social Council resolution 1995/60 and decision 1995/324, as well as General Assembly resolution 50/161, in order to facilitate consideration of agenda items within the time-frame available and in accordance with the conference services allocated to the Commission.
2. Attention is drawn to the draft provisional agenda for this session contained in document E/CN.5/1996/1 and the related annotations, which set out the tasks entrusted to the Commission at its special session of 1996 by the Council and the General Assembly.

5. The special session of the Commission for Social Development is scheduled to meet from 21 to 24 and 28 to 31 May 1996. Monday, 27 May 1996 is an official public holiday; no meetings have been scheduled.
