At its third session, the Commission on Sustainable Development decided to set up an ad hoc open-ended working group in order to prepare for its fourth session, which would deal with financial resources and mechanisms as well as changing production and consumption patterns. In addition, the working group would address related aspects of transfer of environmentally sound technology, cooperation and capacity-building, in accordance with the decision contained in paragraph 217 of chapter I of the report of the Commission on its second session. The Commission further requested the Bureau in consultation with member States and with the assistance of the Secretariat to elaborate the provisional agendas for the ad hoc open-ended inter-sessional working group and proposals on organizational modalities.
