Report on the measures taken with regard to the request from the Ethiopian authorities for the extradition of three Egyptians suspected of involvement in the attempted assassination of the President of Egypt and thought to be in the Sudan

- 1. In a letter from the President of Ethiopia to the President of the Sudan dated 25 July 1995 and received on 27 July 1995, the Ethiopian Government submitted a request for the extradition of three foreigners of Egyptian origin, namely Mustafa Hamza, Izat or Yasim, and Husayn Ahmad Shait Ali. The letter stated that the persons known as Mustafa Hamza and Izat were already in the Sudan when Husayn Ahmad Shait Ali entered the country on the day of the incident by Sudan Airways using a forged Sudanese passport.
- 2. As soon as the request was received, an inter-agency commission was formed under the chairmanship of the Public Prosecutor and including three police officers, an officer from the security service and an officer from military intelligence. The decree establishing the commission, issued on 28 July 1995, granted it full investigative powers and gave it one week in which to complete its task.
- 3. The commission carried out its work with respect to procedures for the extradition of the wanted criminals in the light of the 1964 Extradition Treaty between Ethiopia and the Sudan, which was ratified in 1966.
- 4. The investigating authorities studied the request submitted by the Ethiopian authorities, together with its attachments, and took the following series of measures with a view to bringing to light the facts relating to the information provided in the request:
- (a) The commission had the Attorney General order the prosecuting attorney in charge to issue an arrest warrant for the wanted men.
- (b) It also had the Public Prosecutor issue a warrant for the arrest of the three men.
- (c) On 31 July 1995 a bulletin giving the available descriptions of the men was issued and circulated by the Central Criminal Investigation Department and the Central Military District to all points of entry to and egress from Khartoum, all police stations and departments, all checkpoints on roads leading into cities and all ports, airports and border crossings in order to ensure that the men were arrested and to prevent their movement or departure from the country.
- (d) On 31 July 1995 the commission wrote to the Passport Office requesting information about the men, including details of their dates of entry to the Sudan, their addresses and their residence permits, and ordering that they be

prohibited from leaving the country until such time as investigations were completed.

- (e) On 31 July 1995 the commission wrote to the Passport Office requesting information about passport No. 63203, issued in the name of Faysal Lutfi Abd al-Latif, and details of the bearer's entry to the Sudan from Ethiopia on 26 July 1995.
- (f) The commission received notification from the Passport Office that the wanted persons had no immigration record and that any entry they had made to the Sudan had gone unrecorded since they were Egyptian nationals and thus not subject to immigration controls under the reciprocal arrangements that had been in force between the two countries for decades. The search of arrival cards from past years was continuing in order to ascertain whether or not they had entered the country. The commission was also informed that passport No. 63203 appeared in the records as having been issued to the Sudanese citizen Izz al-Din Ala' al-Din Awsh-Allah and that there was no record in the name of Faysal Lutfi Abd al-Latif. Khartoum Airport records included an entry card in that name among those of passengers arriving on Sudan Airways flight 327 from Addis Ababa on 26 July 1995.
- (g) On 29 July 1995 the commission began looking for the locations mentioned in the request from the Ethiopian authorities, such as the addresses of the person known as Mustafa Hamza or Izz al-Din. It transpired that there was evident confusion about the locations, and there were contradictions that made it impossible for the commission to find them. As a result of these contradictions, it could not locate the exact properties described but undertook such investigations as were possible in the light of the available data. Searches were made of seven houses in Arkawit, a house in the Imarat area and a house in the Kober (Cooper) quarter, as well as a number of farms around Khartoum. These measures did not result in the arrest of any of the three men, and searches are continuing.
- (h) The commission carried out its inquiries through the relevant security services and on the basis of the periodic reports submitted by airports, seaports, border crossings and city exit and entry points. It found nothing to indicate movement by any of the persons concerned or that any of them had entered or left the country.
- establishing the commission, the investigating authorities submitted a report to the Minister of the Interior indicating that the investigation had not been completed and that it was still under way. The commission highlighted the difficulties it had encountered because of the submission of the Ethiopian request more than one month after the incident had taken place and because insufficient information had been provided on the wanted men. Names were incomplete, and the descriptions given were insufficient for purposes of identification and could not lead to arrests. The Ethiopian authorities had also failed to submit any statements from witnesses or any documents to support their claim that the persons known as Mustafa Hamza and Izat were in the Sudan. The documents submitted by the Ethiopian court indicated that their whereabouts were unknown, and the Extradition Treaty between the two countries relies

exclusively on documents from the relevant court. The commission has requested additional information from the Ethiopian side.

- (j) When, on 7 February 1996, the investigating authorities received reports from the Central Criminal Investigation Department and the Central Military District that efforts for the arrest of the wanted men had met with no success, they proceeded to take the legal step specified for such an eventuality, namely the dissemination of bulletins concerning those being sought asking that they should be turned over to the nearest police station within a specified period of time. The bulletins included what descriptions were available of the men and urged the general public to participate in the search for them and in their apprehension or to give information about them. The bulletins were broadcast on television and radio and published in the Arabic and English daily newspapers over a three-day period without leading to the arrest of the suspects or to any information about them being given to the investigating authorities.
- (k) With the aim of advancing the work of the investigation, the investigating authorities recommended that measures should be taken to register Egyptian nationals. Beginning on 9 August 1995 all Egyptian nationals arriving in the country, other than those carrying diplomatic passports, were registered. On 7 February 1996 the commission notified all Egyptian nationals who had been residing in the Sudan before the registration system came into operation that they should register at the nearest police station.
- (1) The investigating authorities requested information on the wanted men from the general secretariat of the International Criminal Police Organization (ICPO-Interpol) through its liaison office in Khartoum. On 15 February 1996 a reply was received saying that no information on them was available.
- (m) The Minister of the Interior issued a directive to governors and local and popular authorities to assist in the search for the foreigners being sought, and on 26 February 1996 it was announced that a financial reward would be given to anyone helping to arrest the men or providing information about them. Governors gave instructions to governorates and localities that every effort should be made to look for the wanted men.
- (n) The investigating authorities are examining the periodic reports submitted by all departments, checkpoints, ports, airports and border crossings in order to detect and prevent the departure of any of the suspects should they be here.
- 5. The investigating authorities have found that the records of Khartoum International Airport include a card bearing the name of Faysal Lutfi Abd al-Latif as having been among the passengers who arrived on Sudan Airways flight 327 from Ethiopia on 26 June 1995. The address given on the entry card is "near the mosque, Kober quarter". A search was made of every part of this neighbourhood, but no address was found for him. Airport taxi records were also examined but did not produce the name of the wanted man. The passport he was carrying was forged.

- 6. The investigating authorities have found nothing to indicate the arrival in the Sudan of the person known as Mustafa Hamza and the person known as Izat or Yasim or to show that they had entered the country at any time in the past. Similarly, there is no record of any of the three men having left the Sudan through legal points of departure such as airports, seaports and border crossings.
- 7. The investigating authorities have received no information to supplement that given in the original Ethiopian request. They therefore reinforced their initial request and the remarks they had made concerning the Ethiopian request with a letter dated 14 February 1996 addressed to the Ethiopian Ministry of Foreign Affairs elucidating the comments made and indicating the information required with a view to obtaining that information from the Ethiopian authorities.
- 8. The search and the investigation are continuing within the scope of the information contained in the request submitted by the Ethiopian authorities. For more satisfactory results to be achieved, more information must be provided on previous movements by the suspects between Ethiopia and the Sudan and fuller and clearer descriptions of the locations and persons involved must be made available. Documents and testimony must be submitted to support the Ethiopian claim that Mustafa Hamza and Izat are in the Sudan, given that the letter from the court, which is the central document on which the operation of the Extradition Treaty depends, gives no indication that they are in the country. Similarly, the measures taken by the commission have produced nothing to support the claim that they are in the Sudan.

# Jurisdictions of the Committee

2. The Committee has the jurisdiction to consider the requisition made by the Ethiopian authorities respecting the surrender of three suspects who are alleged to have conspired to Commit an attempted homicide on the life of the Egyptian President, and to take all the necessary measures relating to this requisition pursuant to the Criminal Procedure Act, 1991, The Extradition Act, 1957, and the Bilateral Extradition Treaty between the Sudan and Ethiopia, 1966.

# Powers of the Committee

- 3. The Committee shall have the following powers:
- a. To look into all the relevant documents and order the presence of any person and compel such a person or persons to appear before the Committee to give their statements.

- b. To address all the Departments and authorities regarding its mission.
- c. The Committee may seek the assistance of any person to complete its mission.

# The Report of the Committee





# His Role in The Terrorist Act

Mustafa Hamza is the person who masterminded and spearheaded the terrorist activity and is known to have traveled to Ethiopia as early 2 years before the attempt on the life of the Egyptian President to prepare the ground for the implementation of the terrorist plan which he initiated, followed closely and also executed as the leader of the whole terrorist effort.

- 1, Reference the requision made by the Etjiopian respecting the surrender of three Egyptian national who are alleged to have conspired to the attempted homicide on the life of the Egyptian President and who are suspected to have left to Sudan.
- 2, There are some significant information needed by the Committee for the sake of investigation, these are -
- a, Complance with article 8(4) of the Bilateral Extradition Treaty between Sudan and Ethiopia, 1966, by providing the particulars that would assist in ascertaing the identities of the following suspects:-
  - 1. Mustafa Hamza
  - 2. Izat or Yasim.
  - 3. Husayn Ahmed Shiat Ali.

The particulars need are the passport photo of the suspect Izat and the descriptions of the three suspects and thier special marks.

- b, Illustration of the locations mentioned in the requision, these locations as provided are inadequately described, are very confusing and do not comply with the geographical realities Khartoum town.
- c, The documents and the statements that would support the presence of Mustafa Hamza and Izat or Yasim in the Sudan or their entry thereto befor or after the incident.
- d, The informations relating to the movements of the suspects between Sudan and Ethiopia befor the incident.
- e, It has been stated in Ref.No.2346/87 dated July the 25th.1995 per j. Wajebu Amare 9 court of Waredu, the 14th.administrative region in Ethiopia that the "whereabouts of the three suspects are yet unknown"

Why then was the requision submitted? How can the Ethiopian authorities allege that the three suspects havee fled to Sudan and state that their whereabouts are yet unknown? What is the rationale behind the Extradition requision when there is no clue that the suspects have fled to Sudan.

g, Article (11) of the Bilaterad Extradition Treaty between Sudan and Ethiopia, 1966 stipulates that the statements made by the accused and their testemonies and their admissions and summons and announcements their passport photos. The persual of these items would help the Committee to know how far the suspects can be linked to the attempted homocide and hint or clue as to whether they have fled to Sudan or not.

h,Please take note of the aforesaid informations and request a reply from the Ethiopian authorities.

EXTRADITION TREATY BETWEEN THE GOVERNMENT OF THE REPUBLIC OF THE SUDAN AND THE IMPERIAL ETHIOPIAN GOVERNMENT

The Government of the Republic of the Sudan and the Imperial Ethiopian Government,

Desiring to make provision for the reciprocal extradition of criminals,

Have resolved to conclude a Treaty for that purpose, and to that end have appointed as their plenipotentiaries:

For the Republic of the Sudan H.E. Sayed Ahmed Kheir,

For the Imperial Ethiopian Government H.E. Ato Ketema Yifru, who, having communicated to each other their respective full powers, found in good and due form, have agreed as follows:

## ARTICLE I

The Contracting Parties agree subject to the terms of this Treaty to extradite persons accused or convicted of any of the offences enumerated in the Treaty which were committed under such circumstances as to fall within the jurisdiction of one Contracting Party and who are found in the territory of the other Contracting Party.

## ARTICLE II

- (1) Extradition shall be granted reciprocally for the following offences:
  - 1. Murder or attempt or conspiracy to murder.
  - 2. Manslaughter.
  - 3. Counterfeiting or altering money or issuing what is counterfeit or altered.
  - 4. Embezzlement and larceny.
  - 5. Obtaining money or goods by false pretences.
  - 6. Fraudulent misappropriations or fraud by a bailee, banker, agent, factor or trustee, or by a director, member or public officer of any company.
  - 7. Rape.

- 8. Abduction.
- 9. Child stealing.
- 10. Burglary and house-breaking.
- 11. Arson.
- 12. Robbery with violence.
- 13. Threats with intent to extort money or other things of value.
- 14. Procuration.
- 15. Assault occasioning grievous bodily harm.
- 16. Offences against laws outlawing slavery.
- 17. Kidnapping.
- 18. False imprisonment.
- 19. Perjury.
- 20. Subornation of perjury.
- 21. Bribery.
- 22. Offences relating to narcotics.
- 23. Sinking or destroying a vessel at sea, or attempting or conspiring to do so.
- 24. Assault on board a ship on the high seas with intent to destroy life or to do grievous bodily harm.
- 25. Revolt or conspiracy to revolt, by two or more persons, on board a ship on the high seas against the authority of the master, or on board an aircraft against the authority of the captain.
- 26. Piracy.
- 27. Abortion or attempted abortion.
- 28. Banditry.
- 29. Traffic in arms.
- 30. Offences against exchange control laws.
- 31. Serious offences against customs laws.

Provided that these or substantially similar offences are punishable by the laws of both countries, if committed within their respective jurisdictions.

- (2) Extradition shall be granted also for participation in the above offences provided such participation is punishable by the laws of both Contracting Parties.
- (3) Extradition may also be granted at the discretion of the requested Contracting Party in respect of any other offences for which it can be granted according to the laws of both Contracting Parties.

## ARTICLE III

In no case, nor under any circumstances whatever, shall the Contracting Parties be bound to surrender their own nationals as determined by their respective laws.

## ARTICLE IV

The extradition shall not take place if, subsequent to the commission of the crime or offence or the institution of the penal prosecution or the conviction thereon, exemption from prosecution or punishment has been acquired by lapse of time, according to the laws of the country to which extradition is desired.

## ARTICLE V

- (1) A person surrendered can in no case be kept in custody or be brought to trial in the territory of the Contracting Party to whom the surrender has been made for any other crime or offence, or on account of any other matters, than those for which the extradition shall have taken place, until he has been restored, or has had an opportunity of returning, to the territory of the Contracting Party by whom he has been surrendered.
- (2) The provisions of the preceding paragraph shall not apply to crimes or offences committed after the extradition.

## ARTICLE VI

A requisition for extradition shall not be founded on a sentence passed in contumacium.

## ARTICLE VII

There shall be no extradition for offences of a political character and no extradition if the person whose extradition is requested proves that requisition

for his surrender has in fact been made with a view to trying or punishing him for a crime or offence of a political character.

## ARTICLE VIII

- (1) The requisition for extradition shall be made through diplomatic channels.
- (2) The requisition for the extradition of an accused person must be accompanied by a warrant of arrest issued by a court in the territory of the Contracting Party requiring the extradition, and by such evidence as, according to the laws of evidence of the place where the accused is found, would justify his arrest.
- (3) If the requisition relates to a person already convicted, it must be accompanied by the sentence of condemnation passed against the convicted person by the competent court in the territory of the Contracting Party who makes the requisition for extradition.
- (4) In all cases particulars which may help to establish the identity of the person whose extradition is sought shall be furnished in so far as practicable.

## ARTICLE IX

If the requisition for extradition be in accordance with the terms of this Treaty, the competent authorities in the territory of the Contracting Party applied to shall proceed to the arrest of the fugitive.

## ARTICLE X

The extradition shall take place when the evidence is found to be sufficient, according to the laws of the territory from which extradition is desired, either to justify the committal of the prisoner for trial, if the crime or offence of which he is accused had been committed in that territory, or to prove that the prisoner is the identical person convicted by the courts of the Contracting Party who makes the requisition; provided, however, that the crime or offence of which he has been convicted is one in respect of which extradition could, at the time of the conviction, have been granted by the Contracting Party applied to, and provided, further, that no criminal shall be surrendered until after the expiration of fifteen days from the date of his committal to prison to await the warrant for his surrender.

## ARTICLE XI

(1) In the examinations which they have to make in accordance with the foregoing stipulations, the authorities of the Contracting Party applied to shall admit as evidence the sworn depositions or the affirmations of witnesses taken in the territory of the other Contracting Party, or copies thereof, and likewise the warrants and sentences issued therein, or copies thereof, and

certificates of, or judicial documents stating the fact of a conviction, provided the same are authenticated as follows:

- (a) A warrant, or copy thereof, must purport to be signed by a judge or a magistrate of the other Contracting Party, or purport to be certified under the hand of a judge or magistrate of the Contracting Party to be a true copy thereof, as the case may require.
- (b) Depositions or affirmations, or the copies thereof, must support to be certified, under the hand of a judge, a magistrate or law officer of the other Contracting Party, to be the original depositions or affirmations, or to be true copies thereof, as the case may require.
- (c) A certificate of, or judicial document stating the fact of, a conviction must purport to be certified by a judge or magistrate of the other Contracting Party.
- (2) In every case the warrant, deposition, affirmation, copy, certificate or judicial document must be authenticated, either by the oath of some witness or by being sealed with the official seal of the Minister of Justice or some other Minister of the other Contracting Party, or by any other mode of authentication for the time being permitted by the law of the territory from which extradition is desired.

## ARTICLE XII

If the individual claimed by one of the Contracting Parties in the pursuance of the present Treaty should be also claimed by one or several other powers on account of other crimes or offences committed within their respective jurisdictions, his extradition shall be granted to the power whose claim is earliest in date, unless that claim is waived.

## ARTICLE XIII

- (1) If sufficient evidence for the extradition be not produced within sixty days from the date of the apprehension of the fugitive, or within such further time as the Court of the Contracting Party applied to shall direct, the fugitive shall be set at liberty.
- (2) If, after a fugitive has been held judicially declared for surrender under this Treaty, the fugitive is not removed from the territory from which his extradition is desired within thirty days time he may be set at liberty.

## ARTICLE XIV

A Contracting Party who has consented to surrender a fugitive criminal in pursuance of the present Treaty shall defray the expenses occasioned by his arrest and detention and by his conveyance to the frontier of that Contracting Party.

## ARTICLE XV

- (1) The present Treaty shall be ratified, and the instruments of ratification shall be exchanged at Khartoum as soon as possible. It shall come into force immediately after the exchange of the instruments of ratification.
- (2) Either of the Contracting Parties may at any time give notice to the other through diplomatic channels of its desire to terminate the present Treaty and, if notice is given, the Treaty shall cease to have effect six months after the date of the receipt of the notice of termination.

In witness whereof the above-named Plenipotentiaries have signed the present Treaty and have affixed thereto their seals.

Done in duplicate at Khartoum this twenty-ninth day of March 1964 in the English language.
