**RAPPORT SUR LA SUITE DONNÉE À LA DEMANDE DES AUTORITÉS ÉTHIOPIENNES
CONCERNANT L'EXTRADITION DE TROIS ÉGYPTIENS**

1. Dans une lettre datée du 25 juillet 1995, et reçue le 27 du même mois, adressée par le Président éthiopien à son homologue soudanais, le Gouvernement éthiopien demande l'extradition des trois ressortissants égyptiens dont les noms suivent :

- Mustapha Hamza
- Izzet ou Bassem
- Hussein Ahmed Chayt Ali

D'après le contenu de cette lettre, les nommés Mustapha Hamza et Izzet se trouveraient déjà au Soudan, tandis que Hussein Ahmed Chayt Ali y serait entré avec un faux passeport le jour même de l'attentat à bord d'un appareil de la compagnie aérienne soudanaise.

2. Dès réception de la demande d'extradition, il a été créé une commission d'enquête présidée par le Procureur général et composée des représentants des divers services concernés, à savoir trois officiers de police, un officier des services de sécurité et un officier de la Direction du renseignement militaire. Le décret du 27 juillet 1995 portant création de cette commission, qui lui confère tous les pouvoirs et prérogatives en matière de recherches et d'investigations, lui a fixé un délai d'une semaine pour mener à bien ses travaux.

3. En application de la Convention d'extradition signée entre le Soudan et l'Éthiopie en 1964 et ratifiée en 1966, la Commission a commencé ses investigations pour retrouver et extradier les trois criminels recherchés.

4. Après avoir procédé à un examen minutieux de la demande d'extradition, les autorités chargées de l'enquête se sont employées à vérifier les renseignements fournis par les autorités éthiopiennes en annexe à leur demande. C'est ainsi que les mesures suivantes ont été prises :

a) Le Procureur général a donné au substitut du parquet une instruction écrite lui demandant de lancer un mandat d'arrêt contre les suspects recherchés;

b) Le Ministère public a lancé un mandat d'arrêt contre les trois suspects;

c) Le 31 juillet 1995, un avis de recherche comprenant tous les renseignements concernant les suspects recherchés a été diffusé par la Direction centrale des recherches et de la région militaire centrale à tous les points d'entrée et de sortie de Khartoum, à tous les postes et commissariats de police et points de contrôle à l'entrée des villes et à tous les ports, aéroports et postes frontière afin de retrouver les trois suspects recherchés et de les arrêter;

d) Le 31 juillet 1995, la Direction générale des passeports a été saisie pour fournir les renseignements suivants sur les suspects recherchés : date d'entrée au Soudan, adresse et justification du lieu de résidence. La Direction a également reçu pour instruction de les empêcher de quitter le pays jusqu'à la conclusion de l'enquête;

e) Le 31 juillet 1995 également, la Direction générale des passeports a été invitée à fournir les renseignements dont elle dispose sur le passeport No 63203 délivré au nom de Fayçal Lotfi Abdellatif qui serait entré au Soudan le 26 juin 1995 en provenance d'Éthiopie;

f) Dans sa réponse à la Commission d'enquête, la Direction générale des passeports indique qu'elle ne dispose d'aucun renseignement sur les suspects recherchés et qu'il n'existe aucune trace de leur entrée au Soudan du fait qu'il s'agit de ressortissants égyptiens qui ne sont pas inscrits sur les registres de l'immigration et ce, conformément à la pratique établie entre l'Égypte et le Soudan depuis des dizaines d'années. Toutefois, la Direction continue de vérifier les cartes d'entrée des années précédentes. Elle précise par ailleurs que le passeport No 63203 a été délivré à un citoyen soudanais du nom de Azzedine Ala'Eddin Aouchallah et que le nom de Fayçal Lotfi Abdellatif ne figure pas sur ses registres. Par ailleurs, les dossiers de la police de l'aéroport de Khartoum comportent une fiche de débarquement au nom de Fayçal Lotfi Abdellatif, entré au Soudan le 26 juin 1995 à bord du vol 327 de la compagnie aérienne soudanaise en provenance d'Addis-Abeba;

g) Le 29 juillet 1995, la Commission d'enquête a commencé la vérification des différentes adresses où pourrait se trouver Mustapha Hamza ou Azzedine en se basant sur les renseignements fournis par les autorités éthiopiennes. Or, il s'est avéré que ces adresses comportaient certaines contradictions et imprécisions de sorte que la Commission n'a pas pu repérer avec précision les immeubles ou maisons en question. Elle a néanmoins inspecté et fouillé sept maisons dans le quartier d'Arkouwit, une maison dans la zone des cités et une autre dans le quartier de Kouber. Elle a également fouillé plusieurs maisons de la banlieue de Khartoum, mais sans réussir à retrouver la trace des trois suspects recherchés. Les opérations de recherche se poursuivent;

h) La Commission a poursuivi ses recherches en faisant appel aux services de sécurité spécialisés et en se fondant sur les rapports périodiques transmis par les services de police des ports et aéroports, ainsi que les postes frontière et points de contrôle à l'entrée et à la sortie des villes, sans réussir à retrouver la trace des trois suspects recherchés;

i) Après l'expiration du délai de sept jours qui leur a été imparti, les autorités chargées de l'enquête ont présenté un rapport au ministre de l'intérieur dans lequel elles l'informent que l'enquête n'était pas terminée et que les recherches se poursuivaient. Le rapport souligne par ailleurs les difficultés rencontrées par la Commission d'enquête en raison de la réception tardive de la demande éthiopienne d'extradition (plus d'un mois après l'attentat) et de l'insuffisance des renseignements concernant les suspects. En effet, leur identité est incomplète et la description fournie ne suffit pas pour les identifier. En outre, les autorités éthiopiennes ne fournissent aucune preuve (témoignages ou documents) à l'appui de l'affirmation selon laquelle les nommés Mustapha Hamza et Izzet se trouveraient au Soudan. De plus, d'après les documents transmis par le tribunal éthiopien, le lieu de résidence des suspects n'est pas connu. En conséquence, conformément aux dispositions de la Convention

d'extradition entre les deux pays qui stipulent que les demandes d'extradition doivent être étayées par des documents transmis par le tribunal concerné du pays requérant, la Commission a demandé aux autorités éthiopiennes de lui fournir des informations complémentaires;

j) Après avoir reçu le 7 février 1996 les rapports des services centraux de recherche et de la région militaire centrale qui indiquent que les recherches effectuées pour retrouver les suspects n'avaient pas abouti, les autorités chargées de l'enquête ont pris les dispositions prévues par la loi, à savoir la publication d'un avis de recherche dans les médias. Cet avis de recherche, qui comporte une description des suspects, précise qu'ils doivent être remis dans les plus brefs délais au poste de police le plus proche. Ainsi, toute la population a été invitée à participer à la recherche et à l'arrestation des suspects ou à fournir tout renseignement les concernant. Cet avis, qui a été diffusé pendant trois jours consécutifs à la télévision, à la radio et dans les quotidiens en langues arabe et anglaise, n'a donné aucun résultat;

k) Soucieuses de ne ménager aucun effort pour poursuivre les recherches, les autorités chargées de l'enquête ont décidé de procéder au recensement de tous les ressortissants égyptiens. Ainsi, à partir du 9 août 1995, tous les citoyens égyptiens, à l'exception des détenteurs de passeports diplomatiques, ont commencé à être enregistrés à leur entrée au Soudan. Par ailleurs, la Commission d'enquête a demandé le 7 février 1996 à tous les ressortissants égyptiens qui résident au Soudan de s'inscrire auprès du poste de police le plus proche;

l) La Commission d'enquête a demandé au Secrétariat général de l'Organisation internationale de police criminelle (INTERPOL), par l'intermédiaire de son bureau de Khartoum, de lui fournir tous les renseignements dont elle dispose sur les suspects. Le 15 février 1996, le Secrétariat général d'INTERPOL a informé la Commission qu'il ne disposait d'aucun renseignement à leur sujet;

m) Le ministre de l'intérieur a donné instruction à tous les gouverneurs de province, aux autorités locales et aux collectivités de participer aux recherches. Le 26 février 1996, il a annoncé qu'une récompense serait versée à toute personne qui aiderait à l'arrestation des suspects ou fournirait des renseignements à cet effet. En outre, les gouverneurs ont donné instruction aux autorités provinciales et locales de déployer tous les efforts nécessaires pour rechercher les suspects;

n) Les autorités chargées de l'enquête examinent régulièrement les rapports périodiques émanant des services de police des ports et aéroports ainsi que des postes frontière afin d'empêcher les suspects de quitter le pays au cas où ils s'y trouveraient.

5. Les autorités chargées de l'enquête ont pu établir que les registres de police de l'aéroport de Khartoum comportaient une fiche de débarquement au nom de Fayçal Lotfi Abdellatif, entré au Soudan le 26 juin 1995, à bord du vol 327 de la compagnie aérienne soudanaise en provenance d'Éthiopie. L'adresse portée sur la fiche mentionne le quartier de Kouber dans les environs de la mosquée, mais toute la zone a été fouillée sans résultat. Par ailleurs, ce nom ne figure pas sur les registres du service des taxis de l'aéroport, ce qui prouve que le suspect était muni d'un faux passeport.

6. Les autorités chargées de l'enquête n'ont pu recueillir aucun renseignement prouvant que les dénommés Mustapha Hamza et Izzet ou Bassem sont entrés au Soudan. De même, il n'existe aucune trace de leur sortie du pays dans les ports, aéroports et postes frontière terrestres.

7. Les autorités chargées de l'enquête n'ont pu obtenir aucun renseignement complémentaire en dehors de ceux qui étaient joints à la demande d'extradition présentée par l'Éthiopie. C'est pourquoi, le 14 février 1996, elle a saisi par écrit le Ministère des affaires étrangères pour lui demander de solliciter des précisions et renseignements complémentaires auprès des autorités éthiopiennes.

8. Les opérations de recherche se poursuivent sur la base des renseignements communiqués par les autorités éthiopiennes, mais pour obtenir de meilleurs résultats, les autorités chargées de l'enquête ont besoin d'informations complémentaires sur les déplacements antérieurs des suspects entre l'Éthiopie et le Soudan, d'une description physique plus détaillée, de leur lieu de résidence supposé ainsi que de documents prouvant la présence au Soudan des suspects Mustapha Hamza et Izzet. Aux termes de la Convention d'extradition entre les deux pays, seule la demande du Tribunal fait foi. Or, cette dernière ne fait pas mention de leur présence au Soudan, comme le confirment les conclusions de la Commission d'enquête.

Jurisdictions of the Committee

2. The Committee has the jurisdiction to consider the requisition made by the Ethiopian authorities respecting the surrender of three suspects who are alleged to have conspired to Commit an attempted homicide on the life of the Egyptian President , and to take all the necessary measures relating to this requisition pursuant to the Criminal Procedure Act , 1991 , The Extradition Act , 1957 , and the Bilateral Extradition Treaty between the Sudan and Ethiopia , 1966.

Powers of the Committee

3. The Committee shall have the following powers :-

a. To look into all the relevant documents and order the presence of any person and compel such a person or persons to appear before the Committee to give their statements.

b. To address all the Departments and authorities regarding its mission.

c. The Committee may seek the assistance of any person to complete its mission.

The Report of the Committee

4. The Committee shall submit its report in a period not exceeding seven days from the date of its formation .

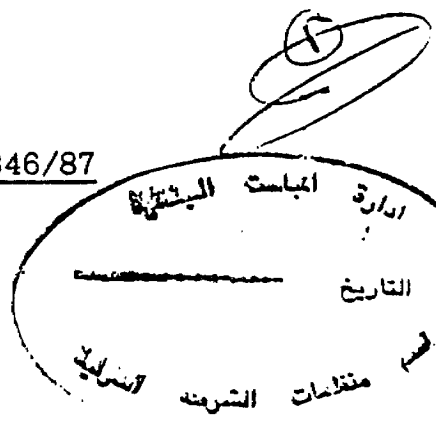

CURRENT ADDRESS IN SUDAN

MUSTAFA HAMZA IS LIVING IN A HOUSE LOCATED BEHIND THE ARABIC MARKET, KHARTOUM (it has been learnt that the market, which was active for some time, is no longer used.) CURRENTLY, HE LIVES IN THE ARKAWIT SECTION OF KHARTOUM, BEHIND ALSUK AL ARBIA, TOGETHER WITH HIS FAMILY.

THIS HOUSE IS LOCATED APPROXIMATELY THREE-AND-HALF MILES SOUTH-EAST OF THE AIRPORT, PAST AFRICAN UNIVERSITY, IN THE EAST ARKAWIT SECTION. MUSTAFA'S RESIDENCE IS A TWO-STORY ROOM CONNECTED THROUGH INTERCOM, AND IS COMPLETELY SURROUNDED BY A FOUR METER STONE WALL. THE MAIN ENTRANCE IS A BLACK PAINTED STEEL GATE THAT SWINGS TO THE OUTSIDE.

Mustafa Hamza is the person who masterminded and spearheaded the terrorist activity and is known to have traveled to Ethiopia as early 2 years before the attempt on the life of the Egyptian President to prepare the ground for the implementation of the terrorist plan which he initiated, followed closely and also executed as the leader of the whole terrorist effort.

I, Dr. Abdel Rahman Ibrahim, the Director for Public Prosecution, issues this proclamation in furtherance to the previous two warrants of arrests dated July the 29th, 1995 and August the 5th, 1995, pursuant to section 78 of the Criminal Procedure Act, 1991.

Taking note of the requisition for surrender made by the Ethiopian Judicial Authority pursuant to the Extradition Treaty concluded between the Sudan and Ethiopia, ratified 1966, I took cognizance of the fact that you are alleged to have committed a criminal conspiracy relating to the attempted homicide of the Egyptian President in Addis Ababa on the 26th of June, 1995.

I also took cognizance of the fact that Woreda 9 court, Region 14 Administration, of Ethiopia authorized your detention in its order No. 2346/87 dated July 25/1995 and that your whereabouts are unknown, though you are suspected to have fled to the Sudan.

I therefore hereby authorize your detention and order you to surrender and report to the nearest Police station in a period not exceeding a week from the date of issuing this proclamation.

The Public is requested to assist in the detention and arrest of the forementioned accused whose identity has been described by the Ethiopian Judicial Authority as follows:-

1, Reference the requisition made by the Etjiopian respecting the surrender of three Egyptian national who are alleged to have conspired to the attempted homicide on the life of the Egyptian President and who are suspected to have left to Sudan.

2, There are some significant information needed by the Committee for the sake of investigation, these are -

a, Compliance with article 8(4) of the Bilateral Extradition Treaty between Sudan and Ethiopia ,1966,by proding the particulars that would assist in ascertaing the identities of the following suspects:-

1. Mustafa Hamza
2. Izat or Yasim .
3. Husayn Ahmed Shiat Ali .

The particulars need are the passport photo of the suspect Izat and the descriptions of the three suspects and thier special marks.

b, Illustration of the locations mentioned in the requisition ,these locations as provided are inadequately described ,are very confusing and do not comply with the geographical realities Khartoum town.

c, The documents and the statements that would support the presence of Mustafa Hamza and Izat or Yasim in the Sudan or their entry thereto befor or after the incident.

d, The informations relating to the movements of the suspects between Sudan and Ethiopia befor the incident.

e, It has been stated in Ref.No.2346/87 dated July the 25th.1995 per j.Wajebu Amare 9 court of Waredu, the 14th.administrative region in Ethiopia that the " whereabouts of the three suspects are yet unknown"

Why then was the requisition submitted? How can the Ethiopian authorities allege that the three suspects havee fled to Sudan and state that their whereabouts are yet unknown? What is the rationale behind the Extradition requisition when there is no clue that the suspects have fled to Sudan.

g, Article (11) of the Bilateral Extradition Treaty between Sudan and Ethiopia , 1966 stipulates that the statements made by the accused and their testimonies and their admissions and summons and announcements their passport photos . The persual of these items would help the Committee to know how far the suspects can be linked to the attempted homocide and hint or clue as to whether they have fled to Sudan or not.

h, Please take note of the aforesaid informations and request a reply from the Ethiopian authorities.

TRAITÉ D'EXTRADITION ENTRE LE SOUDAN ET L'ÉTHIOPIE

Le Gouvernement de la République du Soudan et le Gouvernement impérial éthiopien,

Désireux de prendre des dispositions pour assurer l'extradition réciproque des criminels,

Ont décidé de conclure un traité à cette fin et nommé pour ce faire comme plénipotentiaires :

Pour la République du Soudan, S. E. Sayed Ahmed Kheir,

Pour le Gouvernement impérial éthiopien, S. E. Ato Ketema Yifru, qui, s'étant communiqué l'un à l'autre leurs pleins pouvoirs respectifs, constatés en bonne et due forme, sont convenus de ce qui suit :

ARTICLE PREMIER

Les Parties contractantes s'engagent aux termes du présent Traité à se livrer réciproquement les personnes accusées ou jugées coupables d'une des infractions visées dans le présent Traité commise dans des circonstances telles que cette infraction relève de la juridiction de l'un des États contractants, alors que lesdites personnes se trouvent dans le territoire de l'autre État contractant.

ARTICLE II

1) Donnent lieu réciproquement à extradition les infractions suivantes :

1. Meurtre ou tentative ou complicité de meurtre,
2. Homicide involontaire,
3. Contrefaçon ou altération de monnaie ou usage de monnaie contrefaite ou altérée,
4. Escroquerie et vol,
5. Extorsion de fonds ou de biens,
6. Détournement de fonds ou de biens ou abus de confiance de la part d'un huissier, d'un banquier, d'un agent public, d'un courtier ou administrateur de fonds, ou encore d'un directeur, d'un membre ou d'un représentant d'une société quelconque,
7. Viol,
8. Rapt,
9. Vol d'enfant,

/...

10. Cambriolage et vol avec effraction,
11. Incendie volontaire,
12. Vol à main armée,
13. Menaces aux fins d'extorquer de l'argent ou tous autres objets de valeur,
14. Proxénétisme,
15. Atteinte à l'intégrité physique,
16. Infractions aux lois bannissant l'esclavage,
17. Enlèvement et séquestration,
18. Séquestration arbitraire,
19. Faux témoignage,
20. Subornation de témoin,
21. Corruption,
22. Infraction à la législation des stupéfiants,
23. Destruction d'un navire en mer ou naufrage intentionnel, ou tentative ou complicité de destruction ou de naufrage intentionnel,
24. Agression à bord d'un navire en haute mer avec intention d'attenter à la vie ou d'infliger des blessures,
25. Mutinerie ou complicité de mutinerie, de la part de deux ou plusieurs personnes, à bord d'un navire en haute mer ou à bord d'un aéronef,
26. Piraterie,
27. Avortement ou tentative d'avortement,
28. Banditisme,
29. Trafic d'armes,
30. Infractions à la législation sur le contrôle des changes,
31. Infractions graves à la législation douanière,

à condition que ces infractions ou toutes infractions du même ordre soient punissables par les lois de l'un et l'autre pays, lorsqu'elles sont commises dans leurs juridictions respectives.

2) Donne également lieu à extradition la participation aux infractions susmentionnées à condition que cette participation soit punissable par la loi de l'une et l'autre Partie contractante.

3) L'extradition peut également être accordée à la discrétion de la Partie contractante requise pour toutes autres infractions pour lesquelles elle peut l'être conformément à la loi de la Partie requérante.

ARTICLE III

En aucun cas, ni en aucune circonstance, les Parties contractantes ne sont tenues de livrer les personnes qui au regard de leurs lois respectives sont considérées comme leurs nationaux.

ARTICLE IV

L'extradition ne peut être accordée si, alors qu'un délit ou une infraction a été commis ou a donné lieu à poursuites pénales ou à condamnation, le délinquant est, du fait de la prescription pénale, exempté de poursuites ou de châtement conformément aux lois du pays requérant l'extradition.

ARTICLE V

1) Une personne extradée ne saurait en aucun cas être maintenue en détention ou traduite en justice dans le territoire de la Partie contractante en faveur de laquelle a eu lieu l'extradition pour aucun autre délit ou infraction, ni en raison d'aucun autre motif que ceux qui ont déterminé l'extradition; l'intéressé devant alors être remis aux autorités ou avoir la possibilité de retourner dans le territoire de la Partie contractante par laquelle il a été extradé.

2) Les dispositions du paragraphe précédent ne s'appliquent pas aux délits ou infractions commis après l'extradition.

ARTICLE VI

Une demande d'extradition ne peut être fondée sur une sentence prononcée par contumace.

ARTICLE VII

Il ne peut y avoir extradition pour des infractions de caractère politique si la personne dont l'extradition est demandée prouve que la requête d'extradition n'a été faite que dans le dessein de la punir pour un délit ou une infraction de caractère politique.

ARTICLE VIII

1) La demande d'extradition est faite par la voie diplomatique.

2) La demande d'extradition d'un individu accusé doit être accompagnée du mandat d'arrêt décerné par un tribunal sur le territoire de la Partie contractante requérante, ainsi que des preuves qui, conformément aux règles appliquées en la matière sur les lieux où se trouve l'accusé, justifieraient son arrestation.

3) Si la demande se rapporte à un individu déjà condamné, elle doit être accompagnée de la peine prononcée par le tribunal compétent sur le territoire de la Partie contractante requérante.

4) Dans tous les cas, il sera fourni dans la mesure du possible des renseignements détaillés susceptibles d'aider à établir l'identité de l'individu dont l'extradition est demandée.

ARTICLE IX

Si la demande d'extradition est conforme aux dispositions du présent Traité, les autorités compétentes sur le territoire de la Partie contractante requise procéderont à l'arrestation du fugitif.

ARTICLE X

L'extradition a lieu lorsque les preuves sont jugées suffisantes, conformément à la législation du territoire à partir duquel l'extradition est désirée, pour justifier la mise en accusation du prisonnier, si le crime ou le délit dont il est accusé a été commis sur ce territoire, ou pour prouver que le prisonnier est bien l'individu qui a été condamné par les tribunaux de la Partie contractante requérante; sous réserve toutefois que le crime ou le délit pour lequel l'individu a été condamné est tel que l'extradition aurait pu, au moment de la condamnation, être accordée par la Partie contractante requise, et sous réserve en outre qu'aucun malfaiteur ne sera livré après l'expiration d'un délai de quinze jours à compter de la date de sa détention dans l'attente du mandat de remise.

ARTICLE XI

1) Lors des examens qu'elles doivent faire conformément aux dispositions précédentes, les autorités de la Partie contractante requise admettront comme preuves l'original ou la copie des dépositions ou des déclarations faites par des témoins sur le territoire de l'autre Partie contractante, ainsi que l'original ou la copie des mandats décernés et des condamnations prononcées sur ce territoire, et les actes ou documents juridiques relatifs aux condamnations, à condition que ces documents soient authentifiés de la manière suivante :

- a) Les mandats doivent être censés avoir été signés, ou leur copie certifiée conforme, selon le cas, par un juge ou un magistrat de l'autre Partie contractante;
- b) Les dépositions ou les déclarations doivent être censées avoir été légalisées, ou leur copie certifiée conforme, selon le cas, par un juge ou un magistrat de l'autre Partie contractante;
- c) Les actes ou documents juridiques relatifs aux condamnations doivent être censés avoir été légalisés par un juge ou un magistrat de l'autre Partie contractante.

2) Dans chaque cas, les mandats, dépositions, déclarations, copies, actes ou documents juridiques doivent être authentifiés par serment de témoin ou apposition du sceau officiel du Ministre de la justice ou d'un autre ministre de la Partie contractante, ou par tout autre moyen d'authentification autorisé par la législation du territoire à partir duquel l'extradition est désirée.

ARTICLE XII

Si l'individu réclamé par l'une des Parties contractantes conformément aux dispositions du présent Traité est également réclamée par une ou plusieurs autres puissances en raison d'autres infractions commises dans leurs juridictions respectives, son extradition est accordée à la puissance dont la demande a été faite en premier, à moins qu'il ne soit renoncé à cette demande.

ARTICLE XIII

1) Si des preuves suffisantes pour l'extradition ne sont pas produites dans un délai de soixante jours à compter de la date de l'appréhension du fugitif, ou suivant tout autre délai fixé par le tribunal de la Partie contractante requise, le fugitif sera remis en liberté.

2) Si, après avoir été juridiquement déclaré comme devant être livré en application des dispositions du présent Traité, le fugitif n'a pas été emmené, dans un délai de trente jours, du territoire à partir duquel son extradition est désirée, il pourra être remis en liberté.

ARTICLE XIV

La Partie contractante qui a consenti à livrer un malfaiteur fugitif conformément aux dispositions du présent Traité prendra à sa charge les frais afférents à l'arrestation et à la détention du fugitif ainsi qu'à son transport jusqu'à la frontière de ladite Partie contractante.

ARTICLE XV

1) Le présent Traité sera ratifié et les instruments de ratification seront échangés à Khartoum aussitôt que possible. Le Traité entrera en vigueur immédiatement après l'échange de ces instruments.

2) L'une ou l'autre des Parties contractantes peut à tout moment notifier à l'autre Partie contractante, par la voie diplomatique, son désir de mettre fin au présent Traité et, si une telle notification est faite, le Traité cessera d'être en vigueur six mois après la date de réception de la notification.

En foi de quoi les plénipotentiaires susmentionnés ont signé le présent Traité et y ont apposé leur sceau.
