<u>埃塞俄比亚当局有关要求引渡三名</u> 埃及人所采取措施的报告

- 1. 在埃塞俄比亚总统1995年7月25日给苏丹总统并于1995年7月27日收到的信中,埃塞俄比亚政府要求引渡三名原籍埃及的外国人,姓名如下:穆斯塔法·哈姆扎,伊扎特或亚西姆和侯赛因·艾哈迈德·希特·阿里。信中说,名叫穆斯塔法·哈姆扎和伊扎特的两人已在苏丹,而候塞因·艾哈迈德·希特·阿里在事件发生当天持苏丹假护照乘苏丹航空公司飞机进入苏丹。
- 2. 接到这项请求后,立即成立了一个机构间委员会,由公设检察官主持,成员包括三名警官,一名安全部门官员和一名军事情报部门官员。1995年7月28日发布的成立该委员会的命令赋予该委员会全面调查权并限令一周内完成任务。
- 3. 委员会按照1966年批准的1964年《埃塞俄比亚和苏丹之间的引渡条约》 就引渡通缉罪犯的程序开展了工作。
- 4. 调查机关研究了埃塞俄比亚当局提出的请求信及其附件,并为寻求请求信中所提供情况的事实根据采取了下列一系列措施:
 - (a) 委员会请检察长下令检察官对通缉犯发出逮捕令。
 - (b) 它还请检察官对这三人发出逮捕令。
- (c) 中央刑事调查部和中央军区1995年7月31日向喀土穆所有进出口、所有警察局和警察部门、各城市进出公路检查站、所有港口、机场和边防检查站发出并传播描述目前掌握的有关三人特征的通告,以保证将他们逮捕并防止他们出走或逃离苏丹。
 - (d) 委员会1995年7月31日写信给护照局,要求提供有关此三人在苏丹的入境日

期、地址和居留证等详细情况,并且命令在调查结束前不准他们离境。

- (e) 委员会1995年7月31日又写信给护照局,要求提供姓名为法伊萨勒·卢特菲·阿卜德·拉提夫和号码为63203号护照的情况,以及持照人1995年7月26日从埃塞俄比亚到苏丹入境的详细情况。
- (f) 委员会收到护照局的通知说,通缉犯没有任何移民记录,由于他们是埃及国民,按照几十年来两国间有效的互惠安排,他们不受移民管制,他们在苏丹的任何入境都没有记录。护照局在继续查找前几年的入境卡以确定他们是否已经入境。委员会还获悉,第63203号护照根据记录是发给名叫伊兹·阿尔丁·阿拉丁·阿什阿拉的苏丹公民的,没有姓名为法伊萨勒·卢特菲·阿卜德·拉提夫的任何记录。喀土穆机场的记录显示1995年7月26日从亚的斯亚贝巴乘苏丹航空公司第327号航班入境的乘客中,有这个姓名的入境卡。
- (g) 1995年7月29日,委员会开始寻找埃塞俄比亚当局的请求信中提及的地方,例如被称为穆斯塔法·哈姆扎或伊扎丁者的地址。据悉,关于这些地方显然有不清楚和矛盾之处,以致委员会无法找到。由于这些矛盾之处,委员会无法查明所述房产的确切位置,但根据现有的资料尽可能地开展了调查。他们搜索了阿卡维特的七所房屋,马拉特地区一所房屋和科贝尔(库珀)区一所房屋,以及喀土穆周围的若干农场。这些措施并未导致逮捕这三名男子中的任何一人,搜查工作仍在继续。
- (h) 委员会通过了有关安全部门进行其调查。根据各机场、海港、边防站和城市出入口定期提交的报告,委员会没有发现任何东西可以表明有关人犯中任何一人的移动情况或显示其中任何一人已进入或离开苏丹。
- (i) 当设立委员会的命令所规定的七天期限结束时,调查当局向内政部长提交了一份报告,表示调查工作尚未完成,仍在继续进行之中。委员会突出说明了它所遇到的种种困难,强调这是因为埃塞俄比亚的要求是在事件发生一个多月之后才提出的,并因为所提交的关于通辑犯的资料很不充分。他们的姓名不全,所提供的说明不足以用来查明身份,也不能导致逮捕。埃塞俄比亚当局也没有提交任何证人的陈述

或任何文件材料来证明他们关于被称为穆斯塔法、哈姆扎和伊扎特的人在苏丹境内的说法。埃塞俄比亚法院提交的文件表明,这些人的下落不明,而两国间的《引渡条约》完全依赖于有关法院提供的文件。委员会已经要求埃塞俄比亚方面提供进一步的资料。

- (j) 1996年2月7日,调查当局接获中央刑事调查部和中央军区的报告,称逮捕通缉犯的努力未获任何结果。于是调查当局采取了为此类案件所规定的法律步骤,即分发关于通缉犯的公告,要求将他们在某一具体规定的期限内送交附近的警察局自首。公告列出了现有关于这几个人的描述,并敦促公众参与搜索和捕捉他们,或提供关于他们的情报。公告在电视和电台上广播并在阿拉伯文和英文的日报上登载,共达三天时间,但没有导致逮捕嫌犯或向调查当局提供关于他们的任何情报。
- (k) 为了推动调查工作,调查当局建议采取措施对埃及国民进行登记。从1995年8月9日开始,除持外交护照者之外,所有抵达苏丹的埃及国民都得登记。1996年2月7日,委员会通知所有在开始实施登记制度之前居住在苏丹的埃及国民就近到警察局去登记。
- (1) 调查当局通过国际刑事警察组织(国际刑警)在喀土穆的联络处请求该组织总秘书处提供关于通缉犯的资料。1996年2月15日,收到的答复称手头没有任何关于他们的资料。
- (m) 内政部长向各省省长、地方和民众当局下达一项指示,要求协助搜索这几名被通缉的外国人。1996年2月26日,政府宣布,任何帮助捕获这几名人犯或提供有关他们情报的人将获得一笔奖金。各省省长下达指示,要求各省和各地方竭尽一切努力寻找这几名通缉犯。
- (n) 调查当局正在审查所有部门、各检查站、港口、机场和边防站所提交的定期报告,以便发现和防止任何嫌犯离境,假如他们在境内的话。
- 5. 调查当局发现喀土穆国际机场的记录中有张卡片上写着法伊萨勒·卢特菲·阿卜德·拉提夫的名字,他是1995年6月26日乘苏丹航空公司327次航班从埃塞俄

比亚抵达的乘客之一。入境卡上填写的地址是"科贝尔区清真寺附近"。当局对该居住区的每个角落进行了搜索,没有发现他。也审查了机场出租车记录,但没有找到该名通缉犯的姓名。他持的护照是伪造的。

- 6. 调查当局没有发现任何证据显示被称为穆斯塔法·哈姆扎和伊扎特或亚西姆的人抵达苏丹,或显示他们在过去任何时候曾进入苏丹。同样,也没有任何记录显示这三人中任何人曾通过机场、海港和边防站等合法离境口岸离开苏丹。
- 7. 调查当局没有收到任何可对埃塞俄比亚原请求信中所提供资料做出补充的资料。因此,他们在1996年2月14日给埃塞俄比亚外交部的一封信中进一步强调了他们最初就埃塞俄比亚的要求所发表的意见,并解释了这些意见和指出所需的资料,以期埃塞俄比亚当局提供这些资料。
- 8. 搜索和调查仍然在埃塞俄比亚所提交要求中所载资料的范围内继续进行。 为了取得更令人满意的结果,必须提供进一步的资料,说明这几名嫌犯以前在埃塞俄 比亚与苏丹之间往来行动的情况,并更充分和清楚地叙述所涉地方和人员的情况。 必须提交文件和证词来证实埃塞俄比亚关于穆斯塔法·哈姆扎和伊扎特在苏丹境内 的主张,因为法院的信函并不显示他们在苏丹境内,而该法院的信函是取决《引渡条 约》行动的中心文件。同样,委员会所采取的各项措施也没有得出任何证实所谓他 们在苏丹境内的主张的证据。

 - e .Police Major ElNil Fath ElRahman (Aliens Passport) .Member h.Police Major : Abdel Gafur Osman Keylani (Central Investigation Bureau). Member

Jurisdictions of the Committee

2. The Committee has the jurisdiction to consider the requisition made by the Ethiopian authorities respecting the surrender of three suspects who are alleged to have conspired to Commit an attempted homicide on the life of the Egyptian President, and to take all the necessary measures relating to this requisition pursuant to the Criminal Procedure Act., 1991, The Extradition Act., 1957, and the Bilateral Extradition Treaty between the Sudan and Ethiopia, 1966.

Powers of the Committee

- 3. The Committee shall have the following powers:-
- a. To look into all the relevant documents and order the presence of any person and compel such a person or persons to appear before the Committee to give their statements.

- b. To address all the Departments and authorities regarding its mission.
- c. The Committee may seek the assistance of any person to complete its mission.

The Report of the Committee


4. The Committee shal submit its report in a period not exceeding seven days from the date of its formation.

ORDER

- THE CRIME THE ACCUSED ALLEGED TO HAVE COMMITTED IS
 AN ATTEMPTED HOMICIDE. INVESTIGATION COULD NOT BE
 UNDERTAKEN AS THE ACCUSED HAVE NOT YET MADE
 THEMSELVES AVAILABLE.
- WE THEREFORE HEREBY AUTHORIZE, PURSUANT TO ARTICLES 53 AND 56 OF THE CRIMINAL PROCEDURE CODE, THE DETENTION OF THE ACCUSED INDIVIDUALS, WITH A VIEW TO UNDERTAKING INVESTIGATION AND BRING THEM TO JUSTICE, WHEREVER THEY ARE FOUND AND BY WHATEVER MEANS AVAILABLE, AFTER THEIR IDENTITY HAS BEEN ASCERTAINED.
 - LET THE COPY OF THIS ORDER BE GIVEN TO THE REQUESTING BODY AND THE FILE BE RETURNED TO THE ARCHIVES.

MUSTAFA'S RESIDENCE IS A TWO-STORY ROOM CONNECTED THROUGH INTERCOM, AND IS COMPLETELY SURROUNDED BY A FOUR METER STONE WALL. THE MAIN ENTRANCE IS A BLACK PAINTED STEEL GATE THAT SWINGS TO THE OUTSIDE.

His Role in The Terrorist Act

Mustafa Hamza is the person who masterminded and spearheaded the terrorist activity and is known to have traveled to Ethiopia as early 2 years before the attempt on the life of the Egyptian President to prepare the ground for the implementation of the terrorist plan which he initiated, followed closely and also executed as the leader of the whole terrorist effort.

- 1, Reference the requision made by the Etjiopian respecting the surrender of three Egyptian national who are alleged to have conspired to the attempted homicide on the life of the Egyptian President and who are suspected to have left to Sudan.
- 2, There are some significant information needed by the Committee for the sake of investigation, these are -
- a, Complance with article 8(4) of the Bilateral Extradition Treaty between Sudan and Ethiopia, 1966, by providing the particulars that would assist in ascertaing the identities of the following suspects:-
 - 1. Mustafa Hamza
 - 2. Izat or Yasim.
 - 3. Husayn Ahmed Shiat Ali.

The particulars need are the passport photo of the suspect Izat and the descriptions of the three suspects and thier special marks.

- b, Illustration of the locations mentioned in the requision, these locations as provided are inadequately described, are very confusing and do not comply with the geographical realities Khartoum town.
- c, The documents and the statements that would support the presence of Mustafa Hamza and Izat or Yasim in the Sudan or their entry thereto befor or after the incident.
- d, The informations relating to the movements of the suspects between Sudan and Ethiopia befor the incident.
- e, It has been stated in Ref.No.2346/87 dated July the 25th.1995 per j. Wajebu Amare 9 court of Waredu, the 14th.administrative region in Ethiopia that the "whereabouts of the three suspects are yet unknown"

Why then was the requision submitted? How can the Ethiopian authorities allege that the three suspects havee fled to Sudan and state that their whereabouts are yet unknown? What is the rationale behind the Extradition requision when there is no clue that the suspects have fled to Sudan.

g, Article (11) of the Bilaterad Extradition Treaty between Sudan and Ethiopia, 1966 stipulates that the statements made by the accused and their testemonies and their admissions and summons and announcements their passport photos. The persual of these items would help the Committee to know how far the suspects can be linked to the attempted homocide and hint or clue as to whether they have fled to Sudan or not.

h, Please take note of the aforesaid informations and request a reply from the Ethiopian authorities.

决定为此目的缔结一项条约,因各自委派全权代表如下:

苏丹共和国委派赛义德·艾哈迈德·海尔阁下,

埃塞俄比亚帝国政府委派阿托 · 克特马 · 伊弗鲁阁下,

双方经交换全权证书并确认无误后,达成协议如下:

第一条

缔约双方同意依照本条约的规定,引渡被指控或判定触犯本条约所列任何罪行 而其犯行属于缔约一方管辖范围但查明身在缔约另一方境内的人。

第二条

- (1) 凡犯有下列罪行者得相互引渡:
- 1. 谋杀或意图谋杀或密谋谋杀;
- 2. 过失杀人;
- 3. 伪造或篡改货币或使用伪造或篡改的货币;
- 4. 贪污和非法侵占财产;
- 5. 冒领钱财:
- 6. 受托人、银行业者、代理人、代理商或担保受托人,或任何公司的董事会 董事或公职人员侵占盗用或诈骗;
 - 7. 强奸;
 - 8. 诱拐胁持;

- 9. 拐带儿童;
- 10. 盗窃和入屋行窃;
- 11. 纵火;
- 12. 暴力抢劫:
- 13. 意图敲诈钱财而进行威胁;
- 14. 介绍卖淫;
- 15. 行凶造成重任;
- 16. 违反废奴法:
- 17. 绑票:
- 18. 非法拘禁;
- 19. 作伪证:
- 20. 唆使他人作伪证;
- 21. 行贿受贿;
- 22. 与麻醉品有关的罪行;
- 23. 击沉或破坏海上船只,或意图或密谋击沉或破坏海上船只;
- 24. 在公海船只上意图行凶杀人或严重伤人;
- 25. 两人或两人以上在公海船只上违抗船长的权威或在飞机上违抗机长的权威谋反或密谋谋反:
 - 26. 海盗行为;
 - 27. 堕胎或意图堕胎;
 - 28. 盗匪行为:
- 29. 贩卖军火;
 - 30. 违反外汇管制法罪:
 - 31. 严重违反海关法罪。

但在其各自管辖范围内所犯的上述或基本类似的罪行必须为两国法律都可以惩处的罪行。

- (2) 参与上述罪行者也应予以引渡,但这种参与必须为缔约双方法律可以惩处 的罪行。
- (3) 犯有根据缔约双方法律可以引渡的任何其他罪行者,被请求的缔约一方也可斟酌予以引渡。

第三条

缔约双方在任何情况下都没有义务交出其各自法律界定的本国国民。

第四条

如在犯罪或刑事起诉或判罪后,按照引渡请求国的法律,已因时效终止而免于起诉或惩处者,不予以引渡。

第五条

- (1) 除根据引渡的罪名外,不得以任何其他罪名或事实为由在接受引渡的缔约一方境内拘留或审判被引渡者,直至其已被交还或已有机会回到将其引渡的缔约一方为止。
 - (2) 上款规定不得适用于引渡后所犯的罪行。

第六条

藐视法庭罪的判决不得作为提出引渡要求的理由。

第七条

政治性质的犯罪不得引渡,如果被要求引渡者证明,要求引渡他的实际意图是以政治罪对他进行审判或惩处,即不得引渡。

第八条

(1) 引渡的要求应通过外交渠道提出。

- (2) 在提出引渡被告的要求时,必须出具提出引渡要求的缔约一方境内法院签发的逮捕令以及依照被告所在地的证据法证明有理由将其逮捕的证据。
- (3) 如果引渡请求涉及已被判罪者,则必须出具提出引渡请求的缔约一方境内有关法院对被判罪者发布的判决书。
 - (4) 在任何情况下都应尽可能提供有助于查明被要求引渡者身份的细节。

第九条

如果引渡要求符合本条约的规定,接到引渡要求的缔约方境内的主管当局应即 逮捕逃犯。

第十条

接到引渡要求的国家如发现证据足以将被控在该国犯罪的囚犯交付审判,或证明囚犯与提出引渡要求的缔约方法院判定的罪犯同属一人,便应进行引渡,但所判罪行必须是在定罪时接到引渡要求的缔约方准予引渡的罪行,且自罪犯拘禁之日起十五天内不得引渡,以等待其引渡令。

第十一条

- (1) 接到引渡要求的缔约方当局在按照上述规定进行审查时,对于在另一缔约方境内录取的证人宣誓证词或普通证词或其副本,以及在该国签发的逮捕令和判决书或其副本和说明判罪事实的证书或司法文件,应采纳为证据,但必须按以下规定加以鉴定:
- (a) 视情况需要逮捕状或其副本必须表明确由另一缔约方的法官或治安官签署,或表明确经该缔约方法官或治安官证明无误;
- (b) 视情况需要,宣誓证词或普通证词必须表明确经另一缔约方的法官或治安官或法律干事证明为宣誓证词或普通证词的原件或正式副本:
- (c) 说明判罪事实的证书或司法文件必须表明确已由另一缔约方的法官或治安官证明无误。

(2) 在任何情况下,逮捕令、宣誓证词、普通证词、副本、证书或司法文件均须经证人宣誓证明无误,或用另一缔约方的司法部或其他某部的官印加封,或以接到引渡要求的国家法律当时允许的其他任何方式证明无误。

第十二条

如果缔约一方按本条约要求引渡的人又被另一或多个国家以在其各自管辖范围 内所犯其他罪行为由要求引渡,则应由最早提出引渡要求的国家引渡,除非它放弃引 渡要求。

第十三条

- (1) 自逃犯被捕之日起六十天内或在接到引渡要求的缔约方法院指示的更长 时间内如提不出充分的引渡证据,则应释放逃犯。
- (2) 如已正式宣布按本条约引渡在押逃犯三十天后仍未将逃犯送交接受引渡 要求的国家,则应将他释放。

第十四条

同意按照本条约规定交出逃犯的缔约方应支付将他逮捕和拘留以及送往该缔约方边界的费用。

<u>第十五条</u>

- (1) 本条约须经批准,并应尽早在喀土穆交换批准书。本条约在交换批准书后 立即生效。
- (2) 任何缔约方均可随时通过外交渠道通知对方中止本条约,如果发出通知, 则本条约在收到中止通知之日六个月后不再有效。
