ELECTIONS, NOMINATIONS AND CONFIRMATIONS

Election of nine members of the Committee on Economic, Social and Cultural Rights

Note by the Secretary-General

1. By its resolution 1985/17, the Economic and Social Council decided to establish a Committee on Economic, Social and Cultural Rights to undertake functions relating to the implementation of the International Covenant on Economic, Social and Cultural Rights and to assist the Council in fulfilling its responsibilities under the Covenant.
2. In accordance with that resolution, the Council, at its resumed organizational session of 1992, elected by secret ballot, from a list of persons nominated by States parties to the Covenant, nine experts as members of the Committee on Economic, Social and Cultural Rights, for a four-year term beginning on 1 January 1993 and ending on 31 December 1996 (decision 1992/216). The current membership of the Committee is given in annex I below.
3. At its present session, the Council is to elect nine members of the Committee for a four-year term, beginning on 1 January 1997. The terms of the following members expire on 31 December 1996: Madoe Virginie AHODIKPE (Togo), Juan ALVAREZ VITA (Peru), Dumitru CEAUSU (Romania), Abdessatar GRISSA (Tunisia), María de los Angeles JIMENEZ BUTRAGUEÑO (Spain), Kenneth Osborne RATTRAY (Jamaica), Chikako TAYA (Japan), Philippe TEXIER (France), Margerita VYSOKAJOVÁ (Czech Republic).
4. In a note verbale dated 22 December 1995, the Secretary-General invited the States parties to the International Covenant on Economic, Social and Cultural Rights to submit their nominations for membership in the Committee. The names of the persons nominated as at 15 March 1996 are set out below, together with the States parties that nominated them.
