Reports of the Joint Inspection Unit of interest to  
the United Nations Development Programme

1. The Joint Inspection Unit (JIU) has prepared 13 reports since the last note by the Administrator to the Executive Board (DP/1995/30/Add.4) on this subject. Of these, 11 are of interest or concern to the United Nations Development Programme (UNDP) and to the Executive Board, and are the subject of the present note.
2. Throughout the year, full cooperation continued to be extended to JIU by UNDP, both at headquarters and in the country offices, as and when necessary, in developing the JIU overall annual work programme, and in the preparation of the individual reports. Thereafter, comments on the drafts or final versions of these reports were provided to JIU by UNDP either separately or as part of consolidated views from the Administrative Committee on Coordination (ACC).
3. The contents of the JIU reports have been taken into account, as necessary, in the activities of UNDP and will be reflected in the reports before the Executive Board in so far as they are relevant to the respective agenda items for its sessions during the year. Of these reports, only the first one (JIU/REP/95/1) has been considered by the General Assembly, which took note of the report and endorsed its recommendations. The remaining reports are before the General Assembly and other relevant legislative bodies. No action has yet been taken on them.
