I. INTRODUCTION

- 1. The objective of this report is to provide the Executive Board with information on the financial implementation of UNFPA country programmes and projects that had been approved by the Governing Council at its thirty-third (1986) through fortieth (1993) sessions and by the Executive Board at its first annual session (1994). This is the eleventh update of the report, which is submitted each year in accordance with Governing Council decision 84/21 III. It should be read in conjunction with the "Work plan for 1996-1999 and request for programme expenditure authority" (document DP/1995/26), which is also being submitted to the Executive Board at its second annual session. This report is intended for information only, and no decision or action is requested of the Executive Board.
- 2. The report is structured according to the date of approval rather than according to geographical or other country grouping. Information is provided on: (a) those programmes and projects that were completed in 1994 and those that were ongoing in January 1995; and (b) those that are being submitted for approval to the Executive Board in 1995.
- 3. To give a more accurate picture of the most recent progress of UNFPA activities, the report uses pro forma estimated expenditures in 1994 rather than allocations for that year. It also presents information on expenditures of multi-bilateral funds, as requested by the Governing Council.
- 4. This report provides information on the "resource delivery rate" of programmes completed in 1994. The resource delivery rate, which was defined in document DP/1989/34, is expressed as the total expenditure from all sources of funds for a programme divided by the total amount approved by the Governing Council or the Executive Board for that programme. The "current expenditure rate" for ongoing programmes is the total expenditure accumulated up to and including 1994 divided by the total amount approved (column 7 for the individual countries in tables showing ongoing programmes). When a programme completes its cycle, the current expenditure rate becomes the resource delivery rate. The "overall expenditure rate" for all ongoing programmes approved in a given year is the sum of the total expenditure accumulated up to and including 1994 for all ongoing programmes approved in the respective year divided by the sum of the total amount approved for these programmes (provided in column 7 in the line titled Total Ongoing in tables showing ongoing programmes).
- 5. It is important to note the following: the starting date of a programme is the one approved by the Governing Council or the Executive Board; the end of a programme is either (a) the year when all projects were completed, or (b) the year preceding the one when a subsequent programme began. There cannot be two contemporaneous UNFPA programmes within one country. For programmes starting and/or ending in the middle of a year, the yearly expenditures have been prorated.
- 6. Tables containing the details on all Governing Council- and Executive Board- approved country programmes, new submissions and UNFPA's balance of commitments are provided in the Annex to this report.

II. COUNTRY PROGRAMMES APPROVED BY THE COUNCIL AT ITS THIRTY-THIRD THROUGH FORTIETH SESSIONS AND BY THE EXECUTIVE BOARD AT ITS FIRST ANNUAL SESSION

- 7. At its thirty-third session (1986), the Governing Council approved seven country programmes. Of these, six were completed prior to 1994 and one, Zaire, is ongoing. The current expenditure rate for the programme in Zaire is estimated at 67 per cent (see table A.1).
- 8. At its thirty-fourth session (1987), the Governing Council approved 31 country programmes. Of these, 29 were completed prior to 1994, while two, Liberia and Somalia, are ongoing. The overall expenditure rate for these two programmes is estimated at 60 per cent (see table A.2).
- 9. At its thirty-fifth session (1988), the Governing Council approved 16 country programmes. Of these, 14 were completed prior to 1994, while two, Turkey and Costa Rica, were completed in 1994. Estimated expenditures from regular resources for the programmes in Turkey and Costa Rica are \$4.1 million and \$1.8 million, respectively, and the resource delivery rates are estimated at 82 per cent for each programme (see table A.3). New programmes for these countries are being submitted to the Executive Board in 1995.
- 10. At its thirty-sixth session (1989), the Governing Council approved 13 country programmes. Of these, five were completed prior to 1994; two, Comoros and Mauritius, were completed in 1994, and the other six programmes are still ongoing. The estimated expenditures from regular resources for the programmes in Comoros and Mauritius are \$3.4 million and \$1.8 million, respectively, and the resource delivery rates are estimated at 85 and 72 per cent, respectively. New programmes for these countries are being submitted to the Executive Board in 1995. For the ongoing programmes the overall expenditure rate is estimated at 69 per cent (see table A.4).
- 11. At its thirty-seventh session (1990), the Governing Council approved 13 country programmes. Of these, three were completed prior to 1994; one, Indonesia, was completed in 1994, and the other nine programmes are still ongoing. The estimated expenditures from regular resources for the programme in Indonesia are \$12.9 million and the resource delivery rate is estimated at 52 per cent. A new programme for Indonesia is being submitted to the Executive Board in 1995. The overall expenditure rate for the ongoing programmes is estimated at 62 per cent (see table A.5).
- 12. At its thirty-eighth session (1991), the Governing Council approved 14 country programmes as well as a subregional programme for the English-speaking Caribbean. All programmes are still ongoing, and the overall expenditure rate for these programmes is estimated at 44 per cent (see table A.6).
- 13. At its thirty-ninth session (1992), the Governing Council approved 30 country programmes as well as a subregional programme for the South Pacific. Of these, three, Benin, Mozambique and Sudan, were completed in 1994; and the other 28 programmes are still ongoing. The estimated expenditures from regular resources for the programmes in Benin, Mozambique and Sudan are \$1.9 million, \$4.5 million and \$5.4 million, respectively, and the resource delivery rates are estimated at 52, 63 and 100 per cent, respectively. New programmes for these countries are being submitted to the Executive Board in 1995. The overall expenditure rate for the ongoing programmes is estimated at 36 per cent (see table A.7).

- 14. At its fortieth session (1993), the Governing Council approved 15 country programmes. All programmes are still ongoing, and the overall expenditure rate for these programmes is estimated at 28 per cent (see table A.8).
- 15. At its first annual session (1994), the Executive Board approved six country programmes. All programmes are still ongoing, and the overall expenditure rate for these programmes is estimated at 14 per cent (see table A.9).

III. SUBMISSIONS OF PROPOSED COUNTRY PROGRAMMES AND PROJECTS TO THE EXECUTIVE BOARD IN 1995¹

UNFPA is submitting to the Executive Board in 1995 for its consideration and approval eight 16. country programmes (four in sub-Saharan Africa, two in Arab States and Europe, one in Asia and the Pacific and one in Latin America and the Caribbean) as well as one area programme in Central Asia and two large-scale projects in Asia and the Pacific. The total amount for these programmes and projects is \$97.4 million, of which \$80.7 million is to be programmed from regular resources (see table B). In the sub-Saharan Africa region, the four programmes submitted are for Benin, Comoros, Mauritius and Mozambique with a total amount for the region of \$26.0 million, of which \$20.8 million is to be programmed from regular resources. In the Arab States and Europe region, the two programmes submitted are for Sudan and Turkey with a total amount for the region of \$13.5 million, of which \$12.5 million is to be programmed from regular resources. In the Asia and Pacific region, the country programme submitted is for Indonesia; the area programme submitted covers Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan; and the two large-scale projects are for Cambodia with a total amount for the region of \$55.9 million, of which \$45.4 million is to be programmed from regular resources. In the Latin America and Caribbean region, the programme submitted is for Costa Rica, with a total amount of \$2.0 million, all of which is to be programmed from regular resources.

IV. BALANCE OF UNFPA COMMITMENTS¹

The balance of UNFPA commitments (from regular resources) for ongoing programmes is \$308.6 million, distributed as follows: \$96.1 million for sub-Saharan Africa; \$30.1 million for the Arab States and Europe; \$145.6 million for Asia and the Pacific; and \$36.8 million for Latin America and the Caribbean. If the Executive Board approves the eleven new programmes and projects being submitted this year, the total balance of UNFPA commitments from regular resources will increase by \$80.7 million, to \$389.3 million, distributed as follows: \$116.9 million for sub-Saharan Africa; \$42.6 million for the Arab States and Europe; \$191.0 million for Asia and the Pacific; and \$38.8 million for Latin America and the Caribbean (see table C).
