#### II. DECISIONS

#### A. ELECTIONS AND APPOINTMENTS

#### 50/301. Appointment of the members of the Credentials Committee

At its 1st plenary meeting, on 19 September 1995, the General Assembly, in accordance with rule 28 of its rules of procedure, appointed a Credentials Committee for its fiftieth session consisting of the following Member States: China, Luxembourg, Mali, Marshall Islands, Russian Federation, South Africa, Trinidad and Tobago, United States of America and Venezuela.

"2. Aware of the presence of such bases and installations in some of those Territories, the General Assembly urges the administering Powers concerned to continue to take all necessary measures not to involve those Territories in any offensive acts or interference against other States.

"3. The General Assembly reiterates its concern that military activities and arrangements by colonial Powers in Territories under their administration might run counter to the rights and interests of the colonial peoples concerned, especially their right to self-determination and independence. The Assembly once again calls upon the administering Powers concerned to terminate such activities and to eliminate such military bases in compliance with its relevant resolutions.

"4. The General Assembly reiterates that the colonial and Non-Self-Governing Territories and areas adjacent thereto should not be used for nuclear testing, dumping of nuclear wastes or deployment of nuclear and other weapons of mass destruction.

"5. The General Assembly deplores the continued alienation of land in colonial and Non-Self-Governing Territories, particularly in the small island Territories of the Pacific and Caribbean regions, for military installations. The large-scale utilization of the local resources for this purpose could adversely affect the economic development of the Territories concerned.

"6. The General Assembly takes note of the decision of some of the administering Powers to close or downsize some of those military bases in the Non-Self-Governing Territories.

"7. The General Assembly requests the Secretary-General to continue to inform world public opinion of those military activities and arrangements in colonial and Non-Self-Governing Territories which constitute an obstacle to the implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples.

"8. The General Assembly requests the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples to continue to examine this question and to report thereon to the Assembly at its fifty-first session."

#### ANNEX I

#### Organization of work of the Third Committee

#### A. <u>Guidelines concerning time-limits of statements</u>

1. In accordance with rule 106 of the rules of procedure of the General Assembly and paragraph 22 of decision 34/401 on the rationalization of the procedures and organization of the General Assembly, at the beginning of each session, the Chairman of the Third Committee should propose to the Committee the limitation of the time to be allowed to speakers.

2. Further to General Assembly resolutions 45/175 of 18 December 1990 and 46/140 of 17 December 1991, on the rationalization of the work of the Third Committee, statements made by delegations or on behalf of groups of delegations and by Secretariat officials, unless decided otherwise by the Committee at the beginning of the session, should not exceed 15 minutes. This time-limit will have to be applied with a degree of flexibility towards all speakers. With a view to saving time, all speakers are encouraged to exercise self-discipline, in particular delegations associated with group statements. For practical reasons, group statements are encouraged for the first day of the discussion of an item or sub-item. In this connection, it is important to emphasize the timely distribution of documentation in accordance with the rules of procedure of the Assembly, in order to enable delegations to inscribe themselves on the list of speakers at an early stage.

#### B. Draft resolutions on reports of treaty bodies and reports of the Secretary-General on the status of the treaties

3. Reports of all treaty bodies will be submitted to the General Assembly in accordance with their respective legislative mandates. Substantive resolutions on those reports should be adopted biennially, in accordance with the programme of work of the Third Committee. Where possible, it is recommended that separate draft resolutions on the status of the treaties should not be submitted but should be incorporated in the draft resolution relating to the report of the treaty body. In alternate years, the Committee should simply take note of the reports unless more substantive action is deemed appropriate.

#### C. <u>Proposals emanating from subsidiary organs of the</u> Economic and Social Council

4. The Economic and Social Council, in transmitting proposals to the General Assembly, should, to the extent possible, bear in mind the programme of work of the Third Committee.

#### D. <u>Programme of work</u>

5. An informal meeting of the Third Committee should be held immediately after the election of the members of its Bureau in order to consider the programme of work of the Committee on the basis of a draft to be prepared by the Secretariat and to consider other organizational aspects relating to the Committee's work, especially the status of documentation.

### 50/471. <u>Scale of assessments for the apportionment</u> of the expenses of the United Nations

At its 100th plenary meeting, on 23 December 1995, the General Assembly, on the recommendation of the Fifth Committee,  $\underline{145}$ / resolved that:

(a) The rate of assessment for Palau, admitted to membership in the United Nations on 15 December 1994, should be 0.01 per cent for 1995, 1996 and 1997;

(b) The contributions of Palau for 1995, 1996 and 1997 should be applied to the same basis of assessment as for other Member States, except that, in the case of appropriations or apportionments approved by the General Assembly for the financing of peace-keeping operations, the contributions of Palau, as determined by the group of contributions to which they might be assigned by the Assembly, should be calculated in proportion to the calendar year;

(c) The 1995 assessments of Palau should be taken into account as miscellaneous income in accordance with regulation 5.2 (c) of the Financial Regulations and Rules of the United Nations;

(d) For 1996 and 1997, the rate of assessment for Palau should be added to the scale of assessments established under General Assembly resolution 49/19 B of 23 December 1994;

(e) The advance of Palau to the Working Capital Fund should be calculated by the application of the rate of assessment of 0.01 per cent to the authorized level of the Fund and should be added to the Fund pending the incorporation of its rate in a 100 per cent scale.

#### 50/472. <u>Amendments to the Financial Regulations of the</u> <u>United Nations to change the budget cycle of</u> <u>peace-keeping operations</u>

At its 100th plenary meeting, on 23 December 1995, the General Assembly, on the recommendation of the Fifth Committee,  $\underline{147}$ / having considered the report of the Secretary-General on the draft amendments to the Financial Regulations of the United Nations to change the budget cycle of peace-keeping operations,  $\underline{148}$ / decided to amend Financial Regulations 2.1 and 11.4 to read as follows:

"<u>Regulation 2.1</u>: The financial period shall consist of two consecutive calendar years, the first of which shall be an even year, except for peace-keeping operations with special accounts, whose financial periods shall be one year from 1 July to 30 June."

"<u>Regulation 11.4</u>: The accounts for the financial period, except those for peace-keeping operations with special accounts, shall be submitted by the Secretary-General to the Board of Auditors no later than 31 March following the end of the financial period. The annual accounts for peace-keeping operations with special accounts shall be submitted by the Secretary-General to the Board of Auditors no later than 30 September each year."

#### 50/473. <u>Support account for peace-keeping operations</u>

At its 100th plenary meeting, on 23 December 1995, the General Assembly, on the recommendation of the Fifth Committee,  $\underline{149}$ / on the basis of the report to be submitted by the Secretary-General following completion of his comprehensive review exercise:

(a) Decided to review at its resumed fiftieth session, no later than March 1996, the current methodology for financing the support account, in the light of the changing requirements for and nature of backstopping of peacekeeping operations at Headquarters and taking into account the report to be submitted by the Board of Auditors, and noted the statement made by the Controller to the Fifth Committee on 28 November 1995 <u>150</u>/ on review of the financing formula;

- (i) To establish as a temporary post the position of Special Adviser to the Secretary-General;
- (ii) To continue, for the period from 1 February to 31 March 1996, the sixty-one temporary posts authorized in paragraph 12 of General Assembly resolution 49/250 of 20 July 1995;
- (iii) To authorize the amounts of 40,000 United States dollars for overtime and 900,000 dollars for common services for the period from 1 January to 31 March 1996.

#### 50/474. <u>Relocation of Ukraine to the group of Member States</u> <u>set out in paragraph 3 (c) of General Assembly</u> <u>resolution 43/232</u>

# 50/416. Consideration of the draft articles on the status of the diplomatic courier and the diplomatic bag not accompanied by diplomatic courier and of the draft optional protocols thereto

At its 87th plenary meeting, on 11 December 1995, the General Assembly, on the recommendation of the Sixth Committee,  $\underline{153}$ / wishing to pay tribute to the valuable work done by the International Law Commission on the draft articles on the status of the diplomatic courier and the diplomatic bag not accompanied by diplomatic courier and the draft optional protocols thereto, decided to bring the draft articles prepared by the Commission  $\underline{154}$ / to the attention of Member States, together with the observations made by Member States in written form or orally during the debates of the Sixth Committee, including the report of the Vice-Chairman of the Sixth Committee at the forty-seventh session of the General Assembly,  $\underline{155}$ / and to remind Member States of the possibility that this field of international law and any further developments within it may be subject to codification at an appropriate time in the future.
