Addendum

1. As indicated in document A/50/952 of 7 May 1996, the Secretary-General has received notification of the resignation of Mr. Yuri Chulkov (Russian Federation) from membership of the Committee on Contributions. Accordingly, the General Assembly will be required at its current session to appoint a person to fill the unexpired portion of the term of office of Mr. Chulkov, that is, until 31 December 1996.
