# 857 (XXXII). Accession of the Republic of San Marino to the Convention on Road Traffic of 19 September 1949

The Economic and Social Council,

Taking note of the communication from the Government of the Republic of San Marino, dated 9 August 1961,<sup>1</sup> concerning the desire of that State to become a Party to the Convention on Road Traffic signed at Geneva on 19 September 1949,

Resolves to admit the Republic of San Marino as a Party to that Convention.

# 858 (XXXII). Convention on the Privileges and Immunities of the Specialized Agencies: draft annex relating to the International Development Association

The Economic and Social Council,

Having regard to General Assembly resolution 179 (II) of 21 November 1947 approving the Convention on the Privileges and Immunities of the Specialized Agencies,

Having regard to section 35 of the said Convention providing that the Secretary-General of the United Nations shall transmit a draft annex recommended by the Economic and Social Council to any specialized agency not mentioned by name in the Convention,

Having regard to the fact that the International Development Association has been brought into relationship with the Organization in accordance with Articles 57 and 63 of the Charter of the United Nations,

Recommends to the International Development Association the following draft annex to the Convention on the Privileges and Immunities of the Specialized Agencies and requests the Secretary-General to transmit it to the Association.

#### ANNEX XIV

### INTERNATIONAL DEVELOPMENT ASSOCIATION

In its application to the International Development Association (hereinafter called "the Association") the Convention, including this annex, shall operate subject to the following provisions:

- 1. The following shall be substituted for section 4:
- "Actions may be brought against the Association only in a court of competent jurisdiction in the territories of a member in which the Association has an office, has appointed an agent for the purpose of accepting service or notice of process, or has issued or guaranteed securities. No actions shall, however, be brought by members or persons acting for or deriving claims from members. The property and assets of the Association shall, wheresoever located and by whomsoever held, be immune from all forms of seizure, attachment or execution before the delivery of final judgement against the Association."
- 2. Section 32 of the standard clauses shall only apply to differences arising out of the interpretation or application of privileges and immunities which are derived by the Association from this Convention and are not included in those which it can claim under its Articles of Agreement or otherwise.
- 3. The provisions of the Convention (including this annex) do not modify or amend or require the modification or amendment of the Articles of Agreement of the Association or impair or limit any of the rights, immunities, privileges or exemptions conferred upon the Association or any of its members, governors, executive directors, alternates, officers or employees by the Articles of Agreement of the Association, or by any statute, law or regulation of any member of the Association or any political subdivision of any such member, or otherwise.

### 859 (XXXII). Application of the Mongolian People's Republic for membership in the Economic Commission for Asia and the Far East

The Economic and Social Council,

Noting the application dated 13 November 1961 from the Mongolian People's Republic <sup>2</sup> for membership in the Economic Commission for Asia and the Far East and inclusion in the geographical scope of the Commission,

Amends the terms of reference of the Economic Commission for Asia and the Far East 3 as follows:

- (a) In paragraph 2 of the terms of reference describing the territories of Asia and the Far East, insert the word "Mongolia" after "Laos";
- (b) In paragraph 3 of the terms of reference giving the list of members of the Commission, insert after "Laos" the words "Mongolian People's Republic".
