Carta de fecha 13 de mayo de 1996 dirigida al Secretario General por
el Representante Permanente de Chipre ante las Naciones Unidas

Siguiendo instrucciones de mi Gobierno, tengo el honor de señalar a su atención un asunto grave que se desprende de un anuncio publicado en el periódico turcochipriota Cyprus Today de fecha 6 de abril de 1996 (véase el anexo). El anuncio revela un nuevo acto de provocación por parte de las fuerzas turcas de ocupación en Chipre, que consiste en vender la iglesia bizantina de Panagia Chrysotrimithiotissa en la aldea ocupada de Trimithi. Según el anuncio, la agencia inmobiliaria Keskin y Smith vende la iglesia por 32.500 libras.

La iglesia de Panagia Chrysotrimithiotissa pertenece al Obispado de Kyrenia y data del período bizantino medio. En 1974, la iglesia se incluyó en una lista de monumentos que el Gobierno iba a declarar patrimonio histórico.

El Gobierno de la República de Chipre ha señalado reiteradamente a su atención actos de profanación y saqueo de iglesias y monasterios en la parte de Chipre ocupada por Turquía desde 1974 a fin de poner freno a los intentos sistemáticos de Turquía de borrar el patrimonio cultural griego de la parte ocupada de Chipre.

Este nuevo hecho es un ejemplo más de la existencia de un plan premeditado de la Potencia ocupante turca de modificar la estructura demográfica de la zona ocupada importando miles de colonos ilegales de Anatolia (Turquía) y de erradicar en esa zona el patrimonio cultural de la población grecochipriota autóctona.

El Gobierno de la República de Chipre protesta enérgicamente contra este acto ilegal, sacrílego y repudiable y pide que las Naciones Unidas procedan urgentemente a adoptar las medidas necesarias para evitar que se lleve a cabo.



Le agradecería que el texto de la presente carta y su anexo se distribuyeran como documento de la Asamblea General en su quincuagésimo período de sesiones, en relación con los temas 55 y 112 del programa y como documento del Consejo de Seguridad.
