Lettre datée du 13 mai 1996, adressée au Secrétaire général par  
le Représentant permanent de Chypre auprès de l'Organisation  
des Nations Unies

D'ordre de mon gouvernement, j'ai l'honneur de porter à votre attention un fait grave résultant d'une annonce publiée dans le journal chypriote turc Cyprus Today, daté du 6 avril 1996 (voir annexe). Cette annonce révèle un nouvel acte de provocation commis par les forces d'occupation turques à Chypre concernant la vente de l'église byzantine de Panagia Chysotrimithiotissa, située dans le village occupé de Trimithi, par l'agence immobilière Keskin & Smith pour un montant de 32 500 livres sterling.

Cette église appartient à l'évêché de Kyrenia et remonte à la période byzantine moyenne. En 1974, elle a été ajoutée sur une liste d'ouvrages que le Gouvernement devait classer comme monuments historiques.

Le Gouvernement de la République de Chypre a porté à votre attention les actes de profanation et de vandalisme commis à maintes reprises contre des églises et des monastères dans la partie de Chypre occupée par la Turquie depuis 1974, afin de mettre un terme aux tentatives systématiques de la Turquie de détruire le patrimoine culturel grec dans la partie occupée de Chypre.

Cette intervention constitue une nouvelle preuve de l'existence d'un plan délibéré conçu par la puissance occupante turque visant à modifier la structure démographique de la partie occupée de l'île en transférant des milliers de colons illégaux d'Anatolie et à détruire le patrimoine culturel de la population chypriote grecque locale dans cette région.

Le Gouvernement de la République de Chypre proteste vigoureusement contre cette décision illégale, sacrilège et condamnable, et demande à l'ONU de prendre d'urgence les mesures nécessaires afin d'empêcher qu'elle ne soit mise en oeuvre.



Je vous serais obligé de bien vouloir faire distribuer le texte de la présente lettre et de son annexe comme document de la cinquantième session de l'Assemblée générale, au titre des points 55 et 112 de l'ordre du jour, et du Conseil de sécurité.


