Note by the Secretariat

1. The proposed organization of work of the Commission for Social Development at its special session of 1996 (see annex) has been prepared pursuant to Economic and Social Council resolution 1995/60 and decision 1995/324, as well as General Assembly resolution 50/161, in order to facilitate consideration of agenda items within the time-frame available and in accordance with the conference services allocated to the Commission. The present revision reflects the views expressed and preliminary agreement reached during informal meetings held prior to the special session of the Commission.

2. Attention is drawn to the draft provisional agenda for this session contained in document E/CN.5/1996/1 and the related annotations, which set out the tasks entrusted to the Commission at its special session of 1996 by the Council and the General Assembly.

3. This timetable should be considered tentative and indicative; should the Commission complete the general discussion on an item before the date shown, it may wish to move immediately to the next item.

4. Arrangements have been made to hold morning and afternoon meetings during the session. The morning meetings will be held from 10 a.m. to 1 p.m. and the afternoon meetings from 3 p.m. to 6 p.m.
