I. BASIS OF ASSESSMENT OF MEMBER STATES' CONTRIBUTIONS TO UNIFIL  
FOR THE PERIOD FROM 1 AUGUST 1994 TO 30 APRIL 1996

A. Period from 1 August 1994 to 31 January 1995

1. Under General Assembly resolution 48/254 of 26 May 1994, the Secretary-General was authorized to enter into commitments for the United Nations Interim Force in Lebanon (UNIFIL) at a rate not to exceed \$11,857,000 gross (\$11,474,500 net) per month for a period up to six months beginning 1 August 1994, should the Security Council decide to continue the Force beyond the period of six months authorized under its resolution 895 (1994). In addition, by the same resolution, the General Assembly decided that there should be set off against the apportionment among Member States, their respective share in the unencumbered balance of \$931,000 gross (\$1,194,000 net) for the period from 1 February 1993 to 31 January 1994.

2. By its resolution 938 (1994) of 28 July 1994, the Security Council decided to extend the mandate of UNIFIL for a further interim period of six months until 31 January 1995. Accordingly, under the authorization granted to the Secretary-General by the General Assembly, an amount of \$70,211,000 gross (\$67,653,000 net), representing commitments for UNIFIL for the period from 1 August 1994 to 31 January 1995, net of their respective share in the unencumbered balance, was apportioned among Member States.

3. The amount so apportioned among Member States in accordance with the provisions laid out in section I.E below was appropriated by the General Assembly in its resolution 49/226 of 23 December 1994 and is shown in section IV of the present document.

B. Period from 1 February to 31 July 1995

4. By its resolution 49/226, the General Assembly decided to appropriate to the Special Account a total amount of \$67,407,000 gross (\$65,225,000 net) for the period from 1 February to 31 July 1995, subject to the decision of the Security Council to extend the mandate of the Force beyond 31 January 1995 and the mandate periods to be decided upon by the Council.

5. It was further decided that there should be set off against the apportionment among Member States their respective share in the estimated income of \$10,000 other than staff assessment income and their respective share in the Tax Equalization Fund of the estimated staff assessment income of \$2,172,000 for the period from 1 February to 31 July 1995, inclusive.

6. By its resolution 974 (1995) of 30 January 1995, the Security Council decided to extend the mandate of UNIFIL for a further interim period of six months until 31 July 1995. Accordingly, the amount of \$67,407,000 gross (\$65,225,000 net), representing commitments for UNIFIL for the period from 1 February to 31 July 1995 was apportioned among Member States in accordance with the provisions laid out in section I.E below and is shown in section V.

C. Period from 1 August 1995 to 31 January 1996

7. Under General Assembly resolution 49/226, the Secretary-General was authorized to enter into commitments for UNIFIL at a rate not to exceed \$11,234,500 gross (\$10,870,830 net) per month for a period of up to six months beginning on 1 August 1995, should the Security Council decide to continue the Force beyond 31 July 1995. By decision 49/483 of 12 July 1995, it further decided that there should be set off against the apportionment among Member States, in respect of such future mandate period(s) as might be approved by the Security Council, their respective share in the unencumbered balance of \$1,755,000 gross (\$16,000 net) for the period from 1 February 1994 to 31 January 1995, inclusive.

8. By its resolution 1006 (1995) of 28 July 1995, the Security Council decided to extend the mandate of UNIFIL for a further period of six months until 31 January 1996. Accordingly, under the authorization granted to the Secretary-General by the General Assembly, an amount of \$65,652,000 gross (\$65,208,980 net), was apportioned among Member States. The amount was apportioned in accordance with the provisions laid out in section I.E below and was later appropriated by the General Assembly in its resolution 50/89 of 19 December 1995. The apportionment, which is shown in section VI, was executed in two parts so as to reflect the pro rata application of the scale of assessments for the years 1995 and 1996 (see resolution 49/19 B as adjusted by decision 50/471 A).

D. Period from 1 February to 30 April 1996

9. By its resolution 50/89, the General Assembly authorized the Secretary-General to enter into commitments for the operation of the Force at a rate not to exceed \$10,774,800 gross (\$10,489,600 net) per month for a period of up to five months beginning 1 February 1996, and to assess the amount of \$32,324,400 gross (\$31,468,800 net) on Member States in accordance with the scheme set out in the resolution, should the Security Council decide to continue the Force beyond the period of six months authorized under its resolution 1006 (1995).

10. It was further decided that there should be set off against the apportionment among Member States their respective share in the estimated income of \$4,800 other than staff assessment income and their respective share in the Tax Equalization Fund of the estimated staff assessment income of \$850,800 for the period from 1 February to 30 April 1996, inclusive.

11. The Security Council, by its resolution 1039 (1996) of 29 January 1996, decided to extend the mandate of UNIFIL for a further period of six months until 31 July 1996. Accordingly, the amount indicated in paragraph 9 above was apportioned among Member States in accordance with the provisions laid out in section I.E below and is shown in section VII.

E. Apportionment of the costs of peace-keeping operations

12. On 11 December 1973, the General Assembly adopted resolution 3101 (XXVIII) on the financing of the United Nations Emergency Force (UNEF II). Under the resolution, the membership of the United Nations was divided into four groups: (a) the States permanent members of the Security Council; (b) specifically named economically developed Member States that were not permanent members of the Security Council; (c) economically less developed Member States; and (d) economically less developed Member States that were specifically named. The resolution also specified the amounts of the total appropriation to be distributed among each of the four groups.

13. The four amounts specified in the resolution were established by a methodology intended to produce the following results: the Member States in group D would pay 10 per cent of the assessment rates established for the regular budget, those in group C would pay 20 per cent, those in group B would pay 100 per cent and those in group A would pay 100 per cent plus the amounts not otherwise apportioned.

14. Within each group, according to the terms of resolution 3101 (XXVIII), the amount appropriated was to be distributed among the respective group members on the basis of the relative weight of each group member's regular rate of assessment in relation to the total rate for the group.

15. The scheme for the apportionment of costs set out in resolution 3101 (XXVIII) has continued to be applied since that time for all peace-keeping operations financed through assessed contributions, including UNIFIL. However, the composition of the four groups of Member States has changed repeatedly since 1973 as a result of the admission of 53 new Member States, including 1 new Member State in 1994, and the decisions contained in the various General Assembly resolutions, the latest of which is resolution 43/232 of 1 March 1989, as adjusted by the Assembly in its resolutions 44/192 B of 21 December 1989, 45/269 of 27 August 1991, 46/198 A of 20 December 1991, 47/218 A of 23 December 1992, 49/249 A of 20 July 1995 and 49/249 B of 14 September 1995 and its decisions 48/472 A of 23 December 1993 and 50/451 B of 23 December 1995. The percentage shares shown in sections IV to VII below demonstrate the results of the application of the scheme, using the scale of assessments for 1994, adopted by the General Assembly in its resolution 46/221 A of 20 December 1991 and adjusted in accordance with General Assembly decision 47/456 of 23 December 1992 and resolution 48/223 A of 23 December 1993, and the scale of assessments for 1995 and 1996, adopted by the Assembly in its resolution 49/19 B of 23 December 1994 as adjusted by its decision 50/471 A of 23 December 1995.
