**STATE OF PREPAREDNESS OF DOCUMENTS FOR  
THE UNITED NATIONS CONFERENCE ON HUMAN SETTLEMENTS  
(HABITAT II)**

*Note by the secretariat*

1. In its resolution 33/56, of 14 December 1978, section III, paragraph 2(c), the General Assembly stipulates that a report should be circulated eight weeks before the opening of an intergovernmental body on the state of preparedness of all the documents for the session, in all languages. Furthermore, in paragraph 1 of resolution 36/117B of 10 December 1981, the General Assembly decided that the documents should be given effective simultaneous distribution in sufficient time in the official and working languages of the United Nations. The injunction in resolution 33/56 was reaffirmed by the General Assembly in its resolution 39/68 of 13 December 1984.
2. In compliance with the above-mentioned resolutions, the Conference secretariat submits the following table which shows the status of preparation and distribution of documents for the United Nations Conference on Human Settlements as at 9 April 1996.
