SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS
OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE
STAGE REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The list of items of which the Security Council is seized is contained in documents S/1996/15 of 11 January 1996, S/1996/15/Add.4 of 9 February 1996, S/1996/15/Add.8 of 8 March 1996, S/1996/15/Add.14 of 19 April 1996 and S/1996/15/Add.18 of 17 May 1996.

The Security Council resumed its consideration of the item at its 3672nd meeting, held on 12 June 1996, in accordance with the understanding reached in its prior consultations.

The President drew attention to the text of a draft resolution (S/1996/426), submitted by the United Kingdom of Great Britain and Northern Ireland and the United States of America, and made oral revisions to the text of the draft resolution in its provisional form.

The Security Council proceeded to vote on draft resolution S/1996/426, as orally revised, and adopted it unanimously as resolution 1060 (1996) (for the text, see S/RES/1060 (1996); to be issued in Official Records of the Security Council, Fifty-first Year, Resolutions and Decisions of the Security Council, 1996).

The Security Council resumed its consideration of the item at its 3674th meeting, held on 14 June 1996, in accordance with the understanding reached in its prior consultations.

The President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for the text, see S/PRST/1996/28; to be issued in Official Records of the Security Council, Fifty-first Year, Resolutions and Decisions of the Security Council, 1996).

The situation in Tajikistan and along the Tajik-Afghan border (see S/25070/Add.34, S/1994/20/Add.37, S/1994/20/Add.44, S/1994/20/Add.49, S/1995/40/Add.14, S/1995/40/Add.19, S/1995/40/Add.23, S/1995/40/Add.33, S/1995/40/Add.44, S/1995/40/Add.49 and S/1996/15/Add.20; see also S/23370/Add.43)

The Security Council resumed its consideration of the item at its 3673rd meeting, held on 14 June 1996, in accordance with the understanding reached in its prior consultations, having before it the report of the Secretary-General on the situation in Tajikistan (S/1996/412).

The President, with the consent of the Council, invited the representative of Tajikistan, at his request, to participate in the discussion without the right to vote.

The President drew attention to the text of a draft resolution (S/1996/430) that had been prepared in the course of the Council's prior consultations.

The Security Council proceeded to vote on draft resolution S/1996/430 and adopted it unanimously as resolution 1061 (1996) (for the text, see S/RES/1061 (1996); to be issued in Official Records of the Security Council, Fifty-first Year, Resolutions and Decisions of the Security Council, 1996).
