LETTER DATED 27 JUNE 1996 FROM THE PERMANENT REPRESENTATIVE OF
IRAQ TO THE UNITED NATIONS ADDRESSED TO THE SECRETARY-GENERAL

On instructions from my Government, I have the honour to inform you that violations of Iraq's airspace by United States, British and French aircraft continued over the period 1-15 June 1996 and that the aircraft in question carried out reconnaissance and engaged in acts of provocation. The details are as follows:

1. In the northern region 101 sorties were flown at speeds of 600 to 900 kilometres per hour and at altitudes of 6,000 to 9,000 metres, over the following Iraqi cities and towns: Mosul, Irbil, Dohuk, Zakho, Aqrah, Amadiyah, Tall Afar and Ayn Zalah.
2. In the southern region 610 sorties were flown at speeds of 600 to 900 kilometres per hour and at altitudes of 6,000 to 9,000 metres, over the following Iraqi cities and towns: Nasiriyah, Samawah, Jalibah, Artawi, Busayyah, Qurnah, Chabaish, Maymunah, Shatrah, Hamzah, Qal'at Salih, Basra, Salman, Amarah, Shanafiyah, Lasaf, Ushbayjah, Rumaythah and Shu'aybah.
3. On 15 occasions United States TR-1 reconnaissance aircraft flying at speeds of 600 kilometres per hour and at altitudes of 20,000 metres violated the Republic of Iraq's airspace in the southern region before leaving in the direction of Kuwait.
4. Hostile United States-Jordanian aerial activity inside Iraqi airspace on 2, 4, 10 and 15 June 1996 consisted of 30 sorties over Lasaf, Ar'ar, Salman, Amghar and Ushbayjah.
5. At 2235 hours on 5 June 1996 a hostile formation dropped one heat flare in the Nashwah area of Basra Governorate, two heat flares in the Chabaish area, two heat flares in the Suq al-Shuyukh area and one heat flare to the south-west of Nasiriyah in Dhi Qar Governorate.

You are requested to intervene with the countries in question with a view to bringing a halt to actions that, as flagrant violations of the Charter of the United Nations and the norms of international law, pose a threat to the sovereignty and territorial integrity of the Republic of Iraq.

These actions continue to alarm the civilian population and to cause serious damage to private and public property. The Republic of Iraq affirms its right to seek legal compensation for the damage being inflicted on the Iraqi people and the Iraqi State.
