SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH
THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN
THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The Security Council resumed its consideration of the item at its 3644th meeting, held on 27 March 1996 in accordance with the understanding reached in its prior consultations, having before it the letter dated 7 December 1995 from the Chairman of the Security Council Committee established by resolution 661 (1990) concerning the situation between Iraq and Kuwait, addressed to the President of the Security Council (S/1995/1017).

The President drew attention to the text of a draft resolution (S/1996/221), submitted by France, Germany, Italy, the United Kingdom of Great Britain and Northern Ireland and the United States of America.

The Security Council proceeded to vote on draft resolution S/1996/221, and adopted it unanimously as resolution 1051 (1996) (for the text, see S/RES/1051 (1996); to be issued in Official Records of the Security Council, Fifty-first Year, Resolutions and Decisions of the Security Council, 1996).

The Security Council resumed its consideration of the item at its 3645th meeting, held on 28 March 1996 in accordance with the understanding reached in its prior consultations.

The President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for the text, see S/PRST/1996/13; to be issued in Official Records of the Security Council, Fifty-first Year, Resolutions and Decisions of the Security Council, 1996).

The Security Council resumed its consideration of the item at its 3646th meeting, held on 29 March 1996 in accordance with the understanding reached in its prior consultations, having before it the report of the Secretary-General on the situation in Tajikistan (S/1996/212).

The President, with the consent of the Council, invited the representative of Tajikistan, at his request, to participate in the discussion without the right to vote.

The President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for the text see S/PRST/1996/14; to be issued in Official Records of the Security Council, Fifty-first Year, Resolutions and Decisions of the Security Council, 1996).
