MEETING OF STATES PARTIES
Fourth Meeting
New York, 4-8 March 1996

DECISIONS OF THE MEETING OF STATES PARTIES
ON BUDGETARY MATTERS 1/

(adopted on 8 March 1996)

1. The Meeting of States Parties approved the budget of the International Tribunal for the Law of the Sea covering the initial period from 1 August 1996 to 31 December 1997, amounting to \$6,170,900, as set out in annex III to document SPLOS/WP.3; 2/ together with the staffing table for the Registry during the start-up period of the Tribunal as contained in annexes I and II thereto. In adopting the budget the Meeting also approved the administrative arrangements to be carried out by the Secretary-General and by the officer in charge of the Registry pending the election of the Registrar described in paragraphs 27-29 of document SPLOS/WP.3. 3/

2. Without prejudice to the application of the provisions of article 19 of annex VI of the Convention on the Law of the Sea in respect of future budgets regarding the contribution by the International Seabed Authority, the budget of the Tribunal for the initial period will be financed by all States that are Parties to the Convention as at 1 August 1996. States that become Parties to the Convention thereafter and during the period of the budget will contribute pro rata for the remainder of the initial budget period.

3. The contributions to be made by States Parties shall be based upon the scale of assessments for the regular budget of the United Nations applicable at the time of the adoption of the budget of the Tribunal for the corresponding financial year, adjusted to take account of participation in the Convention. This shall be applied provisionally pending the adoption of a scale by the Meeting of States Parties.

4. The Secretary-General of the United Nations will, on the basis of a list of States Parties and States likely to be States Parties by 1 August 1996, determine the assessed contributions and advise all such States, not later than

15 March 1996, of their contribution payable to the initial budget in accordance with the provisional scale of assessments referred to in paragraph 3. The indicative scale of assessed contributions to the budget of the Tribunal as at 8 March 1996 applicable to States Parties and States likely to be Parties by 1 August 1996 appears in the annex to the present document. States Parties will be requested to pay at least 15 per cent of their contribution within 30 days in order to meet the start-up costs, the balance to be paid in accordance with paragraphs 5 and 6 below.

5. The provisional scale of assessments will be revised on 1 July 1996 on the basis of participation in the Convention as at 1 August 1996. ^{4/} The Secretary-General will notify States of their revised assessed contributions by 15 July 1996.

6. The notification will specify the details of the assessed contribution of each State Party that is attributed to each calendar year of the biennium 1996-1997. Contributions paid earlier to meet the start-up costs will be credited towards contributions due. The notification will call upon States to pay promptly and in full the assessed contribution for 1996 by 15 August 1996 and for 1997 by 15 January 1997.

7. Adjustments will be made to the scale referred to in paragraph 5 to take into account any increase in the number of States Parties. The contribution paid by a State that is a Party as at 1 August 1996 which is in excess of its assessed contribution as a result of adjustments to the scale will be credited to the assessment of the State Party concerned for the next financial period.

8. All contributions will be paid into a separate bank account, and in a convertible currency, to be designated by the Secretary-General of the United Nations, and subsequently into a bank account, and in a convertible currency, as may be designated by the Registrar of the Tribunal. States Parties will be periodically notified of the status of contributions.

9. The collection and management of all contributions shall be undertaken by the Registry, except such services that the Secretary-General of the United Nations will provide from within existing resources, in accordance with General Assembly resolutions 49/28 of 6 December 1994 and 50/23 of 5 December 1995. The Meeting also approved the utilization of the contingency funds as set out in annex III, item D, of document SPLOS/WP.3, ^{5/} in the event that the officer in charge of the Registry considers it essential before the President of the Tribunal is elected.

10. The draft financial regulations and staff regulations which will govern the management of the resources of the Tribunal shall be prepared and submitted for the approval of the Meeting of States Parties in accordance with rule 72 of the rules of procedure of the Meeting of States Parties. Until such regulations have been approved the Financial Regulations and the Staff Regulations of the United Nations will apply mutatis mutandis.

11. The Meeting requests the Secretary-General of the United Nations, in accordance with General Assembly resolutions 49/28 and 50/23 and the programmed activities of the Division for Ocean Affairs and the Law of the Sea of the

Office of Legal Affairs, to continue assistance in establishing the Tribunal and to cooperate with and lend support to the Tribunal in the fulfilment of its functions.
