Has attended several international conferences and meetings of experts pertaining to solar energy, renewable energy sources, rural energy and energy research. Currently member of the United Nations Committee on New and Renewable Sources of Energy and on Energy for Development; was elected Chairman of the Committee at its session held in February 1996.
