Note by the Secretary-General

1. The forty-ninth session of the Committee on the Elimination of Racial Discrimination will be held at the United Nations Office at Geneva from 5 to 23 August 1996. The first meeting of the session will be convened at 10.30 a.m. on Monday, 5 August.
2. This document contains the provisional agenda for the forty-ninth session of the Committee, prepared by the Secretary-General in accordance with rule 6 of the rules of procedure, together with annotations relating thereto.

4. Prevention of racial discrimination, including early warning and urgent procedures

The Committee decided at its forty-fifth session to establish this item as one of its regular and principal agenda items. Within the framework of its efforts to prevent racial discrimination, the Committee may decide to take early warning measures aimed at preventing existing problems from escalating into conflicts; or it may decide to initiate urgent procedures aimed at responding to problems requiring immediate attention to prevent or limit the scale or number of serious violations of the Convention. The Committee may also take action or further action regarding States parties already considered under the item.

5. Consideration of reports, comments and information submitted by States parties under article 9 of the Convention

At its forty-ninth session, the Committee will consider reports received from the following States parties: Bolivia, Brazil, China, Guatemala, India, Malta, Mauritius, Namibia, Panama, Republic of Korea, Swaziland, Venezuela, Zaire.

Pursuant to decisions taken at its forty-eighth session, the Committee has scheduled, at its forty-ninth session, a review of the implementation of the Convention in a number of States parties whose reports are excessively overdue. Those States parties are the following: Bahamas, Botswana, Burkina Faso, Cape Verde, Fiji, Gabon, Lao People's Democratic Republic, Lebanon, Lesotho, Saint Vincent and the Grenadines, Solomon Islands, Somalia, Togo.

In pursuance of established practice and in conformity with rule 64 of the rules of procedure, the Secretary-General has informed the States parties concerned of the tentative dates on which their respective reports are scheduled for consideration or review by the Committee. For the scheduling of the Committee's consideration of that information, see the timetable for consideration of reports, further information and reviews under agenda item 3 above.

6. Consideration of communications under article 14 of the Convention

In accordance with the provisions of chapter XVIII of its rules of procedure, the Committee will consider under this item communications which are or appear to be submitted to it under article 14 of the Convention.

In accordance with rule 88 of the rules of procedure, the meetings of the Committee during which communications under article 14 of the Convention are examined shall be closed.

7. Submission of reports by States parties under article 9, paragraph 1, of the Convention

At its forty-ninth session, the Committee will have before it a note by the Secretary-General concerning the status of submission of reports by States parties in accordance with article 9 of the Convention (CERD/C/306). Part A of that document indicates reports received from States parties and pending consideration by the Committee. Part B of the document contains information relating to overdue reports.

8. Third Decade to Combat Racism and Racial Discrimination

At its 695th meeting (thirtieth session) in August 1984, the Committee decided to keep this item on its agenda and requested the Secretary-General to keep it informed of the relevant activities which would be undertaken in accordance with the Programme of Action for the Third Decade.

9. Report of the Committee to the General Assembly at its fifty-first session under article 9, paragraph 2, of the Convention

In accordance with article 9, paragraph 2, of the Convention, the Committee is to submit, through the Secretary-General, an annual report to the General Assembly. The 1996 report to the fifty-first session of the Assembly is to cover the activities of the Committee at its forty-eighth and forty-ninth sessions.
