Чистое поступление взносов со стороны доноров и правительств стран-получателей

РЕЗЮМЕ

В соответствии с решением 84/9 Совета управляющих от 29 июня 1984 года в настоящем добавлении содержится информация о чистом поступлении взносов в Программу развития Организации Объединенных Наций и о выплатах с ее стороны применительно к каждому участвующему правительству. Приводится также информация о недоплате взносов для покрытия расходов на содержание местных отделений после перехода на совместную отчетность, который был санкционирован в этом же решении Совета.

Исполнительный совет может пожелать принять к сведению настоящее добавление.

ВВЕДЕНИЕ

1. В соответствии с практикой, определенной Советом управляющих в его решении 84/9, настоящий документ содержит следующую информацию:

a) в таблице 1 содержится информация о взносах, полученных в течение 1995 года от каждой страны-донора по всем источникам средств, которыми распоряжается ПРООН;

b) в таблице 2 содержится информация о взносах, полученных в течение 1995 года от каждой страны-получателя, а также о расходах в 1995 году с разбивкой по каждой главной категории;

c) в таблице 3 перечислены те страны, которые после перехода на совместную отчетность в отношении добровольных взносов и расходов на местные отделения, санкционированного в решении 84/9 Совета управляющих (см. пункт 8), не достигли установленных целевых показателей в отношении правительственных расходов на содержание местных отделений. Перечисленные суммы отражены в таблице 2, поэтому суммы, указанные в таблице 3, отражают недостаточный уровень взносов, полученных в 1995 году.

2. С тем чтобы избежать любого неправильного толкования данных, содержащихся в этих таблицах, важно учесть, что информация представлена на основе следующих факторов:

a) Поступления

i) в таблицу 1 и в таблицу 2 были включены только те взносы наличностью, которые были фактически получены в течение 1995 года;

ii) в таблице 2 указанные суммы не включают взносы натурой, сделанные правительствами стран-получателей на осуществление проектов или покрытие расходов на содержание местных отделений;

b) Расходы

i) все указанные в таблице 2 цифры, связанные с расходами, не включают данные о налогообложении персонала и о соответствующих вспомогательных расходах;

ii) в таблицу 2 не включены расходы по глобальным, региональным и межстрановым программам.
