According to information received from officials of the Government of the Islamic Republic of Iran:

- 1. On 7 April 1996, a United States frigate named YENDOR60GFFSIWADM at the position of N2852 and E5022 violated the territorial waters of the Islamic Republic of Iran and fled the region after receiving warning.
- 2. On 18 April 1996, at 1400 hours, a United States warship at the position of N2905 and E5015 created a nuisance for Iranian helicopter AB-212.

The Government of the Islamic Republic of Iran protests these illegal measures by the United States Government and calls for an end to such actions.
