Dear Mr. Diallo,

Thank you for your letter of 14 March 1996 calling our attention to the INCD resolution 8/2, which in particular requested international organizations such as UNDP to submit in writing, before 1 June 1996, an expression of interest in providing overall administrative support to the permanent Secretariat of the CCD.

Let me start by reiterating UNDP's commitment to support the implementation of the Convention in context of our mission to assist programme countries to realize sustainable human development in line with their national development programmes and priorities. UNDP, particularly through our Office to Combat Desertification and Drought (UNSO), is already providing substantive support to the preparation and implementation of the Action Programmes at National, Sub-regional and Regional levels, particularly in Africa, and will intensify this support in the future. This will continue to be our primary preoccupation.

In addition we have already indicated our willingness to host the Global Mechanism of the CCD if the Conference of the Parties requests us to serve in that capacity. We have also continued to collaborate closely with the Interim Secretariat of the CCD and expect this working relationship to intensify as implementation of activities gathers momentum with the entry into force of the Convention. In this regard, we see UNDP supporting the work of the Permanent Secretariat through the following:

- Assistance of UNDP field offices to support outreach aspects of the work of the Secretariat;
- Technical backstopping to complement some aspects of the work of the Secretariat, including through enhancing the capacity of the Secretariat by periodically seconding staff on full or part-time basis as appropriate;
- Facilitate the work of the Permanent Secretariat particularly relating to information collection and reporting, through UNDP field offices.

We recognize that the above areas of support do not exactly respond to the need for an organization to provide "overall administrative support to the Permanent Secretariat" as stated in the aforementioned resolution. We also note the readiness of other relevant organisations, such as UNEP and WMO to host the Secretariat as expressed in their respective statements to the INCD. It might well be that the kinds of services proposed by UNSO, could be provided as "adjunct to overall arrangements" between the Conference of the Parties and the United Nations system and/or any of its organizations.
