**LETTER DATED 30 AUGUST 1996 FROM THE SECRETARY-GENERAL  
ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL**

I have the honour to refer to resolution 1011 (1995), adopted by the Security Council on 16 August 1995, regarding the situation in Rwanda. In paragraph 12 of that resolution, I was requested to report to the Council within six months of the date of adoption of the resolution, regarding, in particular, the export of arms and related matériel to the Government of Rwanda, on the basis of reports submitted by the Committee established pursuant to resolution 918 (1994) concerning Rwanda. The report is contained in document S/1996/202. I was also requested to report to the Council again within 12 months.

Accordingly, I wish to inform you that during this period, the Committee established pursuant to resolution 918 (1994) concerning Rwanda has received the following notifications with regard to the export to, and the import by, the Government of Rwanda of arms and related matériel which have been published as documents of the Security Council:

Export to the Government of Rwanda

(a) On 12 February 1996, from the Government of Singapore for the export of spare parts for vehicles from Singapore to Rwanda through the entry point of Rusumo, Rwanda, via the port of Dar es Salaam, United Republic of Tanzania, which has also been notified by the Government of Rwanda (S/1996/329/Rev.1). The total value of the shipment is f.o.b. US\$ 161,808.23;

(b) On 24 May 1996, from the Government of Singapore for the export of spare parts for vehicles from the Tata Engineering Services (Pte) Ltd. (a Singapore company) to Rwanda through the entry point of Rusumo, Rwanda, via the port of Dar es Salaam (S/1996/396/Rev.1). The total value of the shipment is f.o.b. US\$ 200,746.70;

Import by the Government of Rwanda

(c) On 14 March 1996, from the Government of Rwanda (S/1996/329/Rev.1) for the importation of:

- (i) Two (2) boats for patrol purposes from Italy through the entry point of Rusumo, Rwanda, through the port of Dar es Salaam. The total value of the shipment is c.i.f. Dar es Salaam, US\$ 291,000;
- (ii) Sixty-five (65) Toyota cars from Dubai through the entry point of Rusumo, Rwanda, through the port of Dar es Salaam. The total value of the shipment is c.i.f. Dar es Salaam, US\$ 1,279,030;
- (iii) One hundred twenty-two (122) Tata vehicles for military use, from Singapore through the entry point of Rusumo, Rwanda, through the port of Dar es Salaam. The total value of the shipment is c.i.f. Dar es Salaam, US\$ 4,317,500;
- (d) On 3 June 1996, from the Government of Rwanda for the importation of military clothing from Germany to Rwanda through the entry point of Rusumo, Rwanda, via the port of Dar es Salaam (S/1996/407/Rev.1). The total value of the shipment is US\$ 531,636.
