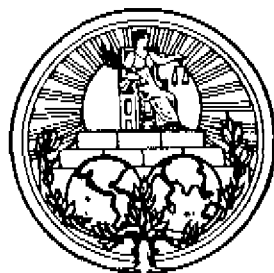

PRÉFACE

Le présent fascicule contient les indications bibliographiques intéressant la Cour internationale de Justice qui sont relatives à la période 16 juillet 1964-31 décembre 1965.



Ainsi que l'indiquent son numéro d'ordre (n° 19) et les numéros des titres qui y figurent (6616-7122), il fait suite aux listes qui ont paru dans le chapitre IX des *Annuaire* et *Yearbooks* de la Cour de 1946-1947 à 1963-1964¹. Il complète ces listes et y renvoie éventuellement par une indication figurant sous l'en-tête de chaque section, le groupement systématique restant le même dans ses grandes lignes.

Les fascicules n°s 1-18 ont fait l'objet de tirages à part, que l'on peut se procurer au même prix que le présent fascicule. Les deux index cumulatifs du n° 18 (chapitre IX de l'*Annuaire* et du *Yearbook* 1963-1964) renvoient à l'ensemble des n°s 1-18.

Le présent fascicule est publié, comme le seront les fascicules suivants, en une édition bilingue indépendante de l'*Annuaire* et du *Yearbook*. A intervalles réguliers, le Greffe mettra en vente des couvertures mobiles permettant de relier ensemble plusieurs fascicules. C'est pourquoi il a paru commode de donner au présent fascicule et aux fascicules suivants une pagination continue.



La *Bibliographie*, préparée par la bibliothèque privée de la Cour, n'engage en aucune façon la Cour. Les indications bibliographiques qu'elle contient ne sont uniformes que pour les titres rédigés au Greffe; les autres ont été reproduites telles qu'elles figurent dans des bibliographies nationales ou dans les lettres de correspondants occasionnels; c'est ce qui explique les légères divergences que l'on constatera dans le système suivi. Ces indications sont aussi complètes que les informations parvenues au Greffe le permettent, notamment en ce qui concerne les documents, ouvrages ou articles relatifs à la suite donnée aux affaires jugées par la Cour. Pour permettre de combler les inévitables lacunes des *Bibliographies* parues à ce jour, les lecteurs sont priés de bien vouloir signaler à M. le Greffier de la Cour internationale de Justice, palais de la Paix, La Haye, Pays-Bas, les titres qui n'y figureraient pas.

PREFACE

The present issue contains bibliographical references of interest in connection with the International Court of Justice for the period 16 July 1964-31 December 1965.

As appears from its serial number (*No. 19*) and from the entry numbers (6616-7122), this bibliography is a continuation of the lists published in Chapter IX of the *Yearbooks* and *Annaires* of the Court for the years 1946-1947 to 1963-1964¹. It supplements those lists and, where appropriate, gives references to them immediately after the title of each section, the system of grouping being, for the most part, the same.

Issues *Nos. 1-18* were also published as offprints, which may be procured at the same price as the present issue. The two cumulative indexes of *No. 18* (Chapter IX of the *Yearbook* and *Annuaire 1963-1964*) cover all issues from *No. 1* to *No. 18*.

The present issue is published, as future issues will be, in the form of a bilingual edition quite separate from the *Yearbook* and the *Annuaire*. The Registry will eventually put on sale loose covers for binding together several issues, and for the sake of convenience continuous pagination is being introduced as from the present issue.

The *Bibliography*, which is prepared by the Court's private library, in no way involves the responsibility of the Court. The bibliographical references which it contains are uniform only so far as concerns entries prepared by the Registry; the others have been reproduced as they appear in national bibliographies or in the letters of casual correspondents; this will explain any slight differences that may be observed in the system followed. These references are as complete as the information received by the Registry permits, in particular in regard to documents, works or articles relating to the post-adjudicative phase of cases. Inevitable omissions in the *Bibliographies* previously published will be rectified if readers will be good enough to bring to the notice of the *Registrar, International Court of Justice, Peace Palace, The Hague, Netherlands*, the titles of works which have not been included.
