B. The judiciary

Appointed High Court Judge with effect from 23 August 1995

C. The Law Commission

Assigned to the Malawi Law Commission (while still Judge) as Law Commissioner, a position of same grade as Justice of Appeal, with effect from 18 January 1996

Duties: A position created under the 1994 new democratic Constitution with duties to:

- Review all the laws of Malawi to bring them into conformity with the new Constitution and international law
- Review the Constitution itself
- Make recommendations on such reviews directly to Parliament
- Act independent of any person or authority

D. Human Rights Commission

One of the two principal officers (with the Ombudsman) of the Human Rights Commission, a new institution created under the new democratic Constitution of 1994 with duties to:

- Protect human rights and investigate violations
- Ensure conformity to human rights conventions and protocols
- Report to Parliament on its work
