José María Gamio Cia (Uruguay)

Date of birth: 1940

<u>Current post</u>: Professor of law at the University of the Eastern Republic of Uruguay and member of the Faculty of Public International Law.

<u>Previous posts</u>: Under-Secretary in the Ministry of Foreign Affairs of the Eastern Republic of Uruguay (1993); Chairman of the Appointments Committee of the Ministry of Foreign Affairs (1993); Chairman of the working group on institutional aspects of the Southern Cone Common Market (MERCOSUR) (1993); National Coordinator of the Rio Group (1993); member of the Civil Service Commission (1986); Director-General of the Ministry of Public Health secretariat (1986); Director of the Department of Culture in the Ministry of Education and Culture (1969-1974); served as a consultant to businesses in a wide variety of areas related to civil, commercial, banking, labour, maritime and tax law.
