JOINT STATEMENT ON THE COMPREHENSIVE NUCLEAR TEST-BAN
TREATY MADE BY THE MINISTER OF FOREIGN AFFAIRS OF THE
RUSSIAN FEDERATION, E.M. PRIMAKOV AND UNITED STATES
SECRETARY OF STATE, WARREN CHRISTOPHER IN JAKARTA
ON 23 JULY 1996

Guided by desire to do everything possible to bring about the implementation of the decisions of the Review and Extension Conference on the Treaty on the Non-Proliferation of Nuclear Weapons and the decisions of the United Nations with regard to the conclusion of the Treaty on the Comprehensive Nuclear Test Ban the Russian Federation and the United States of America are prepared to support the draft Treaty on the Comprehensive Nuclear Test Ban as it was proposed on 28 June of this year by the Chairman of the Ad Hoc Committee on the Nuclear Test Ban of the Conference on Disarmament, Mr. J. Ramaker, although this document does not fully satisfy both sides.

Russia and the United States of America urge other participants in the negotiations to also support that draft so when the work of the session of the Conference on Disarmament is resumed on 29 July, its participants could make a decision to approve the draft treaty and to send it for approval and for opening for signature in the course of the forthcoming session of the United Nations General Assembly.
