## A. Matters related to, and inter-sessional departures from, the approved calendar for 1996

Introduction and overview

1. In its resolution 50/206 A of 23 December 1995, the General Assembly approved the draft calendar of conferences and meetings of the United Nations for the biennium 1996-1997 as set forth in the annex to the report of the Committee on Conferences to the Assembly at its fiftieth session $1 /$ and amended by subsequent decisions taken by the Assembly during that session.
2. At its 373rd meeting, on 26 August 1994, the Committee had decided that requests for inter-sessional departures submitted to the Committee should, in future, be reviewed by the Bureau, in consultation with the Secretariat, for subsequent action.
3. At its 379 th meeting, on 23 March 1995, the Committee agreed that proposed changes to the calendar that did not have programme budget implications could be dealt with by the Secretariat in consultation with the Bureau of the Committee.
4. At its substantive session of 1995, the Committee on Conferences decided that requests for inter-sessional departures submitted to the Committee that involved a change of venue should be referred to the members for approval. Departures that involved other types of changes should, as the Committee had decided at its substantive session of 1994, be reviewed by the Bureau, in consultation with the Secretariat, for subsequent action.
5. In accordance with established procedure, the Committee was informed, by written communication, of requests for changes in venue made by the Advisory Board on Disarmament Matters and the Panel of External Auditors of the United Nations and the United Nations Board of Auditors. The nature of the requests and the action taken by the Committee are described below.

To meet from 1 to 5 July 1996 at Geneva rather than at its established headquarters in New York. The Secretary-General would be in Geneva during the first week of July. Moreover, the presence of the members of the Board in Geneva at that time would give support to a seminar/ conference devoted to the question of the history of multilateral disarmament, which would also take place at Geneva during the session of the Advisory Board. Furthermore, the change of venue would provide the members of the Advisory Board, which served as the Board of Trustees of the United Nations Institute for Disarmament Research, the opportunity to have direct contact with the activities and staff of the Institute and to consult with delegations participating in the Conference on Disarmament, whose negotiations on a comprehensive nuclear test-ban treaty were at a crucial juncture.

To meet at Vienna. As they were inter-agency bodies, the Board of Auditors and Panel of External Auditors did not have an established headquarters. In accordance with its rules of procedure, the Board should convene annually at United Nations Headquarters in June and may convene at such other times and places as may be necessary for the due performance of the duties of the Board at the request of the Chairman or any member of the Board.

To meet at Geneva from 12 to 23 August 1996 rather than at its established headquarters in New York from 10 to 21 June 1996. The change would make it possible to coordinate the venue of its meeting with that of the International Congress of Onomastic Sciences, which would be held at Aberdeen, Scotland, from 4 to 11 August 1996, and which many members of the Group of Experts would attend.
6. In addition, at its 389 th meeting, on 3 June 1996, the Committee considered the proposed convening by the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples of a Pacific regional seminar to review the political, economic and social conditions in the small island Non-Self-Governing Territories, at Port Moresby, from 12 to 14 June 1996.

## Conclusions and recommendations

7. The Chairman of the Committee on Conferences addressed the following letter to the President of the General Assembly:
"At its 389 th meeting, on 3 June 1996, the Committee on Conferences considered the proposed convening by the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples of a Pacific regional seminar to review the political, economic and social conditions in the small island Non-Self-Governing Territories, at Port Moresby, Papua New Guinea, from 12 to 14 June 1996. While the holding of the seminar had been approved by the General Assembly in its resolution 50/39 of 6 December 1995 and provision had been made for the substantive servicing of the seminar in the programme budget for the biennium 1996-1997 (section 2 ), the seminar had not in fact been included in the official calendar of conferences and meetings of the United Nations issued in March 1996 (A/AC.172/1996/2) owing to the lack of information on its dates and venue at that time.
"During the discussion on the matter, the view was expressed that by convening the three-day seminar at Port Moresby, rather than at the headquarters of the Special Committee in New York, the United Nations would not be making efficient use of its limited financial resources, a course of action that would, moreover, be perceived negatively outside the Organization. Furthermore, as the members of the Committee on Conferences had not been apprised of the seminar prior to approving the calendar of conferences and meetings, they had not had the opportunity to review and debate the matter.
"In reply to a query concerning the expenses involved, the Secretariat informed members that the cost of convening the seminar at Headquarters
amounted to $\$ 173,335$; the cost of convening it at Port Moresby amounted to $\$ 130,446$.
"The view was expressed that the figures provided were in fact cost estimates made on the basis of full participation and that accurate costing required a review of participation over the past five years. The view was also expressed that there was no reason to hold the seminar in New York if no savings were involved.
"Following a debate on the matter, the Committee on Conferences took the decision to inform the General Assembly that no agreement had been reached within the Committee to recommend that the Assembly include in the calendar of conferences and meetings for 1996 the Pacific regional seminar with Port Moresby, Papua New Guinea, as its venue.
"The Committee on Conferences requests the President of the General Assembly to bring the concerns expressed in the present letter to the attention of the General Assembly."

## B. Adoption of the draft revised calendar of conferences and meetings for 1997

## Introduction and overview

8. At its 391st meeting, on 19 August 1996, the Committee on Conferences reviewed the draft revised calendar of conferences and meetings for 1997 (A/AC.172/1996/CRP. 2 and Add.1).
9. With regard to the consolidated statement of scheduled special conferences for 1997, requested by the General Assembly in its resolution 46/190 of 20 December 1991, the Secretariat informed the Committee that, as no special conferences were scheduled for 1997, a consolidated statement had not been issued.
10. Also at its 391 st meeting, clarification was sought and received from the Secretariat regarding various items and aspects of the draft revised calendar of conferences and meetings for 1997, including the matter of waivers granted to intergovernmental bodies that request to meet away from their established headquarters, thus constituting a departure from General Assembly resolution 40/243.
11. The Committee requested the Secretariat to submit a report on all bodies that had a general waiver to meet away from their established headquarters, thus constituting a departure from General Assembly resolution 40/243, to be reviewed by the Committee during the main part of the fifty-first session of the General Assembly.
12. At its 396 th meeting, on 19 September 1996, the Committee reviewed a report of the Secretary-General and a conference room paper on the matter (A/49/212 and A/AC.172/1996/CRP.7, respectively).

## Discussion

13. Concern was expressed that the previous sessions of two and three weeks' duration, respectively, of the Committee on the Peaceful Uses of Outer Space and
of its Legal Subcommittee were too long, considering the number of meetings planned and actually held by those bodies.
14. In that regard, it was recalled that, in accordance with General Assembly resolution $50 / 27$ of 6 December 1995, a Working Group of the Whole had been established by the Committee on the Peaceful Uses of Outer Space to examine the working methods of the Committee, including the duration of its session, in order to reach consensus and to accommodate the different views and concerns expressed by the members of the Committee. It was felt that other United Nations bodies, including the Main Committees, in particular those that underutilized their conference resources, could follow that example and consider reviewing their meeting entitlements.
15. Clarification was sought and received from the Secretariat about the capability of the Organization to absorb meetings added to the calendar of conferences and meetings for which resources had not initially been provided in the budget. The representative of the Secretariat explained that the procedure of "overprogramming" had frequently made it possible to do so, as resources were made available when scheduled meetings were cancelled. The current reduced level of resources, however, was sufficient to cover only the meetings included in the calendar of conferences and meetings as adopted by the General Assembly in 1995.
16. The view was expressed that, for financial reasons and in the interest of improved efficiency and effectiveness, subsidiary bodies that had been granted an exception to meet away from their established headquarters should be invited to review their need for the exception in the light of the current situation of their work. In the case of subsidiary bodies without a specific exception, authorization to meet away from their established headquarters should be granted on the basis of a recommendation by the Committee on Conferences.
17. With regard to the 1997 Caribbean regional seminar of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples, the representative of the Secretariat explained that provision had been made for the seminar in the programme of work of the Special Committee, which had been approved by the General Assembly. Moreover, it was expected that conference-servicing resources would not be required for that seminar.
18. The view was expressed that the Committee on Conferences should request the Fourth Committee to review the exception of the Special Committee to meet away from New York. The view was also expressed that such a request should not be made of the Fourth Committee.

## Conclusions and recommendations

19. The Committee recommended to the General Assembly that it should:
(a) Adopt the draft revised calendar of conferences and meetings for 1997;
(b) Authorize the Committee to make adjustments to the calendar of
conferences and meetings for 1997 that might become necessary as a result of action and decisions taken by the General Assembly at its fifty-first session.
20. The Committee noted that the Secretariat had taken into account the arrangements referred to in paragraph 4 of General Assembly resolution 50/206 A.

Accordingly, no sessions were scheduled to open or close on 10 February or 17 April 1997 and bodies would be invited not to hold meetings on those days. The Committee requested the Secretariat to make similar arrangements when drafting the biennial calendar of conferences and meetings for 1998-1999 for presentation to the Committee at its substantive session of 1997.
21. The Committee recommended to the General Assembly that the Assembly should grant waivers to the headquarters rule solely on the basis of a recommendation of the Committee.
22. The Committee on Conferences, recalling paragraph 12 of General Assembly resolution 50/206 A, recommended that the Assembly invite all its subsidiary bodies that were authorized to meet away from their established headquarters to review the exception to the headquarters rule in the light of the current situation of their work, and to make recommendations thereon, through the Committee on Conferences, to the Assembly at its fifty-second session.
23. The Committee further recommended that the General Assembly invite the Economic and Social Council to request all its subsidiary bodies to carry out the same review.
24. The Committee recommended to the General Assembly that it request the bodies that had not fully utilized their meeting entitlements, including the duration of their sessions, to review their meeting entitlements.
25. The Committee recommended that the General Assembly should consider the budgetary impact of any meetings added to the calendar of conferences and meetings for the biennium, as adopted by the General Assembly in 1995, taking into account the letter from the Chairman of the Committee on Conferences to the Chairman of the Fifth Committee contained in document A/C.5/50/66, in which it was stated that available resources would be sufficient to service only those meetings approved in the calendar of conferences, and no additional meetings requested by any intergovernmental organ could be accommodated without additional resources.

## C. Improved utilization of conference-servicing resources

1. Meeting statistics of United Nations organs

## Introduction and overview

26. At its 391 st meeting, on 19 August 1996, the Committee on Conferences reviewed a report of the Secretary-General on meeting statistics of United Nations organs that met in 1995 (A/AC.172/1996/3).

## Discussion

27. Clarification was sought and received from the Secretariat regarding various aspects of the report contained in that document.
28. Concern was expressed regarding the linkage between the duration of meetings and the number of planned meetings.
29. Regret was expressed that the overall utilization factor for 1995 had fallen to 76 per cent from 77 per cent in 1994, that the average utilization
factor for 1995 had dropped to 78 per cent from 82 per cent in 1994 and that the percentage of bodies in the core sample that had utilization factors equal to or exceeding the benchmark figure of 80 per cent had fallen to 54 per cent in 1995 from 62 per cent in the previous year.

## Conclusions and recommendations

30. The Committee on Conferences took note with concern that the overall and average utilization factors ( 76 per cent and 78 per cent, respectively) of the core sample of bodies included in document A/AC.172/1996/3 were below the benchmark figure of 80 per cent.

## 2. Consultations with bodies concerning utilization of the conference services and facilities available to them

## Introduction and overview

31. At its 382 nd meeting, on 21 August 1995, the Committee on Conferences requested its Chairman to consult on its behalf with the chairmen of bodies that had consistently utilized less than the applicable benchmark figure (75 per cent for calendar year 1993 and 80 per cent for calendar years 1994 and 1995) of their allocated resources for the past three sessions, with a view to making appropriate recommendations in order to achieve the optimum utilization of conference-servicing resources.
32. At its 390 th meeting, on 19 August 1996, the Chairman of the Committee provided an oral report on the results of the aforementioned consultations. The Chairman informed the Committee that he had held consultations with the Chairmen of the Committee on Information and the Ad Hoc Committee on the Indian Ocean.
33. Moreover, at its $382 n$ meeting, the Committee requested its Chairman to transmit a letter to the chairmen of subsidiary bodies that had utilized less than 80 per cent of their conference resources in 1994 to invite them to report on measures taken to improve their utilization of conference-servicing resources and realistically to assess their need for such resources, with a view to reducing the conference resources requested.
34. At the 390 th meeting, the Chairman provided an oral report on the replies received from the chairmen of the subsidiary bodies concerned.
35. Furthermore, at its 382 nd meeting, the Committee requested Conference Services to maintain an active dialogue with the substantive secretariats of intergovernmental bodies, providing statistics and information on previous performance, as well as guidelines on the ways and means to enhance utilization of conference-servicing resources. Conference Services was requested to report on the outcome of that dialogue to the General Assembly at its fifty-first session, through the Committee.
36. In addition, in paragraph 9 of its resolution $50 / 206$ A of 23 December 1995, the General Assembly had requested the Secretariat to take the measures recommended by the Committee on Conferences to enhance the utilization of conference-servicing resources and to report thereon to the Assembly at its fifty-first session through the Committee on Conferences.
37. At its 390 th meeting, the Committee considered the report of the SecretaryGeneral on the matter (A/51/253).
38. Lastly, in paragraph 11 of its resolution 50/206 A, the General Assembly had requested the Chairman of the Committee on Conferences to hold consultations with various bodies and committees to ensure rational allocation and capacity utilization of all United Nations conference facilities at Headquarters, United Nations Offices and other duty stations, with a view to addressing the current imbalance in order to enhance the capacity utilization and cost-effectiveness of those facilities, and to report to the Committee on the outcome of those consultations at its substantive session of 1996.
39. At the 390th meeting, the Secretariat, in consultation with the Chairman of the Committee on Conferences, presented an oral report on the matter.

## Discussion

40. Appreciation was expressed for the Chairman's consultations with the Chairmen of the Committee on Information and the Ad Hoc Committee on the Indian Ocean, which had consistently utilized less than the applicable benchmark figure of their allocated resources for the past three sessions. It would be useful to continue such efforts in the future, as they appeared to yield positive results. For example, the Ad Hoc Committee had reduced its session to one meeting and the Committee on Information had reduced its session to two weeks from its initial entitlement of three weeks. It was also noted that some bodies were taking such measures as relying more heavily on informal consultations, streamlining intergovernmental machinery and reducing the duration of sessions.
41. The waiving of the quorum rule frequently improved utilization of meeting time. The view was expressed that late starts were of more serious concern than early endings and should be more heavily weighed in the statistics, as early endings might be indicative of efficiency on the part of the body.
42. It was noted that the need to ensure rational allocation and capacity utilization of all United Nations conference facilities was a complex issue bound by the constraints of the headquarters rule, the geographical distribution of substantive secretariats and the conference-servicing capacity available at the various headquarters, and should therefore be studied more closely at a future session.
43. The Secretary-General's report (A/51/253) indicated that progress was being made in alerting the various bodies to the need for more efficient use of conference services. The Chairman's efforts in addressing letters to the chairmen of the various bodies contributed to a heightened awareness of the need for more efficient use of the resources allocated to them. All of the measures undertaken, inter alia, the active dialogue, and the Chairman's consultations and letters, were a reflection of the Committee's informational role in bringing to the attention of intergovernmental bodies the importance of using conferenceservicing resources efficiently and effectively.
44. In reply to a query, the representative of the Secretariat noted that the notional cost of producing one page of documentation in the six official languages was $\$ 916$, of which $\$ 602$ represented the cost of translation. The notional cost of one meeting was $\$ 4,553$, of which $\$ 4,194$ represented the cost of interpretation. Moreover, if the opening of every meeting held in New York during a calendar year was delayed 10 minutes, the loss in unutilized conference

## Conclusions and recommendations

45. The Committee on Conferences took note of the Chairman's reports on consultations held between the Chairman of the Committee and the chairmen of bodies that had consistently utilized less than the applicable benchmark figure of their allocated resources for the past three sessions, and on the replies received from the chairmen of subsidiary bodies that had utilized less than 80 per cent of their conference-servicing resources in 1994.
46. The Committee requested its Chairman to continue to consult on its behalf with the chairmen of bodies that had consistently utilized less than the applicable benchmark figure of their allocated resources for the past three sessions, with a view to making appropriate recommendations in order to achieve the optimum utilization of conference-servicing resources.
47. The Committee further requested its Chairman to transmit a letter to the chairmen of subsidiary bodies that had utilized less than 80 per cent of their conference-servicing resources in 1995 to invite them to report on measures taken to improve their utilization of those resources and realistically to assess their need for such resources, with a view to reducing the conference resources requested.
48. The Committee took note of the oral report on the consultations with various bodies and committees to ensure rational allocation and capacity utilization of all United Nations conference facilities at Headquarters, United Nations Offices and other duty stations, and decided to revert to the matter at a future session.
49. The Committee also took note of the report contained in document A/51/253 on the active dialogue between Conference Services and the substantive secretariats of intergovernmental bodies. It endorsed the idea of the Secretariat to make the active dialogue a permanent coordination feature, and directed that such action should be taken at Headquarters, as well as at the United Nations Office at Geneva and the United Nations Office at Vienna, where it had noted a need for improved coordination, including between the Secretariat and Member States, in the scheduling of meetings.
50. The Committee recommended that its Chairman, with the assistance of the Secretariat, should circulate a one-page communication to the members of intergovernmental bodies, through their chairmen, emphasizing the importance of starting meetings in a timely manner and indicating the current costs of conference servicing, as well as measures that could be taken to improve utilization of conference-servicing resources.

## 3. Provision of interpretation services to meetings of regional and other major groupings of Member States

Introduction and overview
51. In paragraph 13 of its resolution 50/206 A, the General Assembly had requested the Secretary-General to provide, within the resources approved for conference services in the biennium 1996-1997, interpretation services to meetings of regional and other major groupings of Member States upon request by
those groupings, taking into account the priority due to meetings included in the calendar of conferences and meetings, and to submit a report on the implementation of this decision to the General Assembly at its fifty-first session through the Committee on Conferences.
52. At the 390 th meeting, on 19 August 1996 , the Secretariat presented an oral report on the matter.

Discussion
53. The view was expressed that meetings of regional and other major groupings of States were a valuable mechanism for intergovernmental discussion, as they facilitated consultations and exchange of information and were an integral part of the decision-making process.
54. Concern was expressed about finding ways and means to provide conference services to such meetings in view of the limited resources currently available to that end.
55. The view was expressed that the Office of Conference and Support Services had an obligation to service scheduled meeting of United Nations bodies as a priority and that all meetings of regional and other major groupings of States should continue to be serviced on an "as available" basis.

## Conclusions and recommendations

56. The Committee on Conferences took note of the report on provision of interpretation services to meetings of regional and other major groupings of Member States.
57. In view of the importance of meetings of regional and other major groupings of Member States for the smooth functioning of sessional bodies, the Committee expressed concern that 35 per cent of requests for interpretation services for such meetings had been denied. Nonetheless, it recognized that meetings of Charter and mandated bodies must be serviced as a priority.
58. The Committee urged intergovernmental bodies to spare no effort in the planning stage to take into account meetings of their regional and other major groupings of Member States, and to dovetail such meetings with those of the sessional body. In addition, intergovernmental bodies should notify Conference Services well in advance of any cancellations so that unutilized conferenceservicing resources could, to the extent possible, be reassigned to meetings of regional and other major groupings of States.

## 4. Cost-accounting system for conference services

## Introduction and overview

59. At its 382 nd meeting, the Committee requested the Secretariat to develop as soon as possible a cost-accounting system for conference services, and requested the Secretariat to report on cost estimates of conferences, including estimates of losses incurred as a result of underutilization of conference-servicing resources.
60. Moreover, in paragraph 1 of its resolution 50/206 D of 23 December 1995, the General Assembly had requested the Secretary-General to develop as soon as possible a comprehensive and accurate cost-accounting system for conference services, to report on the progress of its implementation to the General Assembly through the Committee on Conferences and to report the results of its use to the Assembly through the Advisory Committee on Administrative and Budgetary Questions, in accordance with their respective mandates.
61. At its 391st meeting, on 19 August 1996, the Committee on Conferences considered a conference room paper on the matter (A/AC.172/1996/CRP.3).

## Discussion

62. Deep concern was expressed that the note by the Secretariat did not provide the information requested on the development of a cost-accounting system for conference services. The conference room paper was instead an interim report containing interesting ideas that should be amplified as soon as possible. The final comprehensive report should contain information on the relevant work being carried out by various entities within the Organization.
63. The development of a cost-accounting system would raise the awareness of intergovernmental bodies about the financial implications of their utilization of the resources allocated to them.

## Conclusions and recommendations

64. The Committee on Conferences took note of the conference room paper on the cost-accounting system for conference services contained in document A/AC.172/1996/CRP.3. It requested the Secretariat to continue to develop the cost-accounting system on a priority basis, and to report thereon to the Committee at its substantive session of 1997.
65. The Committee regretted that the Secretariat had not yet been able to devise the cost-accounting system as requested by the General Assembly, and expressed the view that in-house resources should be utilized to develop the cost-accounting system without recourse to outside consultants.

## D. Requests for exceptions to section I, paragraph 7, of General Assembly resolution $40 / 243$

Introduction and overview
66. At its 391st meeting, on 19 August 1996, the Committee considered a note by its secretariat containing requests from subsidiary bodies for exceptions to be made to section I, paragraph 7, of General Assembly resolution 40/243 of 18 December 1985, which states that no subsidiary organ of the General Assembly may meet at United Nations Headquarters during a regular session of the Assembly unless explicitly authorized by the Assembly (A/AC.172/1996/CRP.4). At its 395 th meeting, on 23 August 1996, the Committee was informed orally of a request from the Special Committee on Peacekeeping Operations for an exception to the aforementioned resolution, and of the need of the Committee on Conferences itself to meet at Headquarters during the upcoming session of the General Assembly.
67. In accordance with the procedure established by the Committee, the requests included explanations as to (a) why the bodies wished to meet; (b) why they had not completed their work by the deadine of 1 September laid down in section $I$, paragraph 6, of resolution $40 / 243$; (c) why it was necessary to meet during the Assembly session; and (d) how many meetings would be required. Statistical information was also provided on the number of meetings, if any, the bodies concerned had held during the fiftieth session of the Assembly and the efficiency with which they had utilized the resources made available to them.

## Discussion

68. Concern was expressed that bodies requesting to meet in New York during the General Assembly were not necessarily utilizing fully the meeting time allotted to them.

## Conclusions and recommendations

69. The Committee on Conferences recommended to the General Assembly that it explicitly authorize the following bodies to meet in New York during the fiftyfirst session of the General Assembly, on the understanding that meetings would have to be accommodated as facilities and services became available so that the activities of the Assembly itself were not adversely affected: Committee on Relations with the Host Country; Committee on the Exercise of the Inalienable Rights of the Palestinian People; Working Group on the Financing of the United Nations Relief and Works Agency for Palestine Refugees in the Near East; Executive Board of the United Nations Children's Fund; Special Committee on Peacekeeping Operations; and Committee on Conferences.
70. The Committee requested the Secretariat, when drafting the letters of authorization to the aforementioned bodies, to continue to include data on their utilization of conference-servicing resources when they had met in the past during the General Assembly and to encourage the bodies in question, inter alia, to inform the Secretariat of the anticipated duration of meetings so as to achieve maximum utilization of conference-servicing resources.

## II. CONTROL AND LIMITATION OF DOCUMENTATION

A. Implementation of General Assembly resolution 50/206 C; provision of written meeting records to subsidiary organs of the General Assembly; implementation of the rules and regulations on control and limitation of documentation: compliance with, and review of, the 24and 32 -page limits for documentation; format of reports of subsidiary bodies; access to the optical disk system by developing countries

## Introduction and overview

71. In paragraph 11 of its resolution $50 / 206$ C of 23 December 1995, the General Assembly had requested the Secretary-General to present to the Assembly at its fifty-first session, through the Committee on Conferences and the Advisory Committee on Administrative and Budgetary Questions, a report on the implementation of the measures called for under that resolution, including information on possible savings.
72. At its 392 nd and 393 rd meetings, on 20 August 1996, the Committee considered a comprehensive report of the Secretary-General (A/51/268) on the matter, which included separate reports called for under paragraphs 3 and 4 of resolution 50/206 B, paragraphs 2 and 9 (b) of resolution 50/206 C, and paragraph 3 of resolution $50 / 206$ D, regarding, respectively, provision of written meeting records to subsidiary organs of the General Assembly; implementation of the rules and regulations on control and limitation of documentation: compliance with, and review of, the 24- and 32-page limits for documentation; format of reports of subsidiary bodies; and access to the optical disk system by developing countries.

## Discussion

73. With regard to part IV of the report, regret was expressed that only two bodies had taken positive action in compliance with General Assembly resolution 50/206 C. The bureaux of all intergovernmental bodies should urge Member States to spare no effort to consolidate and shorten reports, review their need for documentation in general and for recurrent documentation in particular, biennialize and triennialize agenda items and comply with the rules to control and limit documentation. In addition, information should be provided to the secretariats of intergovernmental bodies on ways and means of achieving economies in documentation.
74. Note was taken with appreciation of the positive results of the experiment carried out by the Committee on the Peaceful Uses of Outer Space to use unedited transcripts instead of verbatim records. Updated reports on the progress of the experiment would be welcome.
75. As to part $V$ of the report, the view was expressed that, while unedited transcripts were not an ideal solution, they could be issued and corrected more speedily than verbatim and summary records and appeared to be a satisfactory cost-efficiency measure. In that regard, it would be useful to have a thorough cost analysis of written meeting records and of unedited transcripts.
76. The view was also expressed that unedited transcripts, which were still
being used on an experimental basis at Vienna, were of doubtful benefit. Delegations had yet to make recommendations about the change in records.
77. It would be useful to inform bodies entitled to written meeting records about the cost benefits that might derive from using unedited transcripts, and encourage them to request such transcripts at one meeting on an experimental basis to supplement their usual records. The Secretariat assured the Committee that such an experiment could be absorbed within existing resources.
78. Regarding part II of the report, regret was expressed that a cost analysis had not been included. Non-compliance with established page limits was a particular problem with documents not originating in the Secretariat. It would be useful if intergovernmental bodies developed a strategy to ensure compliance, inter alia, by carefully reviewing requests for reports and the possibility of drafting them within the limits, on the basis of information provided by the Secretariat at the time of the request.
79. As to part VI of the report, the view was expressed that considerable progress had been made to connect missions to the optical disk system. The intention was noted to offer access to the system for all Permanent and Observer Missions through the Internet by 1 November 1996. The view was also expressed that the report did not provide the proposals requested by the General Assembly in paragraph 3 of its resolution $50 / 206$ D, on facilitating access by developing countries to the optical disk system in all official languages, taking into account the possible savings from reduced copying and distribution costs.
80. Regarding possible economies resulting from access to the optical disk system, the representative of the Secretariat noted that the system was an additional service and not a substitute for hard copy. Indeed, missions connected to it had not reduced requests for hard copy. Nonetheless, the Secretariat had managed to reduce print runs as a result of the new technology, and the number of documents in stock had been halved.
81. Concern was expressed about access to restricted documents, particularly in view of wide public access to the Internet. The representative of the Secretariat assured the Committee that documents with restricted circulation were not currently introduced into the system. It was suggested that a password-access system should be used to restrict access to sensitive documents on the optical disk system.
82. Concern was also expressed about the posting on the Internet of documents in one language only or of documents that had yet to be edited or cleared. The representative of the Secretariat assured the Committee that the Secretariat only introduced into the optical disk system documents issued in all languages. It was suggested that such documents be identified, for example, by an asterisk.
83. It was stated that the difficulties many developing countries faced in arranging for connection to the optical disk system would not be overcome simply by offering access to it through the Internet.
84. The view was expressed that, during the transitional period, the use of such technologies as the optical disk system and the Internet should not constitute an alternative to traditional documents.

## Conclusions and recommendations

85. The Committee on Conferences took note of the report of the SecretaryGeneral contained in document A/51/268.
86. The Committee noted with appreciation the actions taken by the Committee on Natural Resources and the Committee on Relations with the Host Country to streamline their documentation.
87. The Committee recommended to the General Assembly that it reiterate its recommendations on control and limitation of documentation made to intergovernmental bodies contained in resolution 50/206 C and request intergovernmental bodies to report to it, through the Committee on Conferences, on measures taken to control and limit documentation.
88. The Committee recommended to the General Assembly that it request the Committee on the Peaceful Uses of Outer Space to continue to keep it informed, through the Committee on Conferences, of its experience with the use of unedited verbatim transcripts.
89. The Committee, taking into account the assurance given by the Secretariat in paragraph 77 above, requested its Chairman to transmit a letter to the chairmen of intergovernmental bodies that received written meeting records to inform them of the relevant discussion within the Committee and of the notional costs of written meeting records and unedited verbatim transcripts, and to invite them to consider the possibility of requesting the Secretariat to issue unedited transcripts of one meeting for comparison purposes with a view to the possible substitution of such transcripts for their usual records in the future.
90. The Committee recommended to the General Assembly that it stress once again the need for strict compliance with the existing limits of 24 and 32 pages.
91. The Committee recommended to the General Assembly that it should request the Secretariat to submit to it, every two years through the Committee on Conferences, updated information on the number and length of documents.
92. The Committee reiterated that the Secretariat, to the extent possible, should inform bodies, at the time they requested reports, whether the documents could be produced within established page limits.
93. The Committee recommended to the General Assembly that it request the Secretariat to pursue its efforts with a view to improving the quality in the substance and presentation of documentation, applying new publishing techniques to enhance readability and reduce consumption of paper.
94. The Committee recommended that working documents in all languages on the daily list of documents or in the Journal introduced into the optical disk system be identified, for example, with an asterisk.
95. The Committee recommended that, during the transitional period, the use of such technologies as the optical disk system and the Internet should not constitute an alternative to traditional documents.
96. The Committee recommended to the General Assembly that it request the Secretariat to provide proposals in accordance with paragraph 3 of its resolution $50 / 206$ D, on facilitating access by developing countries to the optical disk system in all official languages.

## Introduction and overview

97. At its 384th meeting, on 22 August 1995, the Committee took note of the oral report presented by the representative of the Secretariat in accordance with paragraph 7 of General Assembly resolution $49 / 221$ B of 23 December 1994, welcomed the actions taken to improve the quality of translation into all official languages, in particular the efforts of the Arabic Translation Service to implement the proposal contained in the report of the Committee on Conferences to the Assembly at its forty-ninth session $2 /$ and encouraged the Secretariat to pursue its efforts towards implementing phase II of the proposal.
98. Moreover, in paragraph 4 of its resolution 50/206 E, the General Assembly had noted the actions taken to improve the quality of translation into all official languages, in particular the efforts of the Arabic Translation Service to implement the aforementioned proposal, requested the Secretary-General to undertake a thorough review of the terminology and technical methods used in translation into Arabic, and urged the Secretariat to speed up its efforts towards the implementation of phase II of the proposal and to report thereon to the Committee on Conferences at its substantive session of 1996.
99. At its 393rd meeting, on 20 August 1996, the Secretariat provided an oral report on the foregoing translation-related matters.

## Discussion

100. Appreciation was expressed for the oral report presented on translationrelated matters. The progress achieved in improving the quality of translation in general and of Arabic translation in particular was praiseworthy, and the Secretariat should pursue its efforts in that regard.

## Conclusions and recommendations

101. The Committee on Conferences commended the translation services for the strong efforts made to improve the quality of translation of documents in all the official languages of the Organization, and encouraged those services to continue to spare no effort to that end.

## Introduction and overview

102. At its 335th meeting, on 24 August 1992, the Committee on Conferences had reviewed a conference room paper that contained an annotated provisional outline of the report on publications policies called for in General Assembly resolution $46 / 185$ B of 20 December 1991, section VI (A/AC.172/1992/CRP.1). At the same meeting, the Committee had requested the Secretariat to proceed with the report on publications as outlined in the conference room paper, taking into account the views expressed during the discussion.
103. At its 346 th meeting, on 17 May 1993, the Committee had considered the draft report of the Secretary-General on United Nations publications policy (A/AC.172/153, annex). The Committee had recommended that its comments and observations be taken into account in the preparation of the final report of the Secretary-General on publications policy to be submitted to the General Assembly at its forty-eighth session (A/C.5/48/10).
104. At its 391st meeting, on 19 August 1996, the Committee on Conferences considered the aforementioned report on publications policy.

## Discussion

105. In introducing the item, the representative of the Secretariat, noting that the Fifth Committee had yet to review the report on publications policy, informed the Committee that the Joint Inspection Unit was currently finalizing, for submission to the General Assembly at its fifty-first session, a comprehensive survey on the role publications played in implementing mandates of intergovernmental bodies and the extent to which recurrent publications could be made more cost-effective in that regard.

## Conclusion and recommendation

106. The Committee on Conferences recommended that the General Assembly consider the report on publications policy contained in document A/C.5/48/10 together with the results of the aforementioned survey carried out by the Joint Inspection Unit.

IV. REVIEW OF THE PROGRAMME PERFORMANCE OF THE UNITED NATIONS FOR THE BIENNIUM 1994-1995: SECTION 25E, CONFERENCE SERVICES
```


## Introduction and overview

107. In its resolution $39 / 238$ of 18 December 1984, the General Assembly had approved the recommendations of the Committee for Programme and Coordination, including the recommendation that relevant intergovernmental bodies review the programme performance report.
108. In accordance with that resolution, the Committee on Conferences considered the programme performance for the biennium 1994-1995 for Conference Services.

## Discussion

109. Explanations were provided by the Secretariat regarding the discrepancies between outputs programmed and actual delivery of conference services in the biennium 1994-1995. Factors contributing to the discrepancies included increases in workload, restructuring in relevant areas of the Secretariat and changes in the methodology utilized to derive statistics.

## Conclusions and recommendations

110. The Committee took note of the report contained in document $A / 51 / 128$ and Add.1. The Committee recommended that the General Assembly consider together the report on publications policy contained in document A/C.5/48/10 and the forthcoming report on publications of the Joint Inspection Unit, and wished to draw the attention of the Assembly to paragraphs 33 to 37 of document A/51/128, concerning publications.

A. Medium-term plan for the period 1998-2001: subprogramme
        on conference services
```


## Introduction and overview

111. In accordance with General Assembly resolution $43 / 219$ of 21 December 1988, the Committee on Conferences was invited to review the subprogramme on conference services of the draft proposed medium-term plan for the period 1998-2001, as contained in document A/AC.172/1996/CRP.1.
112. At its 388th meeting, on 30 April 1996, the Committee reviewed the relevant subprogramme.

Discussion
113. The Secretariat indicated that, in compliance with the new prototype of the medium-term plan, the subprogramme, reflecting the organizational structure of conference services, distinguished three main fields of activity: planning, development and coordination; translation and editorial; and meetings and documentation.
114. The view was expressed that the subprogramme must reflect the norms established by the General Assembly on the timely provision of services and on language arrangements. Clarification was sought and received regarding how the staff resources and grade structure of the translation services would be adjusted through the budget process to reflect the continuing increase in documentation; the impact of increased reliance on contractual translation; and the intent to expand the use of the optical disk system. The view was also expressed that technological innovations should be cost-effective and userfriendly.

## Conclusions and recommendations

115. The Committee on Conferences expressed general agreement with the draft subprogramme on conference services. It requested the Secretariat to mention in the final version of the subprogramme that meeting and documentation services should be provided in accordance with the resolutions and rules establishing language arrangements for the various bodies and organs of the United Nations.
B. Impact on conference services of the report of the SecretaryGeneral on the proposed programme budget for the biennium 1996-1997

## Background and introduction

116. Following the issuance of the report of the Secretary-General on the proposed programme budget for the biennium 1996-1997 (A/C.5/50/57), the Bureau of the Committee on Conferences decided that it was the responsibility of the Committee to examine the impact of that report on conference services. Subsequently, at its 388th meeting, on 30 April 1996, the Committee considered the Secretary-General's report.

## Discussion

117. With regard to the freezing of posts in the translation services, reservations were expressed concerning the cutbacks within the Secretariat. The view was expressed that the resulting difficulties should be taken into consideration.

## Conclusions and recommendations

118. The Committee on Conferences authorized its Chairman to send the following letter to the Chairman of the Fifth Committee to apprise that Committee of its concerns and views:
"Following the issuance of the Secretary-General's report on the proposed programme budget for the biennium 1996-1997 (A/C.5/50/57), the Bureau of the Committee on Conferences agreed that it was the responsibility of the Committee to examine the impact of that report on Conference Services. Subsequently, at its 388th meeting, on 30 April 1996, the Committee considered the Secretary-General's report.
"In informing the Committee of the impact of the proposals, the Secretariat indicated that programme managers had been instructed to achieve savings of a certain order of magnitude ( $\$ 26.75$ million) and to attain a vacancy rate of 6.4 per cent. That had involved a major exercise for Conference Services, which kept its core staff at a lower level than necessary to cover requirements and relied heavily on temporary assistance. In order to achieve the required targets, it was necessary to reduce temporary assistance, increase the use of self-revision and postpone the purchase of computerized systems for use in the Translation Services as well as other technological innovations, thereby deferring anticipated productivity gains. Even after taking into account the capacity expected to be released by the cancellation of scheduled meetings, available resources would be sufficient to service only those meetings approved in the calendar of conferences, and no additional meetings requested by any intergovernmental organ could be accommodated without additional resources. Document-processing capacity would also be reduced, in which connection priority would be given to parliamentary documentation, rather than meeting records and publications.
"The Committee expressed its concern at the impact of these measures on the capacity of Conference Services to meet mandated activities, in terms of both servicing meetings and processing documentation. In particular it stressed that the concurrence of the body concerned must be sought before any action was taken to alter entitlements to meetings; that increased reliance on self-revision should not impair translation quality; and that all official languages must receive equal treatment. The Committee also noted that the deferral of technological innovations, including the modernization of the text-processing services at the United Nations Office at Vienna, would be counterproductive in terms of costeffectiveness. More information on the impact of the measures must be provided to enable the General Assembly to take an informed decision.
"I should be grateful if you would have this letter circulated to the members of the Fifth Committee to apprise them of the views of the Committee on Conferences."

## C. Host country agreements

## Introduction and overview

119. At its 388th meeting, on 30 April 1996, the Committee on Conferences decided to take up at its substantive session of 1996 the proposal from the Office of Legal Affairs concerning the negotiation of agreements with States to host United Nations conferences. At its 393rd meeting, on 20 August 1996, the Committee considered the matter of host country agreements.

## Discussion

120. In introducing the report, the representative of the Secretariat noted that on occasion difficulties had arisen, and much time had been spent, in the negotiation and conclusion of host country agreements between the United Nations and Governments issuing invitations to host United Nations meetings and conferences away from established headquarters. It was the established practice to conclude such agreements on the basis of a model agreement contained in an administrative instruction issued by the Secretariat (ST/AI/342). In the view of the Secretariat, in order to facilitate the timely negotiation of such agreements and achieve greater efficiency in time spent thereon, there was a need for the General Assembly, when accepting an invitation from a Member State to host a conference or meeting away from its established headquarters, to specify that an appropriate host country agreement between the United Nations and the State concerned should be concluded successfully and in a timely manner.

## Conclusions and recommendations

121. The Committee recommended that Member States be informed of the existence of the model host country agreement contained in administrative instruction ST/AI/342 in order to make them aware of the arrangements required in hosting a conference or meeting.
122. The Committee also recommended that the body accepting the invitation be kept informed, as appropriate, of the progress made in negotiating the host country agreement in the course of preparations for a conference with a view to encouraging the timely conclusion of a host country agreement before the conference took place.

## D. Audio recording of informal consultations

Introduction and overview
123. At its 392nd meeting, on 20 August 1996, the Committee on Conferences agreed to take up the matter of audio recording of informal consultations.

## Discussion

124. Upon inquiry, the representative of the Secretariat confirmed that, while audio recording of informal consultations of the Main Committees was not the usual practice, recordings were prepared at the request of their secretariats. Once requested, such services continued to be provided until indication was made that they were no longer required.

## Conclusions and recommendations

125. The Committee took note of the assurances given by the Secretariat that the practice of making audio recordings of the informal consultations of intergovernmental bodies would be discontinued and recommended that audio recordings of informal consultations of any intergovernmental body should not be made unless the body concerned decided otherwise.

## E. E-mail address for the transmission of requests for meeting rooms for the convening of bilateral meetings

## Introduction and overview

126. At its 392nd meeting, on 20 August 1996, the Committee on Conferences agreed to take up the matter of an e-mail address for the transmission of requests for meeting rooms for the convening of bilateral meetings.

## Conclusions and recommendations

127. The Committee commended the Secretariat for the exemplary way in which General Assembly resolution $49 / 221$ D of 23 December 1994 had been implemented and for its contribution to the successful conclusion of the general debate and the special commemorative meeting during the fiftieth session of the General Assembly.
128. The Committee recommended that the Secretariat proceed with the establishment of an e-mail capacity through which delegations could make requests for the use of meeting rooms for the convening of bilateral meetings and contacts among Member States during the period of the general debate of the General Assembly session.

## A. Membership

129. The General Assembly, in its resolution $43 / 222$ B of 21 December 1988, had decided to retain the Committee on Conferences as a permanent subsidiary organ. Pursuant to that resolution, the Committee in 1996 was composed of the following Member States: Austria, Bahamas, Belgium, Chile, Egypt, France, Gabon, Ghana, Iran (Islamic Republic of), Jamaica, Japan, Jordan, Kenya, Latvia, Morocco, Nepal, Pakistan, Russian Federation, Saint Vincent and the Grenadines, Senegal and United States of America.

## B. Officers

130. The Committee elected the following officers to serve in 1996:

Chairman: Mr. El Hassane Zahid (Morocco)
Vice-Chairmen: Mr. Hideki Goda (Japan)
Ms. Elisabeth Kornfeind (Austria)
Ms. Mara Treimanis (Latvia)
Rapporteur: Mrs. Sharon Brennen-Haylock (Bahamas)
131. At its organizational session for 1996 (387th meeting), on 1 February 1996, the Committee agreed in principle that the Chairman would undertake informal consultations with a view to determining the composition of the Committee's Bureau in 1997.

## C. Organization of work

132. At its 387 th meeting, the Committee agreed to meet as required to take up matters related to the calendar of conferences and its implementation, in particular the consideration of inter-sessional departures from the approved calendar. At the same meeting, the Committee requested the Secretariat to submit a draft agenda for 1997 at the organizational session to be held early in 1997. The Committee met on 30 April 1996 (388th meeting) to examine the impact on Conference Services of the measures set forth in the Secretary-General's report on the proposed programme budget for the biennium 1996-1997 (A/C.5/50/57) and to review the subprogramme on Conference Services of the draft proposed medium-term plan for the period 1998-2001. It also met on 3 June 1996 (389th meeting) to consider certain changes to the calendar of conferences and meetings for 1996. The Committee convened its substantive session on 19, 20,22 and 23 August 1996 ( 390 th to 395 th meetings) and its resumed substantive session on 19 September 1996 (396th meeting).
133. At its $393 r d$ meeting, the Committee decided to limit its future meetings schedule to a one-meeting organizational session, a three-day substantive session in August and one meeting during the General Assembly, thereby reducing its meeting time by 22 per cent.

## D. Programme of work

134. At its organizational session for 1995, on 23 March 1995, the Committee had requested the Secretariat to submit to it, at its organizational session for 1996, a draft agenda for 1996, which was subsequently issued in document A/AC.172/1996/L.1 and adopted by the Committee (A/AC.172/1996/1).
135. The Assistant Secretary-General for Conference and Support Services and the Director of Conference Services, respectively, addressed the Committee at the opening of its organizational and substantive sessions.
