> Identical letters dated 18 October 1996 from the Vice-Minister for Foreign Affairs of Afghanistan addressed to the Secretary-General and to the President of the Security Council

Upon instructions from the authorities of the Islamic State of Afghanistan, I have the honour to bring the following to your attention and through you to the Security Council for appropriate consideration and action.

As submitted to the Security Council, in my statement of 16 October 1996, the forces of the Islamic State have recently been able to capture armed Pakistani militia and military personnel during the recent events which culminated in the military occupation of Kabul by Pakistani mercenaries, known as Taliban. The following captured individuals were fighting alongside the Taliban against the forces of the Islamic State:

The above-mentioned individuals are currently being held under the custody of the authority of the Islamic State.

As proposed yesterday, the Islamic State of Afghanistan earnestly hopes that the Council will decide to dispatch a United Nations fact-finding mission to Afghanistan to interview the captured Pakistani military officials and militias and evaluate other evidence of intervention, including the recent use by the Taliban of some type of chemical or internationally banned weapons against the forces of the Islamic State of Afghanistan.

I request that the present letter be distributed as a document of the General Assembly, under agenda item 39, and of the Security Council.
