REVIEW AND IMPLEMENTATION OF THE CONCLUDING DOCUMENT OF THE TWELFTH SPECIAL SESSION OF THE GENERAL ASSEMBLY: REGIONAL CONFIDENCE-BUILDING MEASURES

Congo*: draft resolution

The General Assembly,

<u>Recalling</u> the purposes and principles of the United Nations and its primary responsibility for the maintenance of international peace and security in accordance with the Charter of the United Nations,

<u>Bearing in mind</u> the guidelines for general and complete disarmament adopted at its tenth special session, the first special session devoted to disarmament,

<u>Recalling</u> its resolutions 43/78 H and 43/85 of 7 December 1988, 44/21 of 15 November 1989, 45/58 M of 4 December 1990, 46/37 B of 6 December 1991, 47/53 F of 15 December 1992, 48/76 A of 16 December 1993, 49/76 C of 15 December 1994 and 50/71 B of 12 December 1995,

<u>Considering</u> the importance and effectiveness of confidence-building measures taken at the initiative and with the participation of all States concerned and taking into account the specific characteristics of each region, in that they can contribute to regional disarmament and to international security, in accordance with the principles of the Charter,

<u>Convinced</u> that the resources released by disarmament, including regional disarmament, can be devoted to economic and social development and to the protection of the environment for the benefit of all peoples, in particular those of the developing countries,

<u>Convinced further</u> that development can be achieved only in a climate of peace, security and mutual confidence both within and among States,

<u>Bearing in mind</u> the establishment by the Secretary-General on 28 May 1992 of the United Nations Standing Advisory Committee on Security Questions in Central Africa, the purpose of which is to encourage arms limitation, disarmament, non-proliferation and development in the subregion,

Recalling the Brazzaville Declaration on Cooperation for Peace and Security in Central Africa, $\underline{1}/$

1. <u>Takes note</u> of the report of the Secretary-General on regional confidence-building measures, 2/ which deals with the activities of the United Nations Standing Advisory Committee on Security Questions in Central Africa in the period since the adoption by the General Assembly of resolution 50/71 B;

2. <u>Reaffirms its support</u> for efforts aimed at promoting confidencebuilding measures at regional and subregional levels in order to ease tensions and conflicts in the subregion and to further disarmament, non-proliferation and the peaceful settlement of disputes in Central Africa;

3. <u>Also reaffirms its support</u> for the programme of work of the United Nations Standing Advisory Committee adopted at the organizational meeting of the Committee held at Yaoundé in July 1992;

4. <u>Welcomes</u> the fact that the Committee's programme of work has led to specific actions and measures promoting confidence-building and security in the Central African subregion;

5. <u>Takes note</u> of the First Summit of Heads of State and Government of Countries Members of the United Nations Standing Advisory Committee on Security Questions in Central Africa, held at Yaoundé on 8 July 1996;

6. <u>Welcomes with great satisfaction</u> the signature at that Summit of the Non-Aggression Pact between the States members of the United Nations Standing Advisory Committee and <u>reaffirms its conviction</u> that the Pact is likely to contribute to the prevention of conflicts and further confidence-building in the Central African subregion;

7. <u>Invites</u> the States members of the Standing Advisory Committee which have not yet signed the Pact to do so and encourages all member States to expedite ratification so that it may enter into force as soon as possible;

8. <u>Also welcomes with satisfaction</u> the Yaoundé Declaration adopted at the Yaoundé Summit of the Standing Advisory Committee, <u>3</u>/ which aims at the implementation of the following measures:

(a) The promotion of participatory systems of governance as a means of preventing conflicts;

(b) The organization, under United Nations auspices, of training seminars for officers in the armed forces, republican guard, gendarmerie and police forces of the Central African States, in order to promote a culture of peace by explaining, once again, their role in a democratic context;

(c) The development of a programme to combat illicit arms trafficking, in order to remove this source of insecurity and a threat to the stability of States in the subregion;

(d) The setting-up, under United Nations auspices, of an early warning system as the basic instrument for preventive diplomacy in Central Africa;

(e) The strengthening of cooperation between States in the subregion and bilateral and multilateral partners on the question of peace and security in Central Africa;

9. <u>Expresses its conviction</u> that the democratic process offers a valuable means to build confidence, promote development and prevent conflicts and <u>welcomes with satisfaction</u> the decision taken by the States members of the Standing Advisory Committee to hold a subregional conference at Brazzaville in January 1997 on the topic "Democratic institutions and peace in Central Africa";

10. <u>Welcomes</u> the holding, under United Nations auspices, of the first training seminar for instructors in peace operations, at Yaoundé from 9 to 17 September 1996, with a view to strengthening the capacity of the units specializing in peace operations in the armed forces of the States members of the Standing Advisory Committee;

11. <u>Expresses its gratitude</u> to those Governments which responded favourably to the request from the General Assembly and contributed towards financing the aforementioned training seminar;

12. <u>Emphasizes once again</u> the importance of continuing with this training programme in order to strengthen the participation of States members of the Standing Advisory Committee in future United Nations peace operations;

13. <u>Commends</u> the Secretary-General for having established the Trust Fund for the Standing Advisory Committee;

14. <u>Reiterates its appeal</u> to Member States and governmental and non-governmental organizations to make additional voluntary contributions to the Fund for the implementation of the programme of work of the Committee,

particularly the measures and objectives referred to in paragraphs 8, 9 and 12 of this resolution;

15. <u>Requests</u> the Secretary-General to continue to provide assistance to the States members of the Standing Advisory Committee to ensure they are able to carry on with their efforts;

16. <u>Also requests</u> the Secretary-General to submit to the General Assembly at its fifty-second session a report on the implementation of the present resolution;

17. <u>Decides</u> to include in the provisional agenda of its fifty-second session the item entitled "Regional confidence-building measures".
